I've had my communications and worked closely with the civil service and family and I'm very aware of the expertise that all of you provide and the attentiveness that you provide for every employee who really has to go through that process so again I admire the work that you do and I know that it would be in the best interest for them so I want you to know that you got my whole heartily support. I want to say for the record that both the confirmation hearings for Mr. Juan Calvo and Mrs. Priscilla Tuncap has been publicly heard I will note for the record that if there's anyone wishing to provide a further testimony they can do so by sending to speaker@guamlegislature.org or you may have delivered to 163 Chalan Santo Papa Hagåtña Guam. I will leave there a Record of Decision open for a couple of more days like I've noted to each and every one of you and to our listening audience that I am asking that I will try and make it a point to put the both confirmations on for the April session so until the April session I will keep the record open I also for the record would like to acknowledge the presence of some key a senior policy senior staff to *I Maga'håga'* the chief of staff former assistant director of Interior Tony Babauta *Si Yu'os Ma'åse'* for being here Mr. Adrian Cruz from also from the governor's office thank you for being a part of supporting the efforts of both Mr. Calvo and Mrs. Tuncap with that being said if there' nobody else wishing to present oral testimony for either appointments I will call this public hearing on Accountability on Public Accountability Human Resources and the Guam Buildup adjourned and it is 1:50 p.m. *Si Yu'os Ma'åse'* and happy Easter each and every one of you again *Saina Ma'åse'*.
