Senator James Moylan: ok, looking forward to seeing your name on the next session there so we can get you approved. Thank you so much. Thank you, Mr. Chair.

Rena K. Borja: Thank you.

Chairman Jose "Pedo" Terlaje: I just want to thank the Governor and the Lt. Governor for expediting the appointments because I've been bombarded with a whole lot of complaints regarding the issuance of licenses and I wanna thank our Governor and Lt. Governor for really attending to my call on the importance of making those nominations. Have you ever worked for the contractors licensing board, Rena?

Rena K. Borja: No, I haven't.

Chairman Jose "Pedo" Terlaje: Yeah because you know you've never had an RME license or anything like that.
