I open the floor now to my colleagues, uh, for any questions for you Mike, uh, Senator Kelly Marsh Taitano.

Senator Kelly Marsh (Taitano), PhD: *Si Yu'us Ma'ase* Madam Chair and it's been a very good morning so I really thank you the committee everybody who's turned out for having us all start our Friday morning on such a good note. There's been such support from the university itself with the President, the Senior Vice President, and Provost, the UOG Board of Regents Chair, family, friends, community members, it's really been a great outpouring of support and this is absolutely the type of things that we need to have happen. It gives us assurance and it informs us in all these important ways of the senior management skills, the other experience, and background commitment to our community that they bring forth. Several of us here this morning as Senators are also very proud to love of the University of Guam so University of Guam has contributed greatly to our community in a variety of ways by continuing to graduate people who go out there and are our workforce and our management and our local entrepreneurs with that, um, you know, I, I, also want to say it's all of this support is important because this is one of those perhaps very unusual situations where it's a six-year appointment and it's overseen in many ways a very important pillar of our community so which is the university, um, that's very important so I would ask Mr. Naholowaa what he considers, I mean, we did get to hear in your testimony about the potential for, for, us as a community and what the the University can be continuing to do to grow our economy and diversify us within the Board of Regents specifically, uh, maybe some of the the challenges that they've been tackling over the years, um, in setting policy and and overseeing the management of the University, is there anything that stands out as a pressing issue or something that you think has been a really important decision that they have made to keep the university where it wants to be and that's serving our community well?

Senator Regine Biscoe Lee: *Buenas yan* good morning Madam Chair, um, and I just want to say *Si Yu'us Ma'ase* to the nominating committee who participated in moving these, these, names forward to the Governor, the Lieutenant Governor for these nominations, um, I've actually feel so lucky I've had the pleasure of knowing both of these gentlemen, um, in their respective roles in the community and also personally so I really want to thank their family members who are here this morning it's so great to see everybody's faces, um, and thank you for participating in our proceedings, um, Madam Chair you asked one of the questions that, that, I had on my list so I just wanted to move, uh, forward and asking, uh, Mr.Naholowaa if he could share his thoughts about the University of Guam's COVID response specifically with regard to the impact on UOG students and the impact to our broader community. So how do you think UOG did with its shift to online learning and how do you think that we are tackling, um, going forward with this pandemic for students, but also how is the University helping our community at large respond to this pandemic?

Mike Naholowaa: Oh, thank you Senator I appreciate that, um, the COVID virus situation is frightening, but, but, what I love about it is that the University ground fund ways to still get the mission out to prepare the proper curriculum and the studies for the students to maintain and, and, and, like I said this is a new normal. I mean, right now it's the health of our capital, uh, is tantamount and, because of that, you know, we still got it we still got to maintain our mission on H2 we got to maintain the degree programs we also have to maintain the students zest and an effort to, you know, to further learn and I love the way that the University did this because by doing the online courses by changing the, the, synergy of the various colleges and schools we, you know, the University is still able to deliver, to deliver, the proper instructions and programs to the students I know, I know, it's difficult, you know, where we're not in the classroom anymore because the health concerns, but the mission is on the universe proceeds on and that's, and that's, and that shows the residency of the administration the efforts of the school and the course that needs to be done. Okay yes you can't show up to school anymore, but just do doing this and, you know, and like I mentioned it is, it is, uh, the further advancement of technology and, and, I think that's important. What's important is safety of the people and that's why, that's why, going to the online and that is why, you know, where the university is, is, stepping up to the plate to maintain the mission and also the curriculum classes that has to be done I think, I think, that's that would be my best answer on that, that, particular question sent it to me.

Senator Regine Biscoe Lee: Yes great thank you so much, uh, Mike and, and, I think yeah you you're, you're, spot on in terms of, you know, our dependence as a community we really depend on UOG to assist with developing our workforce and, and, leveraging this technology right and helping us respond, um, so again thanks so much for, um, for agreeing to serve in this position, um, and thank you to your family and happy birthday to Leah Beth thank you. Thank you, Madam Chair.

You have produced so many things in your family Mike that contributed to this community and, and, uh, and I wish I was there to give you a big hug you know right now and thank you for all your, your, work, um, you know, I was, I was, looking earlier about the responsibilities to Mike of the University of Guam and it says that the University of Guam Board of Regents has a general supervision over the university. The board sets the policies governing the duties, conditions of employment, compensation and salary of all university employees the board also submits an annual budget to the legislature so I'm glad that we're going to be, uh, you know keeping in touch, because I know you're going to be knocking on all our doors for more money for the University of Guam, um, I guess that's correct, that's correct, so I'll be ready for you Mike, you know, I'll be ready for you so good luck to you. You know you have my support I, I, know you on a personal level and it definitely and everything you've contributed so I wish you the best of luck.

Mike Naholowaa: Thank you Senator. Thank you and thank you Elvin thank you so much Senator Taitague

Senator Amanda L. Shelton, Chairperson: Thank you very much Mike and all of the Senators for your questions. Now we will move back to Roland for your testimony.

Roland S. Certeza: Uh, thank you Madam Chair and that was an example of Moore's Law when, when, uh, things go wrong, uh, it's a quick dash. I had to restart my computer so thanks everybody, um, uh, Senator Lee, Senator Marsh, Senator Taitague. It's nice to see you guys again, uh, and by the way Senator Taitague is not a bad singer herself. When I first moved back to Guam we'd always be out and listening to her sing so and then of course Dr. Krise, Dr. Enriquez, and Dr. Santos. Thank you so much for the, uh, the kind words and the support I look forward to working with you guys and I don't know, uh, Mr Chiang on a personal or professional level we haven't had a chance to meet, but I certainly know my neighbor Sandra McKeever very well. We've been friends and colleagues for a very long time.

So anyways *Hafa Adai* everybody and I'm Roland Certeza obviously I'm the son of Jerry Certeza from Piti and Evelina Camacho from Agaña Heights and I'm so glad that they're here on the call today. My wife Amy and I live in Piti and we've been together for 17 years. I was born and raised on Guam and spent eight years on island, uh, in my early youth. My parents are retired federal civil service workers and we followed my mom's career back to the Bay Area back in 1974. My, my four sisters I think I see my sister Becky on here, and my sister Steph is on here, and my niece Jasmine, but all of my family lives back in the U.S. and I'm the only one out here in Guam. In high school again following my mom's career we had the the fortunate

experience to live in a foreign country and, and, being exposed to poverty and experiencing people with genuine happiness that don't have a lot of material possessions was really a profound experience for me that shaped a lot of who i am today.

I moved back to the island in 1993 after a brief vacation and I just simply fell in love with the island, our ocean, and it felt good to be back home. I graduated from San Diego State with an accounting degree and I also got my master's so I'm a proud Triton with the University of Guam and really whenever I'm asked about the program there I just speak really highly of it, because I had a great experience starting with the business faculty. A remarkable staff very confident and what I found was they were teaching relevant real world business topics and challenges and in fact when I became CEO we implemented the strategic management system that I learned from Dr. Santos and we implemented that in GTA and that's our that's our system today that we that we operate off of and so indeed, uh, what you learn in school can definitely be applied in business today. In our company we have exceptional people, uh, that have graduated from the university.

They are talented, motivated, they are contributing significantly to our business and our community and frankly I would put them up against graduates from any other university. I've had the pleasure of working for companies like Apple and Hewlett-Packard and Sprint and Verizon and Deloitte, but really I've been with GTA for 15 years in various sales management roles and I've been the CEO for the last three years. As a leader I'm focused on primarily creating the most meaningful impact to our employees, our business, our customers, and our community. One area of focus is our employee experience I just simply believe if you look after your employees they will in turn look after your customers and that leads to your company growth and so far that model has worked for us in the past three years despite the challenges of COVID. Simply put, serve the teams that serve your customers is what we always say here and then, and then, I also have an opportunity to challenge our teams really to go beyond I think what's possible and really encourage them to take calculated risks and really encourage this, this, uh, environment of accepting failure.

We, we, believe that's where a lot of the growth and learning comes from is how you fail. Another area of focus that inspires us is giving back to our community and I wanted to share with you guys some of the things that we're doing in the community. Our ongoing support for USO is material for our business the military and their families are so important to our, our, safety and security. Our advocates of make-a-wish; the impact that we make to those children and their families is just inspiring. Our village mayors and our community centers they're kind of at the heart of our community. And of course Special Olympics and junior achievement are near and dear to us as we try to support them. But during this pandemic and despite the obvious business challenges we all face our teams rallied behind the Team Up for Guam program and I was really proud of what the team came up with because one of the main things we wanted to say was, you know, that we were telling our teams was I mean our business is down, but I think this is the time where we need to come up with continuing to support the community so we supplied, you know, 2,000 families in need of food and basic necessities supplied over 10,000 masks, we fed over 500 front line first responders and we built this free wi-fi system for the USS Theodore quarantine site. And what I found remarkable was our technical team was willing to risk exposure to get the job done and support these sailors just a remarkable experience for me and we've also given tablets and smartphones to both hospitals for patients in isolation and we're really not stopping there. While we're working with GMH right now you know you guys all know what's happening on the island, uh, the pandemic and, and, the hospitalization is still high and and what's happening with the front line folks there we are figuring out a way to support them in a more meaningful way over the next 30 days, but really this is just, you know, this is how all of us here in GTA just bring value to our community and we're going to continue to support wherever we can.

And then I just want to say in closing here's what I'm aimed at in contributing as a board member, you know,

financial stability growth, operational excellence, those are all super important areas. What I'm more interested in is understanding and supporting where the overall faculty and the student experiences today now. I'd like to understand where the areas that we need to improve on. How do we find the needed resources and more importantly funding these initiatives? I'm going to be a big advocate of that and of course technology as Dr. Krise was talking earlier about what's going on up at the university, you know, my, my, history in telecom dates back to the university. I mean we built the first internet connection up there with a very small connection with the computer center and it's just remarkable to see how much it's expanded. They've not only brought in significant amount of, of, technical capacity, but they've also, you know, built in diversity links. I'm so happy to see multiple carriers up there even though I'm with GTA, but just building the resiliency around that university I think is important and for us it just lines up exactly what some of the investments that we're making as a company in technology and so i believe in this university and I'm honored, uh, to hopefully serve on its Board of Regents thank you.

Senator Amanda L. Shelton, Chairperson: Thank you so much Roland, uh, for those remarks and I want to apologize I thought these were, this was your aunt and your uncle but they are your parents Jerry and Lina so welcome and your sisters who are also on the line, uh, welcome and congratulations to all of your family. So I'm very glad to hear of all of the great community work you and your company continue to do and really bringing that human aspect to the corporate world, uh, very much appreciated of course when, um, when a government can't always, uh, you know get everything done we have these groups and, uh, people like you folks like you who are willing to step in and assist and that's what makes us such a special community. So thank you for answering that call and, uh, the call to serve here on the University of Guam Board of Regents. Obviously you have a big role you're a very busy, uh, very busy man and, uh, your willingness to answer this call to serve in a different capacity, uh, is admirable so thank you very much for that and I, I, really appreciate your, your, desire to find the best way to serve our faculty and our students at the University of Guam. Obviously you know that in the it's been a big discussion about, um, about tuition increases for our students and a budget, budget, cuts for the university and it's a difficult time for everyone in the government all around, but i appreciate the expertise that you will be bringing to a balance the affordability of an education, a quality education, at the University of Guam while still providing the resources to the faculty and staff at UOG to do the job and to provide that education. So I'll open the floor up for any questions from our colleagues. Senator Marsh if you have, uh, if you have a question.

Senator Kelly Marsh (Taitano), PhD: *Si Yu'us Ma'ase* Madam Chair and before I forget because I'm afraid I might forget I wanted to thank Mr. Naholowaa for those kind words about my father so I appreciate that very much and I believe we're related I just have to ask my sister-in-law, uh, to remind me how closely that I, I, know the entire family and close to them. And it's so good to see you again this morning Mr. Certeza. I'm glad, uh, we got those issues taken care of and it was very, very, good to hear of the points that you brought out that, you know, you're looking at some of the foundation a university can offer great courses and they can do many things for the community, but they really need to be making sure that that foundation, that core, of the, the, student and the faculty experiences is there. So i I'm very pleased to hear that that's going to be part of your very close examination of the university and to look for those strengths and weaknesses. And every institution everybody has them and the more that that's looked at directly the more that the strengths can be built on and the weaknesses can be mitigated and hopefully turned into strength so that again was very important given your background, um, and I think you were, you were, kind of discussing this already, but if you could tell us a little bit about, um, we want people in the positions that are able to make those tough decisions they're maybe not always going to be popular maybe sometimes they're necessary and one of the things that I think is has been very good for UOG is if there have been issues they've, they've, worked at corrective actions and that of course is led by the board can you speak just a little bit about maybe some of

your experience or ability or willingness to, to, face some of those perhaps really tough challenges and, and, draw that firm line?

Roland S. Certeza: Sure, um, you know, the one that's really relevant is actually when I took over as CEO, uh, when the Huntsman family and the board, um, elected to promote me up, uh, one of the things I told them was that there was going to be some very hard decisions around and it really had them focus on a real a few big things that, you know, despite our, you know, we were in privatization for I believe 14 years and while our growth was great, you know, frankly our earnings was slightly anaemic. We didn't see a lot of growth in earnings and I think part of that is that while we were making some great strides on our top line business we weren't making any disciplinary choices on expenses and so when I took over you know I, I, just clearly said look there is dead weight particularly at that executive table, um, I didn't believe that they were contributing in a meaningful way and so when we when I started, uh, immediately, uh, it was all about cutting on the unnecessary costs out of the business and what i mean by that is, you know, I when I talk about employee experience I talk about wanting to fund things around pay increases, training and development, creating a workplace environment that people like to come to. We hadn't made any investments, for example, in their workspace environment with new, you know, cubes and chairs and kitchens and bathrooms and so when I talked to the board I said look we're going to make some, some, changes

but it's going to, it's going to, be painful and so we started taking a look at the, the, who is it who was actually contributing where some of these expenses were that were just in my opinion were, were, not the best spent on the best investment and so we started making those changes and look often times I was standing alone, because a lot of, you know, there's a lot of, um, sort of sacred, uh, ideas around, you know, we can't possibly do that, you know, we've been doing that for a long time and so and I think as execs you've got to be willing to make those tough decisions and you're not it's not you're not trying to be, you know, mercurial in your actions, but you've got a responsibility to your shareholders, to your customers, and to your employees and, you know, the, the, owners said look we're looking for growth and when you looked at what we were doing you know while we were doing all these great things we just weren't growing on the bottom line so it takes a lot of tough work on the expense side of the business and eventually you're going to have to deal with the people aspect of it and frankly I think when we look back I think the moves that we made I think most people would agree that those were necessary, because, you know, we made, you know, we got rid of the, the, space where maybe it wasn't as productive, but then we started to grow in areas where we knew we needed to grow and, you know, and frankly now when I said earlier, you know, when you when you really focus on employees and their experience and making sure there's training and development available and what you're aiming at as far as a customer philosophy and you and then of course you get out of their way and, and, and, let them do their thing magical things happen and, and, fortunately for us we've been able to grow the business despite I mean this COVID process is tough for everybody and, and, we're no different, but, you know, the prior two years we've been able to make some, some, material changes in our business that, that, really just took decisive action so.

Senator Kelly Marsh (Taitano), PhD: *Si Yu'us Ma'ase* for providing us that illustration and I think that really says a lot about what you're going to bring to the table and it helps us understand that I really appreciate that holistic approach. I think it's so important, um, very often perhaps people get very focused on one or two particular aspects and then the holistic approach isn't there and, and, things can suffer so I appreciate that very much I *Si Yu'us Ma'ase* Madam Chair and to both of the nominees for accepting the nomination.

that, my family and I have encountered, uh, Roland on land, on the yoga mat, and in the water, so I agree with, um, what regent McKeever said about the importance of, of, character and also our, our, willingness to use our time and our talent to really impact others and I think in, in, in, Mr. Certeza's testimony you can certainly hear that that's kind of at the, at the, center at the focus of his role both at GTA and hopefully what he'll bring to the Board so, uh, I and I also just want to say *Hafa Adai* and *Si Yu'us Ma'ase* to the Certeza family. Oh my goodness your parents are just adorable this is so great I'm really glad that everybody could join us, um, and thank you so much for your support of Roland and as he steps up and serves in this role, but, um, Mr. Certeza I did want to ask you a similar question to what I asked Mr Naholowaa with regard to UOG's COVID response so, um, specifically to the impact on students, but also the impact on our local community as a whole, um, how they did and how you think we can improve going forward.

Roland S. Certeza: You know, I, I, think Senator Lee, you know, the challenge for all of us is there there's just no playbook for this, um, and I think we were all, you know, in, in, a very new environment and so I what I really appreciated with the first thing that they, that they, did and when we were talking with, uh, Dr. Santos and Dr. Enriquez early on was really again they were focused on their, their, student experience and getting them connected and, and, one of the things I appreciated was just how they engaged, you know, all of us, all of the carriers really to step up and see where we can help mitigate, you know, that, that, challenge that they had to finish this spring semester, but then really how they're kind of thinking through you know the, the, eventual plans around, you know, this sort of mid-term impact of the, of the, pandemic and how that's going to improve, uh, for the distance learning so I applaud these guys I mean there's their, their, you know the response and the, the, quickness was, was, was, what was needed, um, I, I, don't know enough about what's happening on the technology side of where you know whether we're participating in expanding, uh, some of the capacity up at the university, but one of the things I would, you know, I was curious to see what they're doing is, is, making, you know, doctor, Dr. Krise talked about this Guam open an internet exchange and some of you may not know, but, you know, UOG, um, I think it's the University of Indiana, the University of Hawaii, they're all participating right now on this network that's kind of congregating in Guam and it's it is on our footprint for sure, but one of the things I'm interested in is how they can, you know, in to the University's leadership expand that not only to the Department of Education schools, but expand that over to the GCC and certainly the region, uh, with, with, distance learning opportunities. I think that is something that we should look at because when you look at the, the, connectivity right now in the region literally the only island that's not connected now is Kosrae. Every, every one of those islands are connected and I think, you know, the University of Guam is already playing a leadership role in advanced education and I think we can expand that, uh, through its connections and obviously through all the different, um, uh, companies that are participating in that investment on that undersea fiber and we're, you know, we're very active in it, but there are a number of parties there and so I think, you know, that's an opportunity for them to think through this, this, pandemic response, but and then I think probably, you know, like, like, everybody else, you know, and I'm, you know, catching the news is just really everything around safety and cleanliness of what's happening at the university so that when they do reopen and there are students coming back that they're creating an environment that people feel safe at so, you know, I just applaud, you know, the things that they're doing.

Senator Regine Biscoe Lee: Roland thank you so much for sharing your perspective about, um, challenges around making tough decisions around change management and really trying to focus on on people and, and, our shared mission, because I think that's going to be really critical going forward and, and, also looking at this very daunting challenge, uh, this dynamic situation around COVID the pandemic and really using it as an opportunity right to get creative to use our resources and, and, as you were stating to really continue to lead in the region and so I'm really grateful that you've decided, uh, with all the other things on your plate

So one of the things that I'm talking with Paul Huntsman about is, you know, what more can we do there, uh, particularly with them in their foundation, uh, for, for, this community, because they're so, they're so, rooted here. I mean if you guys know we've got local owners, uh, and, and, that they participated in was our first time, uh, they love the island they come back as m-, as often as they can and I know that they're really keen on, on, supporting, you know, this new aspect of, of, of, their giving which is around mental health so, you know, particularly as what the university is going to be doing in that realm, you know, I'm interested to understand, you know, how we can help in that area.
