§ 1105. Powers.

The Authority shall have and exercise each and all of the following powers:

(a) Acquire, construct, reconstruct, purchase, better, extend, improve, operate and maintain airports and related facilities owned or used by Guam for civil aviation purposes.

(b) Acquire by grant, purchase, gift, devise, lease, permit, right of entry or by the exercise of the right of eminent domain in accordance with the provisions and subject to the limitations of laws of Guam including 5 GCA Chapter 5 [Procurement Law], and hold and use any real and personal property necessary, convenient or useful for the carrying out of any of its powers pursuant to the provisions of this Chapter, and to dispose of the same.

(c) To construct, operate and maintain runways, taxiways and related airport facilities on property owned by the United States and used by Guam pursuant to agreement with the United States.

(d) To assume the benefits and obligations of Guam under that certain Joint Use Agreement executed between Guam and the United States on July 19, 1974, and to assume or enter into agreements executed pursuant to said Joint Use Agreement, all the above being performed as an instrumentality of the government of Guam.

(e) To impose, prescribe, revise and collect fees, rates, rentals, landing fees and charges for the use and services of, and the facilities and commodities furnished by the airports operated by the Authority and to charge and collect any fees permitted by the Joint Use Agreement, and to pay charges and costs imposed by said Agreement upon Guam.

(f) To acquire from the United States, under any appropriate federal statute, lands made available for airport purposes to Guam and to comply with the conditions

established by the United States as necessary for the acquisition of such lands.

(g) To apply for, receive and use, all according to the terms thereof, grants-in-aid, or grants-in-kind from the United States for use by the Authority for airport purposes.

(h) To make and enter into contracts, leases, concession agreements and permits and to execute all instruments necessary or convenient in the exercise of its powers, including without limitation, the purchase of liability and casualty insurance for airport purposes, adopt a seal and sue or be sued in its own corporate name.

(i) To, at any time and from time to time, issue general or special revenue bonds pursuant to Article 2 of this Chapter.

(j) To enter into leases with the government of Guam or with the United States, provided that no such lease shall exceed forty (40) years in duration.

(k) To employ agents and retain or contract for the services of qualified consultants, specialists or experts, as individuals or as organizations, to advise and assist the Authority and its employees, all of which may be accomplished without regard to the portion of the Personnel Laws relative to compensation.

(l) To adopt such rules and regulations, pursuant to the Administrative Adjudication Act, as may be necessary for the exercise of powers and performance of the duties conferred or imposed upon the Authority or the Board.

(m) To do any and all other things necessary to the full and convenient exercise of the above powers.

Nothing contained in this Section, or by implication in this Chapter shall be construed to be in any way in derogation or limitation of powers conferred upon or existing in the Authority or in the Board by virtue of the Organic Act, the laws of Guam or the Government Code.

§ 1106. Board of Directors.

(a) All powers vested in the Authority, except as provided herein, shall be exercised by the Board, which shall consist of seven (7) members, called directors, who shall be nominated and appointed by the Governor, by and with the advice and consent of the Legislature. Each director shall serve a term of three (3) years from the expiration of the term for which such director's predecessor was appointed, and until a successor is appointed and qualified, or in the case of a director appointed to a newly created membership in the Board, such director shall serve a term of three (3) years from the date of initial appointment, and until a successor is appointed and qualified. All vacancies occurring in the office of director shall be filled by the Governor in the same manner as for full-term appointments, but only for the unexpired term of the director whose vacancy is being filled.

(b) Four (4) directors shall constitute a quorum of the Board for the transaction of business. The Board may adopt rules and regulations governing the conduct of its affairs. It shall elect a chairman and a vice-chairman from among its members. It shall appoint a secretary who shall not be a member of the Board and who shall maintain all records and minutes of the Board.

(c) Each Director shall receive the sum of Fifty Dollars (\$50.00) for his attendance at any meeting of the Board, but such compensation shall not apply to more than two meetings in any one calendar month. No Director shall receive any other compensation, but shall be reimbursed for actual travel, subsistence and out-of-pocket expenses incurred in the discharge of his responsibilities, including authorized attendance at meetings held away from Guam.

§ 1107. Executive Manager.

(a) The Board shall appoint an Executive Manager, who shall be its chief executive officer. The Executive Manager shall serve at the pleasure of the Board, which shall fix his compensation. The Executive Manager shall have full charge and control of the operations and maintenance of the airports controlled by the Authority, and of the construction of any

- Appointment packet forwarded to this committee for public consideration on June 23, 2020.

II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 4:13 PM.

Vice Speaker Telena Cruz Nelson: All right. If there are no further questions, I'll move forward with Mr. Zenon Belanger, is he here?

Zenon E. Belanger, Appointee: Right here.

Vice Speaker Telena Cruz Nelson: Okay, sorry. You guys are far away, so, it's kind of hard to see your faces. Okay, so Mr. Belanger, do you have anyone testifying on your behalf?

Zenon E. Belanger, Appointee: Not that I know of.

Vice Speaker Telena Cruz Nelson: Okay, so, go ahead and proceed with your testimony, please, thank you.

Zenon E. Belanger, Appointee: *Håfa adai*, Madam Vice Speaker and Committee Members. Thank you for the opportunity to provide testimony regarding my reappointment to the A.B. Won Pat Guam International Airport Authority Board of Directors.

I'm honored to be reappointed by the Governor Lou Leon Guerrero to serve on the Board of Directors. The past year has been fruitful in learning how the airport works and how it ties with our

economy tourism and the lifestyle on Guam; working with our airline partners, the Federal Aid Aviation Agency, our neighboring island airports.

We continue to improve air travel, partnering with other government agencies. We have taken various steps to ensure that we tackle the COVID-19 pandemic and keep our islands safe. We continue to improve facilities, improve the quality of our services and work to make sure the experience of coming to Guam an enjoyable experience for our residents and tourists.

Thanks again for entertaining my reappointment.

Vice Speaker Telena Cruz Nelson: Oaky, Mr. Belanger, just a couple questions. Your time as a board member, what are some of the challenges that you faced with and the solutions that you provided?

Zenon E. Belanger, Appointee: As a Civil Engineer, I was faced with the fact that we were asked to look at the current projects here at the airport and we've done that. We've created a CIP Committee so, that we could look and review the various projects and see how we can facilitate them.

Vice Speaker Telena Cruz Nelson: Can you elaborate?

Zenon E. Belanger, Appointee: I think there's 3 or 4 current projects that are under construction. We have the runway improvements with the third floor corridor and I think and we have the ARF Building which is the fire station for a lack of a better word.

So, looking at how you know what are the schedules look like. Are they within budget and if not what are we doing to facilitate the project so, we can get it done?

Vice Speaker Telena Cruz Nelson: So, can you tell us a little bit about the third floor corridor?

Zenon E. Belanger, Appointee: Currently the contractor is working to complete it. The milestone that we're looking at right now is in October of this year, 2020. We will be opening up the corridor that will connect into CBP, Customs and Border Patrol, where they screen you for as you're coming in and so, that'll be the milestone and then once we get the remaining work completed – the contractor is looking at trying to get this thing done as soon as possible in 2021.

Vice Speaker Telena Cruz Nelson: I'm sorry, you said that you're looking at the corridor to be completed in October 2020 and then the contractor to do something in 2021?

Zenon E. Belanger, Appointee: No, a portion, the west wing, which is almost done. There's the west wing and the east wing. The west wing is on the Agana side of the airport. That portion will be ready to be connected to CBP and have the passengers go up through there and down into CBP and be separated from the outgoing passengers and that's slated to open in October of 2020.

Once that's completed then we will continue to the east wing which is on the Dededo side of the airport and continue with the improvements on that side of the airport and that we're looking at trying to complete sometime in 2021.

Vice Speaker Telena Cruz Nelson: Have any of the CIP that the top 3 that we are looking at; the third floor corridor, the expansion of the runway and the ARF building. Have any of these CIP been impacted by the COVID-19 pandemic due to a halt in the flights or...(inaudible).

Zenon E. Belanger, Appointee: (inaudible). The new procedures that the construction workers have to go through with the social distancing, the mask and all the other stuff like that slows the construction down slightly but the work is progressing.

Vice Speaker Telena Cruz Nelson: Okay, very good. What do you plan to improve during this term as a board member?

Zenon E. Belanger, Appointee: I'd like to improve the facilities in terms of the operations of the facilities and then the engineering part because that's my background and have you know better communications with those departments with the rest of the administration.

Vice Speaker Telena Cruz Nelson: Can you explain a little bit further?

Zenon E. Belanger, Appointee: We have a small staff and sometimes it's overwhelming. So, we may have to look at you know do we need to improve you know build the staff up, get the right type of people. We've had people here that have been here for a quite a while. They're all talented but it's also trying to figure out you know what's the best use of the talents.

Vice Speaker Telena Cruz Nelson: Okay, thank you, that is all the question I have at this time. Senator Taitague, Minority Leader, would you like to ask any questions?

Senator Telo Taitague: Thank you, Madam Chair and thank you, Mr. Belanger for stepping up to the plate as well. It's good to know that there's an engineer on board you know with all the construction that's going on with the airport. Greatly appreciate it. Doesn't it seem that you were just in front of us last year getting confirmed in the same position.

Zenon E. Belanger, Appointee: Yes, I was.

Senator Telo Taitague: Okay, I thought so, when you're back here. I guess you were just filling in and I kind of figured it out after a while that you're just filling in and now you're going for the 3 year term. So, again the good Chair asked all the questions I had especially on an engineering point of view. So, I really appreciate it again for your time and good luck to you. Thank you.

Zenon E. Belanger, Appointee: Thank you very much.

Vice Speaker Telena Cruz Nelson: Thank you, Senator Taitague. Mr. Belanger, we also have letters of support from the Executive Manager, Mr. John M. Quinata and the Board Chairman, Brian Bamba on your behalf.

It's all the questions we have at this time. Now we'll move on with our next candidate, Mr. Gurvinder "Bic" S. Sobti.
