

1 **BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF**
2 **GUAM:**

3 **Section 1.** §5150 of Part F, Article 2, Chapter 5 of Title 5, Guam Code
4 Annotated, is hereby *amended* to read:

5 **“§5150. Duties of the Attorney General.**


1 The Attorney General, the Deputy Attorney General *or* such Assistant
2 Attorneys General, or such Special Assistant Attorneys General as the
3 Attorney General may designate, *shall* serve as legal counsel and provide
4 necessary legal services to the Policy Office and the General Services
5 Agency. Whenever the Chief Procurement Officer, the Director of Public
6 Works, or the head of any executive branch agency, autonomous agency,
7 instrumentality or public corporation of the government of Guam conducts
8 any solicitation or procurement which is estimated to result in an award of
9 Five Hundred Thousand Dollars (\$500,000) or more, the Attorney General
10 or his designees, including one (1) *or* more Special Assistant Attorneys
11 General who may be so designated or appointed by the Attorney General
12 and subject to any reasonable requirements or conditions determined by the
13 Attorney General, *shall* act as legal advisor during all phases of the
14 solicitation or procurement process. The Attorney General, or his designee,
15 including one (1) *or* more Special Assistant Attorneys General *shall*, in
16 addition, when he approves contracts, determine not only the correctness of
17 their form, but their legality. In making such a determination of legality, he
18 may require any or all agencies involved in the contract to supply him with
19 evidence that the required procedures precedent to executing the contract
20 were carried out. He or his designees *may* prescribe the forms and format
21 required to be followed by the agencies in aiding him in his determination of
22 form and legality.”

23 **Section 2. Effective Date.** This Act *shall* be effective upon enactment.

Subject: Request for Emergency Certification - Bill No. 434-30 (LS)

I am writing to request for an emergency declaration pursuant to 2GCA§2103 on the matter of Bill No. 434-30 (LS) – “AN ACT TO AMEND § 5150 OF CHAPTER 5 OF TITLE 5 OF THE GUAM CODE ANNOTATED, RELATIVE TO PUBLIC LAW 72-30 AND THE DUTIES OF THE ATTORNEY GENERAL.”

Bill No. 434 would authorize the Attorney General to appoint Special Assistant Attorneys General to conduct reviews of major procurement solicitations mandated by Public Law 30-72. The Attorney General has advised that there are currently thirty-one solicitations before his office for review and that his office is unable to conduct required reviews in a timely manner. As many of the solicitations deal with health and safety issues, the delay in the procurement process will jeopardize the health and safety of our residents.

Twenty-five of the thirty-one solicitations originate from autonomous entities, all of which engage legal services independent of the AG's office. The appointment of these agency legal counsels as Special Attorneys Generals will allow the procurement process to proceed without delay.

To ensure that the health and safety of our residents are not adversely affected by undue delays in the procurement process, I respectfully request an emergency declaration be made on this matter, and that you grant a waiver of the public hearing requirement.


