

**AN ACT TO CREATE THE 12TH FESTIVAL OF
PACIFIC ARTS COORDINATING COMMITTEE.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings.** The Festival of Pacific Arts is
3 recognized as a major international cultural event, and is the largest gathering in
4 which Pacific peoples unite to gain respect for, and appreciation of, one another
5 within the context of the changing Pacific. The hosting of the 12th Festival of
6 Pacific Arts in 2016 will be one of Guam's major cultural, technical, and economic
7 challenges, requiring broad community participation and cooperation. The Festival

1 will also provide tremendous opportunities for social and cultural exchanges,
2 especially with the exposure of local products, all of which can be used to enhance
3 tourism within our island. The hosting of this Festival in 2016 will be an
4 opportune time for the people of Guam to involve and educate the thousands of
5 newcomers to our island about who we are as *Chamorros*, coupled with the
6 uniqueness of our culture as Pacific Islanders, and the importance of maintaining,
7 perpetuating, and respecting our cultural identity.

8 **Section 2. Coordinating Committee Created.** There is hereby
9 established, under the Office of *I Maga'lahaen Guåhan* (the Governor of Guam),
10 the 12th Festival of Pacific Arts Coordinating Committee, whose duties and
11 responsibilities shall include:

12 (a) The organization of committees and sub-committees for the
13 implementation of programs and other work deemed necessary and requisite for
14 the successful conduct of the 12th Festival Of Pacific Arts to be held on Guam in
15 2016;

16 (b) The preparation and execution of plans, programs, and budgets
17 requisite for the preparation for and successful conduct of the 12th Festival of
18 Pacific Arts by Guam;

19 (c) The management of funds, equipment, and other properties,
20 appropriated, loaned, contributed to, or raised for the purpose of preparing for and
21 conducting the 12th Festival of Pacific Arts in Guam;

22 (d) The submission of regular reports to *I Maga'lahaen Guåhan* (the
23 Governor of Guam) and to the Speaker of *I Liheslatura* (the Legislature), itemizing
24 and detailing the progress being made for and toward the purposes set out in this
25 Section; and

1 (e) The submission of such other reports as may be, from time to time,
2 required by *I Maga'lahi* (the Governor) or the Speaker of *I Liheslatura* (the
3 Legislature).

4 **Section 3. Composition.** The following *shall* constitute the membership
5 of the 12th Festival of Pacific Arts Coordinating Committee (the “Committee”):

6 (a) The President of the Department of *Chamorro* Affairs;

7 (b) the Executive Director of the Guam Council on the Arts and
8 Humanities Agency;

9 (c) three (3) members, to be appointed by *I Maga'lahi* (the Governor),
10 representing the organizations active in the promotion of the arts on
11 Guam;

12 (d) a member of the Mayors’ Council of Guam, appointed by the
13 President of the Mayors Council;

14 (e) two (2) members of *I Liheslatura*, to be appointed by the Speaker,
15 who may designate himself;

16 (f) the Chairperson of the Committee on Cultural Affairs of *I*
17 *Liheslaturan Guåhan* or its successor;

18 (g) the Chairperson of the Board of Directors of the Guam Visitors
19 Bureau or his designee; and

20 (h) the Speaker of the Guam Youth Congress or his designee.

21 **Section 4. Officers.** The Committee *shall* elect its chairperson, who *shall*
22 be the Committee’s presiding officer, its vice chairperson, its secretary and its
23 treasurer, and *shall* assign such duties to each office as it deems necessary. The
24 Committee *shall* establish such rules of order or procedure as it deems appropriate.

COMMITTEE REPORT DIGEST

I. OVERVIEW

The Committee on Tourism, Cultural Affairs, Youth, and Public Broadcasting convened a public hearing on Tuesday, October 20, 2009 at 2:00 p.m. in *I Liheslatura's* Public Hearing Room. The item on the agenda was the consideration of Bill No. 189 (COR) – “An act to create the 12th Festival of Pacific Arts Coordination Committee,” sponsored by J.V. Espaldon, B.J.F. Cruz and R.J. Respicio.

Public Notice Requirements

All legal requirements for public notices were met. Notices were disseminated via e-mail, facsimile, and hand delivery to all senators and all main media broadcasting outlets on Monday, October 12, 2009, and again on Thursday, October 15, 2009, with requests for publication in the Marianas Variety and the Pacific Daily News. Notice of the hearing also was posted on the Guam Legislature’s website and published in the Pacific Daily News on October 19, 2009.

The public hearing was called to order at 2:00 PM.

II. SUMMARY OF TESTIMONY AND DISCUSSION

Vice Speaker B.J.F. Cruz called Francisco C. Lizama, Sylvia M. Flores, Mary C. Torres, and Jackie Balbas to testify.

Francisco C. Lizama, Member, Department of Chamorro Affairs Board of Trustees appeared before the Committee in **support** of Bill No. 189. Mr. Lizama greeted the committee members present, introduced himself as a member of the DCA Board, an artist and a student of Chamorro culture. He read from submitted written testimony, attached.

Vice Speaker Cruz recognized the presence of the main sponsor of Bill No. 189, Sen. James V. Espaldon, and invites him to make opening statements.

Sen. Espaldon discussed resolution presented in 2008 and the granting of the privilege to Guam of hosting the 2016 Festival of Pacific Arts. Stated Guam needs to start organizing now because a lot of development will be going on alongside the planning and he does not want planning to get lost in the buildup.

Vice Speaker Cruz thanked Sen. Espaldon and asked Jackie Balbas, Guam Council on the Arts and Humanities Agency to read from CAHA Executive Director Patrick Bamba's submitted written testimony.

Jackie Balbas, Program Coordinator I, CAHA, appeared before the Committee in **support** of Bill No. 189 and read from CAHA Executive Director Patrick Bamba's submitted written testimony, attached.

Mary Torres, Member, Department of Chamorro Affairs Board of Trustees, appeared before the Committee in **support** of Bill No. 189. Torres stated for the record she is in full support of the bill and in agreement with Sen. Espaldon that the planning needs to begin now—specifically deciding upon a venue at which to hold the Festival of Pacific Arts. From her experience with the annual Micronesian Island Fair at Ypao, she said a permanent structure should be planned and built for such purposes. Ms. Torres also stated, a permanent panel that does not change with the executive administration should be established.

Sylvia M. Flores, President, Department of Chamorro Affairs, appeared before the Committee in **support** of Bill No. 189 and read from her submitted written testimony, attached. She also presented the Chamorro Village and Paseo de Susana Master Plan Summary illustration, both attached.

Sen. Espaldon addressed Mr. Lizama and clarified that he is suggesting the DCA has oversight of this. He then addressed Ms. Torres and clarifies that she suggested a permanent body be established to oversee. Both concur that this is what they meant. Ms. Torres does not want the committee established to change within a year or after a term of administration.

Ms. Flores said a priority is establishing one key location and an organized body.

Sen. Espaldon asked then if Ms. Flores is in favor of keeping FestPac under DCA. **Ms. Flores** responded that a lot of the emphasis falls under the DCA's purview.

Sen. Espaldon said he is trying to resolve Ms. Torres's proposal. If purview is granted to DCA, the President will leave after a given administration's term ends. **Ms. Flores** responded that DCA has a staff to which she will leave the duties of overseeing FestPac.

Sen. Espaldon referred to the attached illustration, provided by Ms. Flores and asked whether this place could serve as the cultural activities center.

Ms. Flores responded "yes."

Sen. Telo Taitague asked whether anyone has appeared from the Governor's office and asked Ms. Flores whether he has accepted the bill.

Ms. Flores states she is not aware and did not speak to the Gov. on the matter. CAHA still has the open account of the Festival. Though she does not know how much cash is left in it, she

has told CAHA to leave the account open “as we move toward fundraising for the Chamorro Village.”

Sen. Taitague clarified that the account is for FestPac specifically and asked whether they are allowed to receive donations.

Sen. Aguon stated that in conjunction with the promotion of this particular festival, he would like to see there is much more emphasis placed on the Chamorro culture and language. He affirmed he is extremely supportive of this and any proposal that would attempt to preserve our language and our culture. He then addressed Ms. Torres to clarify that, as yet, there is no venue.

Ms. Torres stated that Paseo, in its present state, is not suitable to host FestPac. She agreed with the conceptual design (attached illustration) and said if it is completed it will be suitable to host FestPac.

Sen. Aguon stated there is no direct request for funding and asks whether this is because they are waiting for the proposed coordinating committee to form and prepare a financial plan or because they are waiting for the next budget cycle.

Ms. Flores responded that it is the former reason.

Sen. Aguon then stated he would prefer providing the proposed committee with seed money.

Ms. Flores said she reached out to many of the planners for the American Samoa group and they received money from the Department of the Interior. She remembers she was hosted by a village once before and says Guam needs to reach out to its different villages to host the visiting communities.

Sen. Aguon stated that just by virtue of allowing some of the events to be held down south, we would be exposing all the different areas of our island, telling the entire Guam story.

Vice Speaker Cruz interjected that there may be some misunderstanding on the intent of the bill but the sponsors could add another section to it, as in, “With the passage of this bills, an appropriation of x amount of dollars for the director and one staff member.” He then addressed Ms. Torres, stating that her idea intrigues him and there is nothing worse than a change of administration while planning to host a large event. He referred to his experience with the South Pacific Games.

Ms. Torres said it is important to remember that this will be the core planning committee and although it will serve as the working engine, ultimately it is the government that has jurisdiction, Department of Chamorro affairs, for example.

Vice Speaker Cruz said this has to be a full-time job for a number of years for someone to oversee this.

Sen. Espaldon addressed Ms. Flores and clarified whether she means to use the FestPac account to raise funds for Chamorro Village Paseo master plan. He is concerned that a successful hosting of the festivities is not related to the successful completion of this plan (gestures to attached illustration).

Ms. Flores affirmed the account is there, the fund is there and it has nothing to with the Paseo de Susana or the Chamorro Village.

Vice Speaker Cruz advised against comingling the funds and said they will close the books on it and start a new account. He then calls Leonard Iriarte, Judy Flores and Rita Franquez to testify.

Rita Franquez appeared before the Committee in **support** of Bill No. 189 and stated she is very excited about projects and things of this nature happening in Hagåtña, though she does not see any real money put toward it. She went on to point out that before anyone pursues such “glorious and very noble” projects, they ought to take a look at Skinner Plaza and Plaza de España, as they are deteriorating. She then encouraged the Legislature to reclaim buildings it already owns.

Vice Speaker Cruz thanked Ms. Franquez and assures the Legislature is moving toward this direction.

Sen. Espaldon stated the one other edifice mentioned by Ms. Franquez, the Spanish Palace, is being addressed by the Guam Historic Preservation.

Judy Flores appeared before the Committee in **support** of Bill No. 189 and stated the first order of business is to get this commission going, get a dynamic person who can move forward with fundraising, a good grant writer.

Leonard Iriarte, *I Fanalaian Oral History*, appeared before the Committee in **support** of Bill No. 189 and concurred with all testimony previously given. He stated the incredible impact FestPac has had on Guam’s resurgence of culture.

Raphael Unpingco, *Inadahen I Lina’la Kotturan Chamoru*, appeared before the Committee in **support** of Bill No. 189 and concurred with all testimony previously given. He referred to his experience at Palau’s 2004 FestPac and stated his organization would like to give whatever help it can in the forming of the proposed committee.

Sen. Tina Rose Muña Barnes requested the addition of her name to co-sponsor the bill and suggested the mayors be included in the proposed committee.

Sen. Espaldon stated he is pleased there has been unanimous support and considered rethinking the composition in the interest of putting forth “our very best efforts.”

Vice Speaker Cruz thanked the public for coming and providing testimony and announced he will leave the record open for an additional ten (10) days for submissions of written testimony.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Tourism, Cultural Affairs, Youth, and Public Broadcasting finds that in 2016, Guam will host 12th Festival of Pacific Arts, the largest cultural event held in our region. Twenty-seven Pacific island nations and territories will send representatives to Guam to showcase their respective culture's visual arts, music, cuisine, dance, jewelry, crafts, and storytelling. Because of the magnitude of the event, the large number of guests expected to attend and the logistical planning for their accommodations and showcase venue, much consideration, planning, and fundraising must occur well ahead of the event. The creation of a 12th Festival of Pacific Arts Coordinating Committee, as called for in Bill No. 189 will enable Guam to adequately prepare to host the festival. The creation of a coordinating committee is absolutely necessary to produce an exhibition worthy of our neighboring islands' talent and audience.

The Committee finds further that the coordinating committee would be well-served by involving Guam's mayors in the planning and execution of the festival events. As such, the Committee recommends the addition to Bill No. 189 of a Mayors' Council representative to the 12th Festival of Pacific Arts Coordinating Committee. Accordingly, the Committee substitutes Bill No. 189 to effect this change.

A Fiscal Note was requested of the Bureau of Budget and Management research on August 28, 2009 and one was not received by the Committee. Pursuant to 2 GCA §9105, requirement for a Fiscal Note is waived.

The Committee on Tourism, Cultural Affairs, Youth, and Public Broadcasting, to which was referred Bill No. 189(COR), hereby submits these findings to *I Mina' Trenta na Liheslaturan Guåhan* and reports out Bill No. 189-30 (COR) as substituted by the Committee, with the recommendation **TO DO PASS**.

The hosting of the 12th Festival of Pacific Arts in 2016 will be one of Guam's major cultural, technical, and economic challenges, requiring broad community participation and cooperation. The festival will also provide tremendous opportunities for social and cultural exchanges especially with the exposure of local products, all of which can be used to enhance tourism within our island. The hosting of this festival in 2016 will be an opportune time for the people of Guam to involve and educate the thousands of newcomers to our island about who we are as Chamorros coupled with the uniqueness of our culture as Pacific Islanders and the importance of maintaining, perpetuating and respecting our cultural identity.

Section 2. Coordinating Committee created. There is hereby established, under the Office of the Governor of Guam, the 12th Festival of Pacific Arts Coordinating Committee, whose duties and responsibilities shall include:

(a) The organization of committees and sub-committees for the implementation of programs and other work deemed necessary and requisite for the successful conduct of the 12th Festival Of Pacific Arts to be held on Guam in 2016;

(b) The preparation and execution of plans, programs and budgets requisite for the preparation for and successful conduct of the 12th Festival of Pacific Arts by Guam;

(c) The management of funds, equipment and other properties, appropriated, loaned, contributed to, or raised for the purpose of preparing for and conducting the 12th Festival of Pacific Arts in Guam;

1 (d) The submission of regular reports to the Governor of Guam and to the Speaker of the
2 Legislature itemizing and detailing the progress being made for and towards the purposes set out in
3 this Section; and

4 (e) The submission of such other reports as may be, from time to time, required by the
5 Governor or the Speaker of the Legislature.

6 **Section 3. Composition.** The following shall constitute the membership of the 12th Festival
7 of Pacific Arts Coordinating Committee (the "Committee"):

8 (a) The President of the Department of Chamorro Affairs;

9 (b) The Executive Director of the Guam Council on the Arts and Humanities Agency;

10 (c) Three (3) members to be appointed by the Governor representing the organizations active
11 in the promotion of the arts on Guam;

12 (c) The Speaker of the Legislature, who may appoint a representative; and,

13 (d) The Chairperson of the Committee on Tourism, Cultural Affairs, Youth and Public
14 Broadcasting of the 30th Guam Legislature, or its successor.

15 **Section 4. Officers.** The Committee shall elect its chairperson, who shall be the Committee's
16 presiding officer, its vice chairperson, its secretary and its treasurer, and shall assign such duties to
17 each office as it deems necessary. The Committee shall establish such rules of order or procedure as
18 it deems appropriate.

Guam will be able to share our culture with our Pacific Island brothers and sisters and further develop our relationships. In addition, the festival in 2016 will bring global focus and recognition to our island as media coverage will extend well beyond our shores.

I am in favor in moving our island forward in the preparation of a very prestigious event for our community, The 12th Festival of Pacific Arts, which I feel is not too far away.

Given the responsibility of hosting this event, what is first and foremost is for this able body to officially identify the one agency which is responsible to administer the task in leading this committee. Over the past years, administrations have struggled to identify the department to lead the plans and delegation to a Festival. It is important that we take the planning to heart and look at the objective of having this festival. The lead agency must be able to promote and preserve our precious Cultural Heritage; safeguarding, preserving, protecting and promoting of our cultural heritage regionally and nationally. I recommend this legislative body look at the Department of Chamorro Affairs as the lead agency so that there is no question where official files are stored and properly documented, as well as being the official contact for other Pacific Island jurisdictions to ensure a clear line of communication. In the past it has been difficult to access prior year festivals' documents in order to plan for upcoming festivals. For the record, prior to 2008, there was little to none of FestPac paraphernalia (videos, tapes, literature, etc.). DCA, however, has created a FestPac library to ensure accountability and future planning purposes. Therefore, it is imperative for a single Government entity to be responsible for official correspondences and administrative oversight of Guam's participation in the Festival of the Pacific Arts.

Si Yu'os Ma'åse for your time and I hope you consider my recommendation's when finalizing Bill 189.



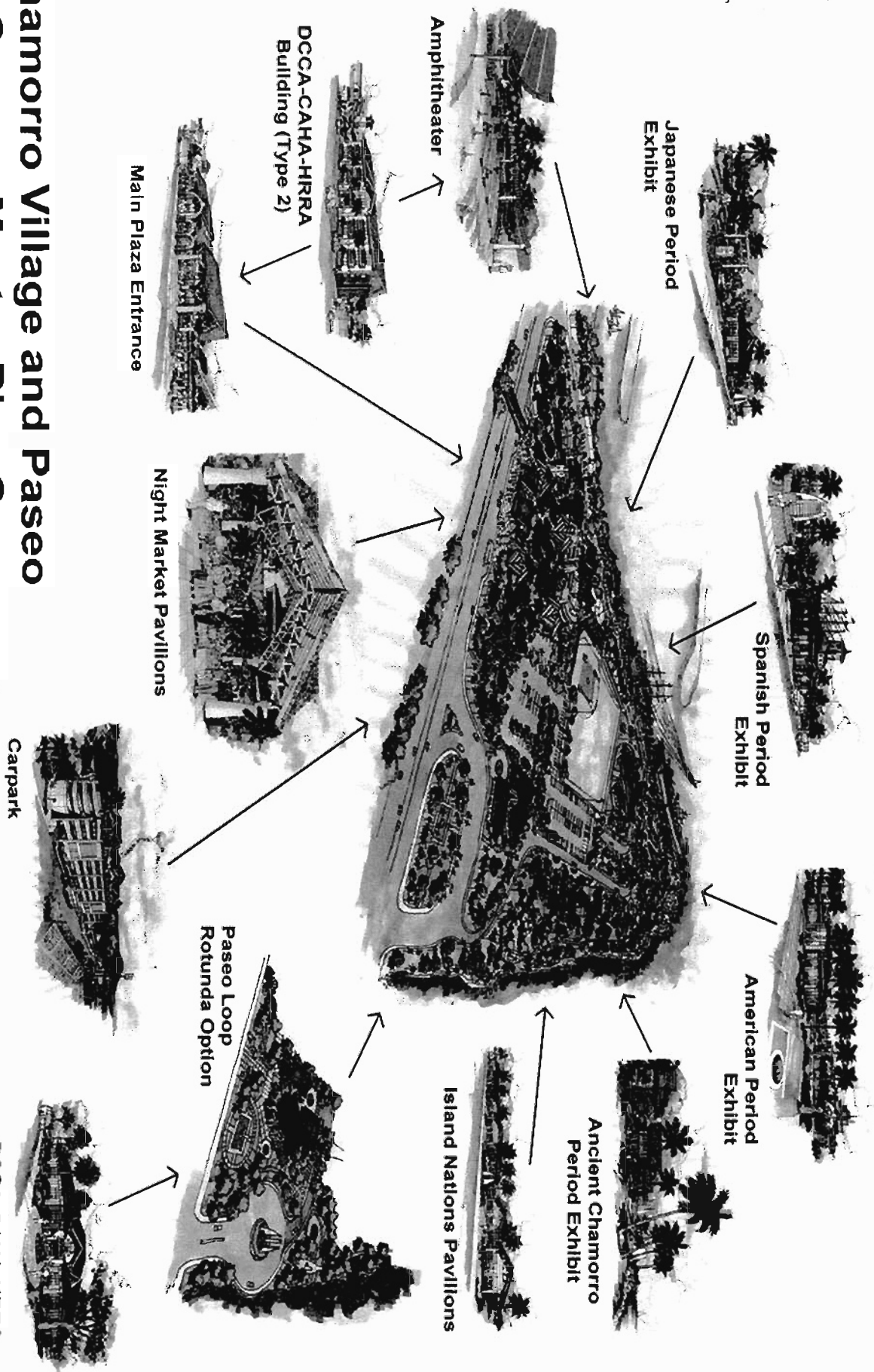


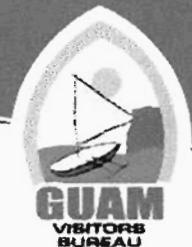
