**AN ACT TO AMEND §72106(a) OF CHAPTER 72 OF
TITLE 10 OF THE GUAM CODE ANNOTATED,
RELATIVE TO THE FIRE, LIFE AND MEDICAL
EMERGENCY FUND ('FLAME').**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** §72106(a) of Chapter 72 of Title 10, Guam Code Annotated, is
3 hereby *amended* to read:

4 **“§72106. Fire, Life and Medical Emergency Fund ('FLAME').**

5 (a) Creation of Fire, Life and Medical Emergency Fund (“FLAME”).

6 There is hereby created the Fire, Life and Medical Emergency Fund

1 (“FLAME”). Sixty percent (60%) of all monies deposited within the Fund
2 *shall* be used for the purchase, critical maintenance and repair of essential
3 emergency rescue and firefighting vehicles, emergency life support and
4 medical equipment, and training for Emergency Medical Technician and
5 Paramedic certifications. Forty percent (40%) of all monies deposited within
6 the Fund *shall* be used to pay for emergency medical and paramedic certified
7 firefighter salary adjustments required by 4 GCA § 6223 and § 6231 and 10
8 GCA § 72105.3. The Fund *shall* be under the control of the Guam Fire
9 Department and the Director of Administration (the Director). The Director
10 *shall* administer the Fund and release the necessary monies upon request by
11 the Fire Chief for expenditures authorized by this Section. The Director *shall*
12 report on a quarterly basis to the Speaker of *I Liheslaturan Guåhan* the
13 revenues collected and expended from this Fund and post the same on the
14 Department’s website.”


