



### **COMMITTEE REPORT NARRATIVE**

#### **I. OVERVIEW**

The Committee on Municipal Affairs, Aviation, Housing, and Recreation convened a public hearing on Monday, November 30, 2009 at 9:00 a.m. in *I Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of Bill No. 279-30 (COR) – “An act to add paragraph (i) to §40128 of Chapter 40, Title 5, Guam Code Annotated relative to actions taken by the municipal planning councils,” sponsored by F.F. Blas, Jr., T.R. Muña Barnes, and T.C. Ada.

#### **Public Notice Requirements**

All legal requirements for public notices were met. Notices were disseminated via hand-delivery and e-mail to all senators and all local media outlets on November 20, 2009, and again on November 23, 2009 with requests for publication in the Marianas Variety and the Pacific Daily News. Notice of the hearing was also made known on the Guam Legislature's website.

#### **II. SUMMARY OF TESTIMONY**

**Chairperson Tina Rose Muña Barnes** called the Committee on Municipal Affairs, Aviation, Housing, and Recreation to order at 10:05 a.m. Barnes read the title of Bill No. 279-30 then welcomed and introduced Senator Blas.

**Senator Blas** thanked Senator Barnes for the introduction and for co-sponsoring Bill No. 279-30. Blas briefly introduced Bill No. 279-30 then stated that he took a public hearing to villages throughout Guam. Blas stated that many people from the Municipal Planning Council for each village testified in support of Bill No. 279-30 because it gives a voice to the Municipal Planning Council to act on behalf of the people within their villages so they may report their findings to the 30<sup>th</sup> Guam Legislature and then it directs this legislative body to be able to look seriously into these acts and to perform the needed legislative actions, should they be necessary.

The Public Hearing on Bill No. 279-30 was duly heard and **adjourned** at 10:11AM. There being no oral testimony received, the Chairperson announced that the Committee on Municipal Affairs, Aviation, Housing, and Recreation will continue to receive written testimonies for the next ten (10) days.






