



**COMMITTEE REPORT DIGEST**

**I. OVERVIEW**

**BILL NO. 246-31 (COR) – “AN ACT TO ADD A NEW ITEM (Q) TO §1106 OF ARTICLE 1 OF CHAPTER 1 OF TITLE 22 OF THE GUAM CODE ANNOTATED RELATIVE TO REQUIRING THE DIRECTOR OF LABOR TO POST JOB OPPORTUNITIES AT MAYORS' OFFICES,”** was introduced by Vice Speaker Benjamin J.F. Cruz on June 23, 2011; and was subsequently referred to the Committee on Rules; Federal, Foreign & Micronesian Affairs; and Human and Natural Resources on the same date.

Senator Rory J. Respicio, Chairperson of the Committee on Rules; Federal, Foreign & Micronesian Affairs; and Human and Natural Resources convened a public hearing on Thursday, July 7, 2011 at 9:00 AM in the Legislature's Public Hearing Room. Among the items on the day's agenda was the consideration of Bill No. 246-31 (COR).

**Public Notice Requirements**

In accordance with the Open Government Law, notices were disseminated to all senators and to all main media broadcasting outlets first, on June 29, 2011, and second, on July 5, 2011. Notice was also sent to the Guam Department of Labor.

**II. SUMMARY OF TESTIMONY & DISCUSSION**

There being no objection from the Committee, **Senator Rory J. Respicio** addressed Bill No. 244, 245 and 246 together and **called to order** the hearing on said bills at approximately **11:49 A.M.**, announcing the titles of each bill and reading, for the record, the sponsor's statement (attached), submitted by Vice Speaker Cruz.

**Senator Respicio** then opened the floor for testimony.

**Mr. Jose Garrido** expressed his support for all three bills but wanted to also make a strong statement. In reference to Bill 244, he believes it's a good bill and addresses at least the employer's name, address, and telephone number. He thinks that anyone who aspires to employ an H-2 worker also has the legal responsibility of the individual. He also believes that it is a violation for a non-immigrant temporary worker to process an application in the Government of Guam. He agrees that it isn't Mr. Massey's fault, because if nobody reports it to him, then there's no way for him to know what's going on.

**Mr. Greg Massey**, Administrator for the Alien Labor Processing & Certification Division (ALPCD) at the Guam Department of Labor (GDOL), paraphrased the written testimony submitted by Labor Director Leah Beth Naholowaa.

**Mr. Massey** explained that there are systems in place to identify US workers, but regulations state that an advertisement cannot indicate the name of the employer. There needs to be this system in place because if an employer's name is reflected in a job advertisement, interested applicants will be able to directly approach the employer, whether to apply or simply to inquire as to what the advertised position entails. This would make it impossible for GDOL to monitor each situation, for example, tracking the number of applicants, which is not only part of their requirements, but is an important component in allowing them to adequately deliver services.

**Senator Guthertz** asked Mr. Massey, in regards to Bill 245, about who would conduct the job interviews? To which, Mr. Massey replied that the person who conducts the interview must be the person who normally conducts the interview and has hiring and firing authority.

**Senator Respicio** clarified that an H-1 worker could be conducting the interview, because that could be a management-level position and this bill just prohibits an H-2 from conducting the interview.

**Mr. Massey** adds that this bill would limit the employer and the power or say they have in their business.

**Senator Guthertz** asked Mr. Massey what types of enforcements are in place to ensure compliance with local and federal laws.

**Mr. Massey** explained that anyone who knows the business is familiar with him and his Division's small task force. They write up citations multiple times a week, and are consistently on top of employers. However, ALPCD doesn't publicize each of their citations, the way that other, OSHA for example, does.

**Senator Guthertz** mentioned that there is a major concern in the community that we're going to open up the island to foreign workers for the build-up. One way to quell the uneasy feeling growing from residents on the island is to open up the statistics on enforcements, on fines, and on violations the Departments finds and fixes.

**Mr. Massey**, while open to the suggestion, explained that part of their success is tied to the fact that they don't force their visibility in the media.

**Senator Guthertz** expressed her belief that this is public information and should be very transparent to help provide assurance to the people of Guam that the Department is carrying out its enforcement duties, otherwise, like right now, no one knows how the industry is being policed.

**Mr. Massey** expressed his intent to look into publication.

When the conversation moved to Bill 246, **Mr. Massey** expressed the Department's support of the bill, but also mentioned that this policy was previously in place but eventually stopped because in the end it was not effective. His concern was a technical one, regarding covering the cost of supplies for this requirement. To address this concern, though, the Department proposed an amendment to the bill to allow for the Department to electronically provide the information to each mayor's office.

**Senator Guthertz** suggested that Mr. Massey was not being realistic in that this process would not require a lot of money. She also expressed her belief that everyone on Guam would love to know what jobs are available on the island and that our printed newspapers would support and probably have a small section dedicated to this info, to read something along the lines of "Job Available Now" with further information on the job. But she also expressed her support for the electronic transmittal of this information. Even the media recognizes that this is a critical time for the island; and even using Channel 12 PBS would help get the word out. She wanted to make clear that there are ways to do this that wouldn't cost a lot of money, but will still let people know that there are jobs opportunities available.

**Senator Respicio** joined the conversation expressing his support of the Departments suggestion to provide the information by email.

**Mr. Vicente Garrido** also expressed his support of Bill 245 and has always believed in transparency. If what Senator BJ Cruz is saying in the June 6, 2011 edition of the Marianas Variety is true about what is happening at DOL, then it's sorry to say that there is corruption in progress.

**Mr. Francis Munoz** also testified in support of all three bills. His interest is in the immigration laws that apply to Guam as it does in the mainland USA. When we look at all these contractors

and the skilled workers they are looking to bring in, and yet the attorney general was hoping to take the skilled workers from our island first before bringing in workers. We have not been informed, because this Body has no idea of how many legal and illegal immigrants are here. He doesn't like that illegal aliens are running around and not being taken care of. He doesn't see INS doing their job and he hopes that that changes.

**Senator Respicio** comments on the issue of enforcement and mentions that he has considered revisiting the 70/30 funding split of the Manpower Development Fund between the Guam Community College (70%) and the Department of Labor (30%).

**Mr. Massey** adds that Guam has the strongest H-2 program in the country. The issue/problem with the H-2 hiring rates is that there are hardly any local applicants for the vacant positions. He wants to clarify the misconception that employers prefer H-2 workers because H-2 workers are "cheap labor." In fact, local employers would much rather hire US workers because they are required to do so much more in order to hire an H-2, including paying much more in fees and preparing multiple reports per year.

**Mr. Jose Garrido** talks about the ads that are run in the newspaper. He believes that as he's gone to some of the H-2 workers homes and work places, that he could fire half of them and send them back home. He poses the question, 'is everyone who comes to Guam as skilled as the ads dictate that they must be?'

**Mr. Munoz** believes that with the assistance of the Attorney General, then we can stop what's going on and try to keep it to local hiring first.

**Mr. Massey** responds explaining that if any local workers feel they were passed up because of discrimination issues, they can approach the ALPCD office.

**Senator Respicio** also wanted to add a clarification to the general misconception regarding foreign workers being "cheap labor," as he explains that H-2 workers do not get paid less, because the law requires that they are paid the prevailing wage.

**Mr. Munoz** states that we're in a financial crisis and we can't afford to be hiring people anymore. He claims that the senators will be heavily burdened.

**Senator Respicio** thanks everyone for their participation.

**Mr. Massey** adds a last comment that he hopes there will be a roundtable discussion on the issue so that he can answer all the questions that came up in more detail.

There being no further discussion, **Senator Respicio** thanked the individuals for their testimony, **adjourned the hearing at approximately 1:14 PM** and declared Bills 244, 245, and 246 as having been publicly heard.

### **III. FINDINGS & RECOMMENDATIONS**

In response to the suggestions presented during the public hearing, various amendments were made to the language of the bill, which are reflected in the substitute version of Bill 246, which is included in this report.

Dear Chairman Respicio and members of the committee:

*Buenas yan Hafa Adai* and thank you for the opportunity to present written testimony on three measures presented today for deliberation.

You and Senator Mana Silva Taijeron joined me in introducing these bills to promote transparency in the temporary labor certification process for the Temporary Non-agricultural Employment H-2B Program. The measures are as follows:

- **Bill No. 244-31 (COR)** would mandate employers to disclose their names, addresses and telephone numbers when advertising job opportunities for temporary alien labor certification.
- **Bill NO. 245-31 (COR)** would prohibit H-2(b) alien workers from hiring or processing alien labor certifications.
- **Bill No. 246-31 (COR)** would require the Director of Labor to post all job vacancies for temporary alien labor certification at all Mayor's Offices.

The Governor of Guam has delegated authority to certify that qualified workers in Guam and the United States are not available to perform the required services, and that the alien's employment will not adversely affect the wages and working conditions of United States resident workers who are similarly employed on Guam. This

process is initiated by employers submitting application for temporary labor certification to the Guam Department of Labor, which then recommends to the Governor action.

In recent months, I have been critical of whether the approval of certain applications for labor certification were warranted, given our high unemployment rate and numerous graduates from the Guam Community College.

I have been given assurances from the Guam Department of Labor that applications for labor certifications recommended for approval by the governor meet the minimal requirements of both local and federal law. However, it concerns me that only meeting minimal requirements is adequate to ensure that qualified local and U.S. workers are afforded every opportunity to fill jobs being sought for temporary alien labor.

The measures being heard today are in no way an indictment of the work of the Department of Labor. Nor is it an indictment of the integrity of employers seeking temporary alien labor under the H-2B program. However, I question whether the minimal requirements prescribed under regulations sanctioned by the U.S. Department of Labor for determining the availability of qualified U.S. workers to fill labor demands is adequate.

In recent months, I have seen advertisements for a public relations specialist, laundromat supervisor, graphic designers and bakers. After reviewing documents provided to my office under a request made under the Freedom of Information Act, I have seen the approval for certifications for specialty cooks, landscape gardeners, floral designers, butchers, air-conditioning and refrigeration mechanics, graphic designers, wedding service attendants, and automotive repairers. In another example, certification was recommended for approval to fill the position of a caregiver after 18 locals applied for the position.

Furthermore, thanks to the U.S. Congress, there is no cap on the number of H-2B workers permitted to work on Guam. Consider the number H-2B workers permitted in the U.S. mainland: a mere 66,000 for a country that boasts a labor force of 153.7 million people. There are currently about 1200 H-2B workers now permitted to work on Guam.

where the unemployment rate is now 13.3% and about 65,000 persons who are employed.

Bills 244-31, 245-31 and 246-31 are several ways to address this issue and provide some level of transparency to ensure local and qualified job seekers have every opportunity to apply for and fill positions employers are seeking to fill with alien workers. Furthermore, consumers who are concerned about well-being of our local workforce can know those companies in our community who make an earnest effort to hire locally.

The Guam Administrative Rules for Temporary Alien Labor Certification currently prohibits employers from disclosing their identities and contact information. Bill No. 244 proposes to change this so that companies that are seeking to recruit alien workers should disclose who they are. Prospective applicants should be able to apply for these vacant jobs directly with the employers. My office has consulted with the Department on amending this bill to be consistent with federal regulations.

Another reform measure is Bill No. 246-31 to mandate the Director of Labor to post job opportunities at Mayor's offices throughout the island. The Mayors' know who are unemployed in their villages. They can help spread the word and find qualified candidates.

The final bill would prohibit alien workers from conducting hiring or participating in the alien labor certification process. In recent weeks, My Senatorial office has received complaints of H-2(b) alien workers conducting job interviews on local applicants.

It is with pleasure that the Guam Department of Labor offers written testimony on three bills undergoing public hearing with your committee. After careful thought and consideration, we humbly offer the following comments on each bill:

**Bill No 244-31**

The systems to determine the availability of workers in connection with Temporary Labor Certifications in Guam, and any revisions to that system must be approved by the Commissioner of Immigration pursuant regulations in 8 CFR 214.2(h)(6)(v). The current policy was set and published as the *Administrative Policy for Temporary Alien Employment; Certification on Guam found at Federal Register Vol. 50, No.3, Friday Jan. 4, 1985, Notices*. In section (VI)(E) of the Administrative Policy the employer is required to advertise for 3 days and that the advertisement refer applicants to apply with the Guam Employment Service and that the advertisement **“shall not identify the employer’s name, address and telephone number”**

Bill 244-31 seeks to amend provisions in the Guam Administrative Rule which mirrors the federally mandated policy. Although the legislature may amend the Guam Administrative Rule as proposed in Bill 244-31, the Department and the employer would still be mandated follow the federal requirements as changes in the federal policy have not been proposed, approved by the DHS and published in the federal register as required under federal regulations.

In light of the above, the changes to the GAR proposed in Bill 244-31 would be in conflict with federal regulations and would likely not be enforceable.

The Department is in opposition to the amendment of the GAR proposed in Bill 244-31 for two reasons:

1. Language conflicts with current federal rules.
2. The inclusion of the employer's name would likely encourage applicants to apply directly with the employer, thereby limiting DOL's ability to independently verify qualified and available applicants applying for the job. By ensuring that ALL responding job seekers apply directly with the Guam Employment Service, DOL can refer applicants to multiple employers and protect workers who may be improperly rejected.

Should applicants apply directly with the employer, DOL would have no record of the applicant and would rely solely on the employer's recruitment results. An unscrupulous employer may fail to report qualified and available US applicants and Guam DOL would not have any means to be aware of the existence of the applicants unless the applicant approaches DOL with a complaint. The potential for fraud and abuse is too great should this loophole be put in place.

We understand the intent of the Bill and offer that the legislature may opt to enhance the advertising requirement **prior** to the filing of an application for Temporary Labor Certification. Recruitment efforts prior to filing (hereinafter referred to as "prior recruitment") are not structured under the current rules and typically, any recruitment done by the employer is acceptable since current rules do not quantify what prior advertisements efforts are minimally acceptable. The prior advertisement directs applicants to apply directly with the employer.

The legislature may amend the GAR by adding verbiage that mandates standards for prior advertisements by setting a duration (ie. 2 working days), or set a type (ie. Newspaper, radio, internet) or required verbiage in an advertisement such as the employer's name.

It is noteworthy to mention that increased prior recruitment will increase the employer's cost and may meet with opposition from the public.

**Bill 245-31**

In documentation submitted in the Temporary Labor Certification, as required by federal regulations, the employer assures the department that:

“The employer’s representative who interviews or considers United States workers for the job offered to the alien shall be the person who normally interviews and considers, on behalf of the employer, applicants for job opportunities.”

Bill 245-31 prohibits an H-2B worker from interviewing or being a part of the recruitment process. The Department supports this bill as it strengthens the mere assurance made by the employer by outlawing it by statute.

The concern that the Department has is the enforcement of this statute, which is not addressed in the language of the bill. Questions that come to mind are: Is violation of the statute a criminal offense or a civil offense? Who is liable for violations...the employer or the alien?

To address these questions, we suggest that language be inserted as follows:

**Section (k)(1): Enforcement- Upon verification by the Department of Labor that an unlawful interview has taken place in violation of this section, the Department shall issue a fine to the employer of not less than Five Hundred Dollars (\$500.00) for the first offense.**

This section clearly defines who investigates the violation, who is liable for a violation and what the penalty would be.

**Bill 246-31**

Bill 246-31 states:

*“( q) Shall cause the posting of all job opportunities for which applications for temporary alien labor certification have been submitted by employers at each Mayor's office.”*

The Department has no objection to the provisions in Bill 246-31, however, there is a concern as to manpower and copying costs associated with this provision. If the information can be provided electronically, we feel that the spirit of the provision can be fulfilled in a more cost effective and expedient way. To allow this, we recommend the following amended language:

"(q) Shall cause the posting of all job opportunities for which applications for temporary alien labor certification have been submitted by employers at each Mayor's office **by transmitting appropriate job announcements electronically to the email address for each Mayor's Office on Guam. A listing of email addresses, for the purposes of this section, will be provided to the Department by the Mayor's Council of Guam .**"

We hope that the comments we have provided, on the three Bills above, has been helpful in fine tuning the legislation before your committee. The Department and its staff stand ready to answer any further questions that you may have with regards to the above.




