





I. OVERVIEW

The Committee on Youth, Cultural Affairs, Procurement, General Government Operations and Public Broadcasting convened a public hearing on Thursday, March 3, 2011 at 10:00 a.m. in the Public Hearing Room of *I Liheslatura*. Among the items on the agenda was the consideration of Bill No. 74-31(COR) "An act to amend §43107 of Title 5 Guam Code Annotated, relative to the quarterly attendance report of board and commission members."



ANNOTATED, RELATIVE TO THE QUARTERLY ATTENDANCE
REPORT OF BOARD AND COMMISSION MEMBERS.**

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. §43107 of Title 5 Guam Code Annotated is hereby amended to read as follows:

“§43107. Quarterly Attendance Report Required. The chairman of each board or commission shall submit a quarterly report on the attendance of the members of the board or commission to the Governor and the Legislature.”
