Before we begin, I would like to go ahead and give the opportunity for the author of the bill to give us a short synopsis. Senator Ada?

(a) Bill Sponsor Summary.

Senator Tony Ada. What Bill No. 71 does, in Section 2603 of 11 GCA, it gives a GRT exemption to the BOSS contractor and their subs that meet the conditions of Section 58128.7 of 12 GCA. Prior to September 30, 2011 the requirements for the BOSS contractors and their subs to take the GRT exemption in Section 58128.7 of 12 GCA and there is quite a bit of exemptions to it. They were supposed to get first consideration to employment to civil service employees. They also avoid utilization of extraneous capacity and competition of Guam's businesses to require at least 75% of the BOSS contractor and its sub-contractors to be former civil service employees. The local redevelopment agencies under the BRAC process shall endeavor to have such extraneous capacities process through the BRAC. What Bill No. 71 does is..... what it did was that Public Law 31-88 repealed that section of 58128.7 of 12 GCA. This means that they no longer needed to meet the requirements of that to take the exemption. So, Bill 71 just removes the GRT exemption.

Chairman Pangelinan. Thank you very much, Senator Ada.

This concludes the public hearing on Bill No. 71-32. Senator Pangelinan,

The Department of Revenue & Taxation (DRT) hereby submits written testimony regarding the
aforementioned proposed legislation. DRT fully supports the passage of Bill No. 71-32(Cor).

We fully support the Act to repeal Paragraph (34) of §26203, Chapter 26 of 11GCA collectively known as
the BOS Contractor/Subcontractor Exemption. Upon the enactment of P.L. 27-103, the exemption law
was associated with the requirements of 12 GCA §58128.7 (Chapter 58: Qualifying Certificates). During
these periods, the Guam Economic Development Authority has confirmed that no BOS
Contractor/Subcontractor has met the requirements of §58128.7.

On September 30, 2011, P.L. 31-088 repealed 12 GCA §58128.7 in its entirety. However, P.L. 31-088 did
not address Paragraph (34) of §26203. With the repeal of §26203(k)(34), this would clarify that the
exemption will be repealed in its entirety. As with any tax exemption, the end result will always be the
loss of revenue to the Government.

Thank you for allowing the Department to provide testimony and comments to Bill No. 71-32(Cor).

Repeal of Paragraph 34 of §26203, Ch. 26, 11GCA would exclude Base Operating Services (BOS) contractors and subcontractors from exemptions. It should be noted that the Bureau has requested data from the Department of Revenue and Taxation; however, information has not been provided at the time of these comments.
