

3 that the Guam Board of Accountancy (GBOA) wishes to enter into an agreement

1 with the University of Guam Endowment Foundation, Inc. (Foundation) to
2 establish an “Agency Advised Endowment Fund Agreement” establishing a Guam
3 Accountancy Endowment Fund (Fund) for the purpose of enhancing the University
4 of Guam (UOG) School of Business Accountancy Degree Program (Program).

5 *I Liheslatura* further finds that the Fund will be administered under the
6 direction of a standing committee of the GBOA, to be composed of several
7 members from the GBOA, UOG, and other accounting professionals in our
8 community.

9 *I Liheslatura* further finds that the purpose of the Fund will be used to
10 support activities that will directly enhance the quality of the Program, and that the
11 GBOA will continue to provide leadership, mentoring, and guidance, with an
12 outside perspective in the learning experience, for UOG students who are pursuing
13 their degrees in the field of accounting.

14 It is, therefore, the intent of *I Liheslatura* to appropriate a specific sum from
15 the Guam Board of Accountancy Fund to fund the Program, which the Foundation
16 *shall* hold and administer as agreed upon by the GBOA and the Foundation, for the
17 creation of a visiting accounting professor and lecturer program at the UOG,
18 specifically for the direct enhancement of the Program.

19 **Section 2. Appropriation to the Foundation.** The sum of One Million
20 Dollars (\$1,000,000) is appropriated from the fund balance of the GBOA Fund to
21 the Foundation for the purpose of establishing an endowment fund, to be known as
22 the Guam Accountancy Endowment Fund.

23 Such Fund *shall* be administered and governed as agreed upon between the
24 Foundation and the GBOA, pursuant to the Agency Advised Endowment Fund
25 Agreement, whereby the Fund *shall* fund a visiting accounting professor and
26 lecturer program specific to directly enhancing the UOG School of Business
27 Accountancy Program.

1 The GBOA, or a duly created standing committee of the GBOA, in
2 consultation with the Accounting Faculty and the Dean of the School of Business







II. COMMITTEE PROCEEDINGS

Chairman Vicente Pangelinan: Bill 303 is a bill that would appropriate \$1M from the fund balance from the fund balance of the Guam Board of Accountancy Fund to the University of Guam Endowment Foundation, Inc. for the creation and implementation of the Herminia Dierking and John Phillips Visiting Professor and Lecturer Program.

We have signed up Annette Santos, Martha Suez Salas and Mr. Dave Sanford.

Sponsor Statement

Chairman Vicente Pangelinan. Very briefly, the bill will allow the funding of a visiting professor program named after the late Herminia Dierking and Mr. John Phillips for an accountancy program and the funding would come from the fund balance from the Board of Accountancy. It will be managed by the Executive Committee of the Endowment Fund and the Board of Regents. That is the intent of the bill. We will now receive testimony.

Mr. Dave Sanford. Hello, my name is Dave Sanford. I am the Executive Director of the Guam Board of Accountancy. Let me preface my remarks with the fact that now that we have gotten the easy stuff out of the way.... I am just going to read my testimony in support of the bill. My apologies from our Board Chair, John Onedera – he is attending a funeral this morning and could not be here.

The Guam Board of Accountancy fully supports Bill 303-32 appropriating \$1M from the Guam Board Accountancy Fund to the University of Guam Endowment Foundation for the creation and implementation of the Herminia Dierking and John Phillips Visiting Professor and Lecturer Program.

This appropriation will culminate in an agency advised endowment fund agreement - which most of us have seen and may have comments on – between the Guam Board of Accountancy and the Foundation enabling the Guam Board of Accountancy to partner with the University of Guam to supplement UOG’s accounting program. The Board of Accountancy is committed to aiding and growing the UOG accounting program to better prepare our local Guam certified public accountant candidates to excel in passing the CPA exam. As well, moving to a 150 hour education requirement for licensing – which is required throughout the United States by the other 54 jurisdictions regulating CPAs to maintain Guam’s substantial equivalency; meaning that our CPAs would be on the same footing as any CPA nationwide and can go and practice in any jurisdiction equally – challenges the UOG to provide more options for students, and GBA believes that the creation of this program driven by Guam’s public, governmental and private accounting profession leaders, is a valuable first step towards doing so.

In addition, we believe the creation of this program will encourage local businesses contributions to this endowment, to aid our community efforts in developing a resident cadre of Guam CPAs to fulfill Guam's need for future leadership.

Thank you for this opportunity. Essentially the Board is fully behind this. We've got the funds available and we are definitely ready and willing to work with the University of Guam to implement this program with their ultimate authority.

Chairman Vicente Pangelinan. Thank you very much, Mr. Sanford. Dr. Santos?

Dr. Annette Taijeron Santos. Buenas yan Hafa Adai. I am Annette Taijeron Santos. I am the Interim Dean for the School of Business and Public Administration at the University of Guam. Thank you for allowing me to offer my written testimony as well as oral testimony in support of Bill 303-32, with modification. I think the modification that I am requesting has been addressed with my discussions with our partners with GBOA and also with other members of the University of Guam Endowment Foundation. The area that I wanted to modify would be to include an accounting faculty and the dean in advisement committee to select the visiting lecturer and professor.

In general, the faculty and I are very appreciative of the intent of Bill 303-32. The bill is timely as we experience growth in our accounting majors and the need for faculty to meet this growing demand. Bill 303-32 also allows us to enhance our accounting programs and to diversify our accounting portfolio. The anticipated dynamics are exciting and we look forward to the faculty research opportunities that we can anticipate from this bill. It is our hope that the bill will also allow us to attract leaders from the accounting field to augment our program offerings and move towards the trend in the accounting program research area. I think it's a wonderful tribute to name this program after Herminia Dierking and John Phillips. These individuals represent the genuine interest that faculty should have in our students and the demonstrated commitment to providing our students with the skill sets that are necessary and the knowledge that they will need to succeed in the professional environment.

This bill is a great tribute to the legacy and also hopes to sustain our accounting program at the University of Guam. Thank you very much for this bill and Si Yu'os Ma'ase.

Chairman Vicente Pangelinan. Si Yu'os Ma'ase, Dr. Santos.

Ms. Martha Suez-Salas. Good morning, Senators, Madam Speaker and Mr. Chairman. I am one of three full time accounting faculty at the University of Guam. My name is Martha Suez-Salas and I am here to support Bill 303-32. The University of Guam as a land grant university is committed to serve and to provide quality higher education in the Pacific region. Likewise, the accounting program must abide by these high standards to serve our diverse student population and the business community that relies on the human capital that we produce. Ultimately, the curriculum should satisfy employers and student's expectations while complying with the framework outlined by the American

Institute CPAs and the University of Guam institution and program learning objectives while fulfilling the requirements of our accrediting body.

Thus, a visiting professor will provide this specialization in areas of need, such as forensic accounting, auditing and management accounting, which will serve to enhance our program and our student's understanding of these complex subjects. Our students are enthusiastic, bright and capable. But, they need the knowledge to be able to compete with off island graduates. The Herminia Dierking scholarships and the John Phillips program will offer an invaluable opportunity to our students and to the accounting program.

Thank you.

Chairman Vicente Pangelinan. Thank you very much. Zeny?

Ms. Zeny Asuncion-Nace. Hafa Adai, Mr. Chairman, Madam Speaker and Honorable Senators. My name is Zeny Asuncion-Nace and I am with the University of Guam. I am here to provide testimony in support of Bill 303-32. I am currently serving as an adjunct faculty in the School of Business with the accounting discipline. I teach the auditing class between 7pm and 8:30pm and I also facilitate the CPA examination review course on Saturdays. I am also the Controller of the University of Guam, full time.

The reason I joined the faculty pool is that I saw the necessity to strengthen the pool of instructors, specifically in the field of accounting. The University currently has a limited resource of instructors who are CPAs. There are only two CPAs in the School of Business; one is my colleague here, Martha Suez-Salas and myself, who is just an adjunct faculty. My auditing class in the Spring of 2014, out of the 23, I graduated 18 who are accounting majors and will soon be part of work force looking for a job.

If you look at the five-year history of the number of students with conferred degrees, there is an average of about 145 graduates each semester and education is about 80. Not that I am putting education second, but it quite factual. I strongly support Bill 303-32 as this will afford students a greater variety or a selection style of education or instruction and not to mention the experience of these visiting professors when they come to the University, especially in this day and age of cybercrime, fraud, identify theft, consumer fraud, etc., I think we need to prepare these students of the discipline of what's out there. Sure, we have our own taste of fraud here, but what about what is still out there? I am sure there is more to learn from the stateside comfort to what we have here on the island. So as Mr. Dave Sanford has said, pretty soon the Accounting Board will require 150 hours for the CPA examination and the University needs to be prepared to impart those instructions to our students.

Honorable Senators, Mr. Chairman and Madam Speaker, I hope you also feel strongly in supporting this bill. Si Yu'os Ma'ase, thank you and Biba UOG!

Chairman Vicente Pangelinan. Si Yu'os Ma'ase. Were there any questions? Senator Respicio?

Senator Respicio. Thank you, Mr. Chair, Mr. Speaker. I just want to recall how this Board of Accountancy Fund has matured along the way. I think it was 12 years ago when this Fund was not made separate and apart from the government of Guam, when it did not have its own checking account and when Mr. Sanford was still the Executive Director, if you recall Mr. Chairman, he had to front a lot of the money because while you had a positive fund balance, the cash balance was not the same. This was also at a time when Senator Toni Sanford was in Legislature. Having seen how this Fund evolved over the years to where you actually have a \$1M cash in your fund is something that should be part of the public record and it should be something that we should continue to express our appreciation. It shows that things do work when you separate things from the general fund.

[to Mr. Sanford] You had to spend a lot of your money and we had to hope that you got reimbursed right, Dave?

Mr. Dave Sanford. This is actually the second million that UOG is getting.

Senator Respicio. Because at one time it was about \$140 thousand that you had to front load. So, it's pretty significant.

Mr. Dave Sanford. I was out of pocket for about nine months worth of expenditures.

Senator Respicio. Thank you Mr. Chairman.

Chairman Vicente Pangelinan. Thank you very much.

Speaker Won Pat. Can I just clarify something? So, based on page 1 where it says that it will administered under the standing committee of the Accountancy Board of UOG and other accounting professionals, Dr. Salas you were suggesting that on this board you wanted to add faculty member. I didn't catch everything.

Dr. Annette Taijeron Santos. Madam Speaker, yes I requested consideration to modify to include an accounting faculty, as well as the Dean of the School of Business & Public Administration to be part of that committee.

Speaker Won Pat. Because although it says UOG, but specifically it's not just anyone at UOG, but rather these two professionals.

Dr. Annette Taijeron Santos. I believe the relevance is important.

Speaker Won Pat. Thank you. I would just like to show my support. Because you are right, we are so far away and sometimes we are limited with only the individuals that we have here and as much as we would like to expose our students and send them off island, I think what's cheaper, in the long run is to bring in these professionals. I applaud you for your work. Thank you very much, Mr. Chairman.

Chairman Vicente Pangelinan. Thank you very much, Speaker Won Pat, Mr. Mendiola and Mr. Dierking.

Mr. Mark Mendiola. Hafa Adai Mr. Chairman. My name is Mark Mendiola and I am the Executive Director for the University of Guam Endowment Foundation. I appreciate the opportunity to give oral testimony in support of this bill. We have been working with the Guam Accountancy Board on this mechanism that would help the University of Guam Endowment Foundation meet its mission. If I may, I would like to read our mission into the record so that folks understand the whole purpose of the UOG Endowment Foundation is to support the University of Guam.

The mission of the UOG Endowment Foundation is to foster and promote the growth, progress and general welfare of the University of Guam to solicit, receive, administer and disburse gifts, grants and requests of property of every kind and to hold this property in trust in such a manner that the Foundation deems appropriate for the benefit of the University of Guam. Acting as a catalyst for dynamic growth, the University of Guam Endowment Foundation perpetuates the philosophy of synergistic relationships resulting in a strong and unique institutional image throughout the Pacific Rim.

So, we firmly believe that this legislation that is before you folks would really help the University of Guam and we want to be that catalyst to support the types of activities that occur at the university. This fund would be a permanently restricted fund, specifically for this program and this project. It cannot be used for any other purposes without the express written consent between the Accountancy Board and the University of Guam Endowment Foundation. In essence, our Board of Directors will act as the fiduciary responsible agent to ensure the fund continues to grow and that mechanisms are in place so that the appropriations will be used for its intended purpose.

On behalf of the University of Guam Endowment Foundation, our Board of Directors fully support this bill and we ask that you give special consideration to this. Thank you.

Chairman Vicente Pangelinan. Thank you and Si Yu'os Ma'ase, Mr. Mendiola, Mr. Dierking.

Mr. Steven Dierking. [Read written testimony verbatim. See attached]

Chairman Vicente Pangelinan. Thank you and Si Yu'os Ma'ase, Mr. Dierking, Speaker Won Pat?

Speaker Won Pat. Thank you very much. I just want to ask – and I was only able to find it in your agreement, your MOU that is attached here that you have indicated there will be an administrative cost in which the endowment will be able to get a maximum of 2% of the fund for three years average balance. Can you explain no. 11 (in MOU), for your cost to the Fund?

Mr. Mark Mendiola. University of Guam Endowment Foundation is a non-profit organization, so we are a separate entity from the government of Guam. Some of our operational costs is through administrative fees that we tack on to the return of investments. Traditionally, most university endowment foundations tack on an administrative cost. Our cost has been at 2.5% , but through our consultation with Guam Accountancy Board and our Board of Directors, we were able to make that exception and basically it's an all in fee that we would basically manage. That is the purpose of the administrative cost; maintaining the fee to that fund and making sure that it is audited – things of that nature. Perhaps Mr. Sanford and I could elaborate a little bit more on that. But most of folks that make contributions to the Endowment Foundation, there is a stipulated donor agreement that there is a 2.5% administrative cost/fee that we charge. Other non-profit organizations usually charge between 5%-7%, but the Endowment Foundation – because we want the funds as much as possible go to its intended purpose.

Mr. Dave Sanford. Basically, the way we see it, all of – as Mark says - the endowment funds charge a management fee and it's really all over the board if you look at all the universities across the United States. We were happy with the flat 2%, which includes not only the endowment funds management administrative fee, but part of the investment management fees. The basic premise of the investment management is that we should be able to earn enough in investment earnings to actually cover this entire fee and still add to the corpus of the endowment on a continuing basis. The Endowment Fund then benefits from the administrative part of the fees so they can cover their costs of managing and also additional costs they would have in terms of fundraising to try and generate additional contributions. That's also one of the things we see as a benefit of establishing this – as a separate endowment fund it would allow all of the local businesses to make their contributions also. We are hoping we can draw in a basic annual amount from most of these two. We were happy with the 2%, being as they gave us a break from the 2-1/2%.

Speaker Won Pat. I am happy to hear that, as well that you were able to get it at 2%.

Mr. Dave Sanford. We kind of pushed them a little bit.

Speaker Won Pat. The one thing that is good is that part of the fee can be used to conduct an audit of the fund to ensure that it is truly restrictive to be used for specific purposes. It won't be at their cost; it will be part of the administrative cost.

Mr. Mark Mendiola. The way the agreement is set up is that this is basically a stipulated donor agreement and whatever is in the agreement will be maintained in perpetuity, unless the Board agrees that there would be a change or anything like that, but the enabling legislation that allow us to do and that of course we would come back for consideration. We understand that this is public money, it's in public trust but the fiduciary duty would lie with Endowment Board of Directors in consultation with the folks from the Guam Accountancy Board to ensure that the funds are used appropriately.

Speaker Won Pat. Once last comment. In future generations when they come back and they look at this legislation and then they see a name; Herminia Dierking. People always

ask what is it and I am wondering whether there is any objection to – one is to say that former senator, Herminia Dierking and the fact that they are CPAs and it's important. So, it's not just a name after somebody, but truly because of what they stood for, what they taught for many years, what they practiced and I leave that up to the Chairman to consider, but that's just a suggestion that we would like to make.

Chairman Vicente Pangelinan. Thank you very much, Madam Speaker. Dr. Underwood, thank you for joining us. I know you were here earlier and thank you for coming back.

Dr. Robert Underwood. Thank you very much Senator Pangelinan and all the Senators. Thank you very much for this opportunity. I have submitted written testimony and very much in favor of this bill. I am sure that everyone has outlined all the reasons for it and I am also grateful to the Guam Board of Accountancy and for their initiative on this. This is an excellent use of funds because as Mark has outlined it's in perpetuity and that's exactly what an endowment is suppose to be like; that's what it means to have an endowed chair. When we are able to demonstrate the viability of this effort, we would be able to demonstrate that to other potential donors who may be interested instead of thinking like one time deal. So, they'll think I'll give you some money then you can hire so-and-so or you can hire a visiting professor on a one-time deal. This is an excellent - and very common of course in a more well endowed university. So, we are very, very happy for that because this will be the first time that we really have an endowed chair. We are very grateful to the Guam Board of Accountancy, grateful to you Senator and the other Senators for anticipated support for this. Also very grateful that we are honoring former faculty members Herminia Dierking and John Phillips through this vehicle.

I have one minor suggestion. I don't know whether it has been raised already. It's in Section 2, where it says when the Guam Board of Accountancy develops the rules and regs that we put in "with the collaboration and participation of the Accounting Faculty of the University of Guam". If you read the legislation, it is implied that there are levels of collaboration, but if you don't specify that there is actual collaboration, then what happens is that people who are looking at it from the outside may say, are you ceding the authority of hiring over to an outside agency. That is the only concern. Of course, we are not. We will follow the guidance of the Guam Board of Accountancy. But, we very much appreciate the idea and in support. I think this will be another example of how to do this and hopefully this will offer an opportunity to people with significant funds to have this opportunity to endow chairs in a lot of different disciplines, as well. I am very happy this a great groundbreaker. Thank you very much.

Chairman Vicente Pangelinan. Thank you very much, Dr. Underwood. Speaker Won Pat, any additional questions?

Speaker Won Pat. One more. Mr. Sanford, I know it's not part of your testimony on the bill, but you have attached it to your testimony. Number 8 (in the MOU) says it is not a separate trust and although it is a restricted and it's going to be co-mingled with the rest of the fund, can you explain why that designation of it not being a separate trust? I

understand that you have this one big endowment fund and then you would have individual accounts or ... please explain to me.

Mr. David Sanford. Well, Mr. Mendiola can address it from an endowment perspective, but essentially that is just the language that specifies the fact that the funds can be co-mingled from an investment perspective so when investing, typically the higher the amount you invest, the lower the fees are going to be to manage those investments and you can get into some investments. Essentially that's only co-mingling from the standpoint of investment; the fact that it is actually a restricted agency advised endowment agreement, which specifies specifically what can be done with the money means that from a restricted standpoint the endowment fund itself can only use the funds for what is specified in the agreement and the co-mingling is strictly from an investment perspective.

Speaker Won Pat. If by chance your investments works and your returns are [inaudible]... I know the account specifically for this purpose still maintain at least for the duration [inaudible].

Mr. David Sanford. We would suffer, as well. Then, of course we would make them suffer, as well.

Mr. Mark Mendiola. A great question, Madam Speaker. Usually what happens when that occurs - basically we don't disburse any of the funds until the fund becomes healthy and whole again. We try to stay and maintain the principal amount and whatever the rate of return in the market may be is what we disburse. Of course the internal mechanism at the university request will come via the department to the President, then the President to the Endowment Foundation Board to disburse these funds. At the time we review the fund we can determine the total amount of money that is available for them to utilize. But the principal amount is what we maintain as part of the corpus so that will continue to grow and then as every year comes along if there are no lecturers that year, then of course that fund continues to grow. This is through the advice and guidance from our financial advisors, our money managers. There will be a tremendous set of eyes looking at this fund to ensure that it stays healthy and our portfolio is in line with a lot of the other academic institutions. We balance it out so that whenever there is a hit, it's not a detrimental hit.

Speaker Won Pat. I am sorry, one more. We are appropriating the monies to go into the Endowment Fund, the \$1M. How are you going to ensure that a check will be written to the Endowment Fund that the \$1M in fact is cash to be remitted to the University of Guam Endowment Foundation?

Mr. David Sanford. I guess we'll have to trust the Chairman of the Board of Accountancy to sign the check and pass it along. But, yes we do have the funds and they are available. As soon as the bill is passed and signed from an appropriation perspective, it's legal. Then, we will write the check and they'll establish it and I am sure we will have a public event so it will be obvious to everybody that is what actually has happened.

I might also add from the Board of Accountancy's perspective, we would also hope that we could add to this on a continuing basis, on an annual basis for whatever access funds we generate, at least to the extent that we might cover the annual expenses and continue to grow the endowment and that will happen as long as we continue to have the CPA candidates come in and sit at the Guam Test Center to take the CPA exam.

Chairman Vicente Pangelinan. If no other comments or questions from the committee, I want to thank you for your presence and your testimony this morning. Si Yu'os Ma'ase.

This concludes the testimony on Bill No. 303-32 (COR). There being no additional individuals to present any additional testimony, this Committee will continue to remain open for the acceptance of any additional information or public testimony on the bill discussed. Buenas yan Hafa Adai! As Interim Dean of the School of Business and Public Administration, I offer testimony in favor of Bill 303-32 (COR) – An Act to appropriate the sum of One Million Dollars (\$1,000,000) from the fund balance of the Guam Board of Accountancy Fund to the University of Guam Endowment Foundation, Inc. for the creation and implementation of the Herminia Dierking and John Phillips Visiting Professor and Lecturer Program. I further request your consideration to modify Section 2, Lines 17-19 of the proposed Bill 303-32 to include the items in bold, “The GBOA, **in consultation with the Accounting Faculty and Dean of the School of Business and Public Administration (SBPA), University of Guam** shall create and adopt rules and regulations for the visiting accounting professor and lecturer program.”

While the number of accounting majors and accounting degrees conferred grew over time, the number of faculty remained steady. On average, each of the 3-4 faculty members is tasked with advising and mentoring about 42 students at a time. The table below shows select data that support the need for this type of program. The proposed program will address the need to augment the core faculty and explore ways to complement and diversify the faculty portfolio of experience.



AGENCY ADVISED ENDOWMENT FUND AGREEMENT

Between
the University Of Guam Endowment Foundation, Inc.
and
the Guam Board Of Accountancy (the "Agency")

THIS AGREEMENT (the "Agreement") is made and entered into as of _____, 2014, by and between The University of Guam Endowment Foundation, Inc. (the "Foundation"), and the Guam Board of Accountancy (the "Agency").

Recitals

WHEREAS, the Agency desires to establish an agency advised endowment fund in the Foundation; and

WHEREAS, the Foundation is a Guam nonprofit corporation exempt from federal income taxes under Internal Revenue Code ("Code") §501(c)(3), a public charity described in Code §170(b)(1)(A)(vi), and accordingly an appropriate institution within which to establish such an agency advised endowment fund; and

WHEREAS, the Foundation is willing and able to hold and administer such an agency advised endowment fund, subject to the terms and conditions hereof;

General Provisions

NOW THEREFORE, the parties agree as follows:

1. GIFT AND FUND DESIGNATION. The Agency hereby transfers irrevocably to the Foundation the property (cash, publicly traded securities, or other assets) described in the attached Exhibit A to establish an agency advised endowment fund to be known as the GUAM ACCOUNTANCY ENDOWMENT FUND (the "Fund"). Subject to the right of the Foundation to reject any particular gift, from time to time the Foundation may accept additional irrevocable gifts of property from the Agency or from any other source to be added to the Fund, all subject to the provisions hereof. All gifts, bequests, and devises to this Fund shall be irrevocable once accepted by the Foundation.

2. PURPOSE. The purpose of the Fund shall be to provide support to the Agency (a single tax-exempt nonprofit quasi-governmental organization described in 22 GCA §35104) and its activities for direct enhancement of the University of Guam School of Business accountancy degree program (the "Program"), as advised by the Agency and directed by the Board of Directors of the Foundation (the "Board"). Such Agency advice shall be determined by and provided to the Board by a standing committee of the Agency, composed of the following members:

Committee Chair:

- Chairperson, Guam Board of Accountancy

Committee Members to be appointed by Committee Chair from among the following:

- additional Agency board members desiring to serve
- Senior Vice President, UOG Academic and Student Affairs
- Dean, UOG School of Business and Public Administration
- Vice President, UOG Administration and Finance
- President and/or Executive Director, Guam Society of CPAs
- President and/or Executive Director, Guam Chapter, Association of Government Accountants

Committee Liaison to Foundation:

- Executive Director, Guam Board of Accountancy

Such support shall be used to further the educational or other exempt purposes of the Agency within the meaning of Code §170(c)(1) or §170(c)(2)(B) and 22 GCA §35104 and shall be consistent with the mission and purposes of the Foundation.

3. DISTRIBUTIONS. The ordinary income, capital appreciation (realized and unrealized), and principal (both historic dollar value and any principal contributions, accumulations, additions, or reinvestments) allocable to the Fund, net of the fees and expenses set forth in this Agreement, may be committed, granted, or expended pursuant to the distribution (or spending) policy of the Foundation, as such policy may be amended from time to time by the Foundation, solely for purposes specified in this Agreement. The Foundation's distribution (or spending) policy, as applied to endowments such as the Fund, shall be designed to take into account total return concepts of investment and spending, with the goal of preserving the real spending power of endowments over time while balancing the need for consistent spending to support the educational and similar exempt purposes of such endowments.

If any gift to the Foundation for the Fund is accepted subject to conditions or restrictions as to the use of the gift or income therefrom, such conditions and restrictions will be honored, subject, however, to the authority of the Board to vary the terms of any gift if continued adherence to any condition or restriction is in the judgment of the Board unnecessary, incapable of fulfillment, or inconsistent with the educational purposes of the Foundation. No distribution shall be made from the Fund that may in the judgment of the Foundation jeopardize or be inconsistent with the Foundation's Code §501(c)(3) status or result in the imposition of any excise tax, penalty, or other tax, fine, or assessment under the Code. In the event the Foundation loses its status under Code §501(c)(3), this Agreement shall terminate.

4. RECOMMENDATIONS FOR DISTRIBUTIONS. Subject to the

AGENCY ADVISED ENDOWMENT FUND AGREEMENT

Foundation's principles and procedures for advised funds, the commitments, grants, or expenditures from the Fund contemplated in this Agreement shall be made to the Agency at such time or times and in such amount or amounts as may be determined by the Foundation; provided, however, that the Agency may from time to time submit to the Foundation recommendations regarding specific purposes or amounts for distributions to the Agency. All recommendations from the Agency shall be advisory, and the Foundation may accept or reject them, applying reasonable standards and guidelines with regard thereto.

5. ADMINISTRATIVE PROVISIONS. Notwithstanding anything herein to the contrary, the Foundation shall hold and administer the Fund, and all contributions and assets allocable to the Fund, subject to the provisions of applicable law and the Foundation's Articles of Incorporation and Bylaws, as amended from time to time. The Board shall oversee distributions from the Fund and shall have all powers of modification and removal specified in United States Treasury Regulation §1.170A-9(e)(1)(v)(B).

The Board agrees to provide the Agency a copy of any annual examination of the finances of the Foundation as reported by independent certified public accountants.

This Agreement constitutes the entire agreement of the parties and any future modification hereof must be in writing. This Agreement and all related proceedings shall be governed by and interpreted under the laws of the Territory of Guam. Any action with respect to this Agreement shall be brought in the Superior Court of Guam.

6. CONDITIONS FOR ACCEPTANCE OF GIFTS. The Agency agrees and acknowledges that the establishment of the Fund is made in recognition of, and subject at all times to, applicable law and the terms and conditions of the Articles of Incorporation and Bylaws of the Foundation, as amended from time to time, including, but not by way of limitation, provisions for:

- a. Presumption of Donors' intent;
- b. Variance from Donors' direction; and
- c. Amendments.

7. CONTINUITY OF THE FUND. The Fund shall continue so long as assets are available in the Fund and the purposes of the Fund can be served by its continuation. If the Fund is terminated, the Foundation shall use any remaining assets in the Fund exclusively for educational purposes that:

- a. are within the scope of the educational and other exempt purposes of the Foundation; and
- b. most nearly approximate, in the good faith opinion of the Board, the original

purpose of the Fund.

8. NOT A SEPARATE TRUST. The Fund shall be a component part of the Foundation. All money and property in the Fund shall be held as general assets of the Foundation and not segregated as trust property of a separate trust.

9. ACCOUNTING. The receipts and disbursements of the Fund shall be accounted for separately and apart from those of other gifts to the Foundation.

10. INVESTMENT OF FUND ASSETS. The Foundation shall have all powers necessary, or in its judgment desirable, to carry out the purposes of the Fund including, but not limited to, the power to retain, invest, and reinvest the assets of the Fund and the power to commingle the assets of the Fund for investment purposes with those of other funds or the Foundation's general assets.

11. COSTS OF THE FUND. It is understood and agreed that the Fund shall share a pro rata portion of the total investment and administrative costs and expenses of the Foundation. Those costs and expenses charged against the Fund shall be a maximum of two percent (2.0%) of the Fund's three year average balance determined annually as of the end of the Foundation's fiscal year. Any costs and expenses incurred by the Foundation in accepting, transferring, or managing property donated to the Foundation for the Fund, including without limitation the Foundation's costs and expenses (including reasonable attorneys fees) of any claim or proceeding with respect to the Fund in which the Foundation is prevailing party, also shall be paid from the Fund.





1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the Guam Board of Accountancy (GBOA) wishes to enter into an agreement
4 with the University of Guam Endowment Foundation, Inc. (Foundation) to
5 establish an “Agency Advised Endowment Fund Agreement” establishing a Guam
6 Accountancy Endowment Fund (Fund) for the purpose of enhancing the University
7 of Guam (UOG) School of Business Accountancy Degree Program (Program).

8 *I Liheslatura* further finds that the Fund will be administered under the
9 direction of a standing committee of the GBOA to be composed of several
10 members from the GBOA, UOG, and other accounting professionals in our
11 community.

12 *I Liheslatura* further finds that the purpose of the Fund will be used to
13 support activities that will directly enhance the quality of the Program and that the
14 GBOA continue to provide leadership, mentoring, and guidance with an outside

1 perspective in the learning experience for UOG students who are pursuing their
2 degrees in the field of accounting.

3 It is, therefore, the intent of *I Liheslatura* to appropriate a specific sum from
4 the Guam Board of Accountancy Fund to fund the program which the Foundation
5 *shall* hold and administer as agreed upon by the GBOA and the Foundation for the
6 creation of a visiting professor and lecturer program at the UOG specifically for
7 the direct enhancement of the Program.

8 **Section 2. Appropriation to the Foundation.** The sum of One Million
9 Dollars (**\$1,000,000**) is appropriated from the fund balance of the GBOA Fund to
10 the Foundation for the purpose of establishing an endowment fund to be known as
11 the Guam Accountancy Endowment Fund.

12 Such Fund *shall* be administered and governed as agreed upon between the
13 Foundation and the GBOA, pursuant to the Agency Advised Endowment Fund
14 Agreement whereby the Fund *shall* fund a visiting accounting professor and
15 lecturer program specific to directly enhancing the UOG School of Business
16 Accountancy Program.

17 The GBOA or a duly created standing committee of the GBOA *shall* create
18 and adopt rules and regulations for the visiting accounting professor and lecturer
19 program. The visiting accounting professor and lecturer program *shall* be called
20 the Herminia Dierking and John Phillips Visiting Professor and Lecturer Program.

21 **Section 3. Severability.** *If* any provision of this Act or its application to any
22 person or circumstance is found to be invalid or contrary to law, such invalidity
23 *shall* not affect other provisions or applications of this Act which can be given
24 effect without the invalid provisions or application, and to this end the provision of
25 this Act are severable.
