**AN ACT TO AMEND § 106119(k) OF PART A OF
ARTICLE 1, CHAPTER 106 OF TITLE 11, GUAM CODE
ANNOTATED, RELATIVE TO DEPOSITING
ESCHEATED FUNDS IN THE HOUSING TRUST FUND
FOR THE FIRST-TIME HOMEOWNER ASSISTANCE
PROGRAM; AND TO AUTHORIZE THE TRANSFER OF
FUNDS ELIGIBLE FOR ESCHEATMENT UNDER §
21116 OF TITLE 5, GUAM CODE ANNOTATED.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 106119(k) of Part A of Article 1, Chapter 106 of Title 11, Guam
3 Code Annotated, is hereby *amended* to read:

1 “(k) All funds transferred to the Treasurer of Guam pursuant to the
2 provisions of this Section *shall* escheat to the government of Guam one (1)
3 year subsequent to the date such transfers occurred. The Treasurer of Guam
4 *shall* deposit such funds in the Housing Trust Fund established in Article 10
5 of Chapter 4, Title 12, Guam Code Annotated. Such funds *shall* be used in
6 accordance with the provisions of the First-time Homeowner Assistance
7 Program.”

8 **Section 2. Transfer Authority of Funds Eligible for Escheatment under**
9 **§ 21116 of Title 5, Guam Code Annotated.** Notwithstanding any other provision
10 of law, the sum of Seven Hundred Sixty-Four Thousand Nine Hundred Seventy-Five
11 Dollars and Fourteen Cents (\$764,975.14), escheated to the General Fund prior to
12 the end of Fiscal Year 2015, and available for appropriations in Fiscal Year 2015,
13 pursuant to § 21116 of Chapter 21, Division 2, Title 5, Guam Code Annotated, *shall*
14 be deposited in the Housing Trust Fund established in Article 10 of Chapter 4, Title
15 12, Guam Code Annotated. Such funds *shall* be used in accordance with the
16 provisions of the First-Time Homeowner Assistance Program.
