

**AN ACT TO APPROPRIATE FUNDS FROM THE
FISCAL YEAR 2014 FUND BALANCE OF THE
TOURIST ATTRACTION FUND TO THE GUAM
DEPARTMENT OF CORRECTIONS FOR OVERTIME
COMPENSATION.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the sum of Four Million Dollars (**\$4,000,000**) from the unappropriated,
4 unallocated fund balance of the Fiscal Year 2014 Tourist Attraction Fund (TAF) is
5 available for appropriation.

1 **Section 2. Appropriation.** Notwithstanding § 30107, of Chapter 30, Title
2 11 GCA, the sum of Seven Hundred Ninety-Eight Thousand, Nine Hundred Eighty
3 Nine Dollars (\$798,989) is hereby appropriated from the unappropriated,
4 unallocated fund balance of the Fiscal Year 2014 Tourist Attraction Fund to the
5 Department of Corrections for overtime compensation accrued for Fiscal Year
6 2015. Notwithstanding the general provisions of § 30107.1, of Chapter 30, Title
7 11 GCA, this appropriation is *not* subject to transfer or use for any other purpose.
