

# AN ACT TO AMEND §§ 70115, 70116 AND 70117 OF CHAPTER 70, TITLE 11, GUAM CODE ANNOTATED, RELATIVE TO THE ISSUANCE OF BUSINESS LICENSES.

## **1 BE IT ENACTED BY THE PEOPLE OF GUAM:**

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds
that the current system for issuing and renewing business licenses on Guam creates
a major inconvenience to business owners and employees of the Department of
Revenue and Taxation.

1 It is, therefore, the intent of *I Liheslaturan Guåhan* to amend current laws to 2 allow the Department of Revenue and Taxation to renew these licenses on an annual basis. 3 Section 2. § 70115 of Chapter 70, Title 11, Guam Code Annotated, is 4 5 hereby *amended* to read as follows: **"§ 70115.** 6 Term of License. All licenses and endorsements applicable thereto shall be 7 (a) 8 issued on an annual basis and, regardless of when issued, shall expire 9 one (1) year after the date for which issued or renewed. All licenses and endorsements applicable thereto which 10 (b)11 are already in existence prior to the enactment of this law shall be 12 renewed on the month consistent with the month they originally 13 attained their license. The Department of Revenue and Taxation shall have up to eighteen (18) months from the enactment of this law to 14 15 amend the renewal dates of these licenses and endorsements to 16 conform with the renewal date outlined in this Section. Notwithstanding the terms of this Section, a licensee 17 (c)holding multiple licenses may elect to have the multiple licenses 18 19 expire concurrently one (1) year after the month chosen at the licensee's discretion." 20 Section 3. § 70116 of Chapter 70, Title 11, Guam Code Annotated, is 21 22 hereby *amended* to read as follows: **"§ 70116.** 23 Fees. 24 (a) All original license fees *shall* be charged on an annual basis, commencing on the date of issuance or renewal and ending on the day 25 26 before the month and day of issuance in the following year. The existing fee 27structure for business licenses *shall* remain intact and in effect.

(b)All licenses and endorsements renewed as per § 70115(b) of this Chapter shall have their fees prorated appropriately to conform with the revised renewal date."

Section 4. § 70117 of Chapter 70, Title 11, Guam Code Annotated, is 4 5 hereby *amended* to read as follows:

A licensee may renew his license at the "§ 70117. Renewal. expiration thereof by the payment of the annual license fee and by filing 7 with the renewal application an affidavit oath and subject to the penalties of 8 9 perjury that he has continued to comply with all of the prerequisites and 10 qualifications provided by law, rules and regulations which were certified by the proper departments of the government of Guam in the application for his 11 original license. The renewing licensee shall not be required to obtain the 12 13 approval of the government of Guam or any department or agency thereof 14 regarding the application of the zoning law of Guam to the licensee's business premises; provided, that the licensed business is located upon the 15 16 identical premises upon which it was located on the date of the issuance of 17 the previous license.

18 A licensee who fails to renew his license on or before one (1) year or 19 twelve (12) months after it was issued shall be assessed a penalty of One 20 Dollar (\$1.00) per each calendar day he is delinquent, which penalty shall 21 become part of the renewal fee. Any licensee who fails to renew his license on or before the thirty (30) days after the license should have been renewed 22 shall be required to discontinue his business until he renews the license or be 23 24 subject to an injunction issued by the Superior Court and to prosecution 25 under § 70119. Such failure to renew while continuing the operation of the 26 business shall constitute refusal and failure to obtain a license under the 27provisions of this Division."

Section 5. Effective Date. The Department of Revenue and Taxation
 shall work with the Office of Technology in implementing the objectives of this
 Act. These changes to the term of business licenses *shall* be effective on the second
 day of October 2016.

5 Section 6. Severability. If any provision of this Act or its application to 6 any person or circumstance is found to be invalid or contrary to law, such 7 invalidity *shall not* affect other provisions or applications of this Act that can be 8 given effect without the invalid provisions or application, and to this end the 9 provisions of this Act are severable.
