
**CERTIFICATION OF PASSAGE OF AN ACT TO *I MAGA'LAHEN GUÅHAN***



**AN ACT TO APPROPRIATE FUNDS FROM THE  
FISCAL YEAR 2014 FUND BALANCE OF THE  
TOURIST ATTRACTION FUND TO THE GUAM  
VISITORS BUREAU FOR DEPOSIT INTO THE GUAM  
FESTPAC & FOLKLIFE FESTIVAL TRUST ACCOUNT.**

1        **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2        **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds  
3 that the sum of Four Million Dollars (**\$4,000,000**) from the unappropriated,  
4 unallocated fund balance of the Fiscal Year 2014 Tourist Attraction Fund (TAF) is  
5 available for appropriation.

1           **Section 2. Appropriation.** Notwithstanding § 30107 of Chapter 30, Title  
2 11 GCA, the sum of Two Million Dollars (**\$2,000,000**) is hereby appropriated from  
3 the unappropriated, unallocated fund balance of the Fiscal Year 2014 Tourist  
4 Attraction Fund to the Guam Visitors Bureau for deposit into the Guam FESTPAC  
5 & Folklife Festival Trust Account. Notwithstanding the general provisions of §  
6 30107.1 of Chapter 30, Title 11 GCA, this appropriation *shall* continue to be  
7 available until expended and is *not* subject to transfer or use for any other purpose.
