1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Finding and Intent.** *I Liheslaturan Guåhan* finds
3 that the Department of Public Works requires additional time to complete the
4 ongoing *request for proposal*, contract negotiations, and project award process for
5 the capital improvement projects for flood mitigation, as authorized and funded
6 pursuant to P.L. 32-53. It is the intent of *I Liheslaturan Guåhan* to extend the
7 expenditure timeline until funding is expended.

8 **Section 2.** Section 3 of Public Law No. 32-053 is hereby *AMENDED*, to
9 read:

10 **“Section 3. Unused Appropriation.** Funds may be ~~not~~ expended pursuant
11 to the provisions of this Act ~~within one year~~ following the date of enactment, and
12 *shall continue to no longer* be available for its stated purpose until expended. Any
13 excess funds *shall* be used by the Director of DPW to fulfill additional work listed
14 in Section 2 of this Act.”

15 **Section 3. Effective Date.** This Act shall become immediately effective
16 upon enactment.
