AN ACT TO AMEND § 26202 OF ARTICLE 2, CHAPTER 26, DIVISION 2, TITLE 11, GUAM CODE ANNOTATED, AND TO REPEAL § 16311 OF ARTICLE 3, CHAPTER 16, TITLE 3, GUAM CODE ANNOTATED, RELATIVE TO REVISING THE BUSINESS PRIVILEGE TAX FROM FOUR TO SIX PERCENT (6%), AND TO DEDICATE THE REVENUE TO BE COLLECTED FROM THE EXPANDED REVENUE STREAM TO THE GUAM MEMORIAL HOSPITAL AUTHORITY (GMHA) FOR ITS OPERATIONS AND MODERNIZATION; THE DEPARTMENT OF EDUCATION TO FUND ITS CAPITAL NEEDS; AND THE GENERAL FUND OF THE GOVERNMENT OF GUAM TO ADDRESS THE TAX BASE EROSION RESULTING FROM THE PASSAGE OF THE TAX CUTS AND JOBS ACT OF 2017, REMOVING THE REFERENDUM ON TAX INCREASES, AND CREATING A GMHA STABILIZATION FUND; AND REQUIRING WEEKLY SPECIAL ECONOMIC SERVICE MEETINGS.
