BE IT RESOLVED BY I MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN: WHEREAS, FORMER MAYOR VICENTE DIAZ GUMATAOTAO, FONDLY KNOWN AS "UNCLE BEN," WAS BORN ON NOVEMBER 30, 1927, IN THE HISTORIC PRE-WAR VILLAGE OF SUMAY. HE IS THE SON OF THE LATE †JOSEFINA DIAZ AND †LEON DIAZ GUMATAOTAO, AND IS THE THIRD ELDEST CHILD OF TWELVE (12) CHILDREN AND THE FIRST-BORN SON; AND AT THE ADVENT OF WORLD WAR II, FORMER MAYOR VICENTE DIAZ GUMATAOTAO'S FAMILY WAS MADE TO MARCH TO THE MANENGGON HILLS CONCENTRATION CAMP DURING THE IMPERIAL JAPANESE ARMY'S INVASION OF GUAM: AND, AS A TEENAGER, HE WAS EXPOSED TO THE ATROCITIES OF THE BRUTAL AND GRUESOME WAR AT THE HANDS OF THE JAPANESE SOLDIERS. FURTHERMORE, MAYOR VICENTE DIAZ GUMATAOTAO'S FAMILY WAS LATER RELOCATED TO THE HILLS OF SANTA RITA WHERE HIS FAMILY REBUILT THEIR LIVES: AND MAYOR VICENTE DIAZ GUMATAOTAO LATER MARRIED THE FORMER ANTONIA BENAVENTE RABON OF SINAJANA, AND THEY RAISED THREE (3) DAUGHTERS; ELIZABETH "BETSY" G. HUSSEY, LISA G. PERKINS, AND YVETTE MARIE R. LEON GUERRERO CRUZ; AND SEVEN (7) SONS, ANTHONY FREDDIE SABLAN, GARY FRANK GUMATAOTAO, GLEN GUMATAOTAO, ROBERT G.R. LEON GUERRERO, KEVIN A.R. LEON GUERRERO, MANUEL F. LEON GUERRERO III, AND VICENTE D. GUMATAOTAO II. UNCLE BEN HAS ALSO BEEN BLESSED WITH TWENTY-THREE (23) GRANDCHILDREN; ANTHONY SCOTT, KEVIN MICHAEL, ANDREA NICOLE, DOMINIQUE, JANELLE, ANGELICA, JOSHUA AARON, HANNA, AYA, AMY LISA, VICENTE JEREMIAH, STACY NICOLE, ASHLEY BLAIR, MATTHEW JOHN, TYLER, GABRIEL JESUS, ELIJAH JAMES, PATRICIA ROSE, MANUEL IV, LUCIAN JACOB, ANTONÍA MARIA, VICENTE III, MIEKO ROSAE; AND TWENTY-TWO (22) GREAT-GRANDCHILDREN, ALICIA HALLIE, JADE KIANA, ADDIE, ANTHONY, KIANA SUSAN, KAIDEN ROONEY, KAITLIN, HAILEY, VALERIE, MELANIE, CARSON, COLTON, CADENCE, YOHANN, ADELYNN, CARSON, WILLIAM, NOAH, VIVIAN, ISAIAH, NEVAEH, AND TJ; AND MAYOR VICENTE DIAZ GUMATAOTAO SERVED A GRATEFUL NATION FOR OVER TWENTY-EIGHT (28) YEARS AS A DECORATED SAILOR IN THE UNITED STATES NAVY. DURING HIS TOUR IN THE NAVY, HE COMPLETED MESS MANAGEMENT SCHOOL AND WAS AN INSTRUCTOR FOR STEWARDS WITHIN HIS DIVISION, AS WELL AS STEWARDS THAT WERE TO BE ASSIGNED TO THE WHITE HOUSE; AND, HE SUBSEQUENTLY RETIRED AT THE RANK OF MASTER CHIEF PETTY OFFICER (E-9), THE HIGHEST ENLISTED RANK IN THE UNITED STATES NAVY; AND UPON HIS RETIREMENT, MAYOR VICENTE DIAZ GUMATAOTAO WORKED WITH FORMER SPEAKER THOMAS C. TANAKA AS A LEGISLATIVE CONSULTANT FOR THE GUAM LEGISLATURE FROM JANUARY 1979 TO DECEMBER 1983. HE THEN WORKED WITH FORMER SENATOR EDWARD DUEÑAS FROM 1984 TO 1988, AND EVENTUALLY TOOK A POSITION IN THE OFFICE OF FORMER CONGRESSMAN VICENTE C. BLAZ IN THE 101ST AND 102ND U.S. CONGRESS, FROM JANUARY 1989 TO DECEMBER 1993, SERVING AS A TRUSTED ADVISOR; AND AFTER TEN (10) YEARS OF RETIREMENT, UNCLE BEN GUMATAOTAO WAS CALLED UPON BY THE COMMUNITY OF PITI TO RUN FOR MAYOR; AND, HE WAS ELECTED AND SERVED AS THE VILLAGE MAYOR FOR TWELVE (12) YEARS, FROM JANUARY 2004 TO DECEMBER 2015; AND DURING HIS TIME SERVING AS MAYOR OF PITI, MAYOR VICENTE DIAZ GUMATAOTAO IMPROVED HIS VILLAGE THROUGH THE RESTORATION OF THE PITI BASKETBALL COURT, THE RENOVATION THE PEDRO SANTOS PARK, THE CLEAN-UP OF MARINE CORPS DRIVE, AND THE DEVELOPMENT OF THE MASSO RESERVOIR FOR THE VILLAGE OF PITI; AND MAYOR BEN WAS AN ACTIVE MEMBER OF NUMEROUS CIVIC AND RELIGIOUS ORGANIZATIONS, TO INCLUDE: THE U.S. NAVY LEAGUE (LIFETIME MEMBER); THE YOUNG MEN'S LEAGUE OF GUAM; THE FLEET RESERVE ASSOCIATION, BRANCH #73; THE NATIONAL ASSOCIATION OF UNIFORM SERVICES (LIFETIME MEMBER); THE GUAM DIABETES ASSOCIATION; THE LEGION OF MARY (AUXILIARY MEMBER) OF PITI CHURCH; THE FINANCE COUNCIL OF PITI CHURCH; FORMER MEMBER, PITI MUNICIPAL PLANNING COUNCIL; FORMER MEMBER, GUAM PUBLIC UTILITIES COMMISSION; AND FORMER MEMBER, GUAM LAND USE COMMISSION; AND MAYOR BEN LIVED TO THE AGE OF NINETY-ONE (91) YEARS AND PASSED AWAY ON DECEMBER 28, 2018, EXPERIENCING A FULL, VIBRANT AND ACCOMPLISHED LIFE; AND HIS FAMILY, FRIENDS, THE COMMUNITY HE SERVED, AND THE PEOPLE OF GUAM WILL SURELY MISS HIM; NOW THEREFORE, BE IT RESOLVED, THAT THE COMMITTEE ON RULES OF I MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN DOES HEREBY, ON BEHALF OF I LIHESLATURAN GUÅHAN AND THE PEOPLE OF GUAM, POSTHUMOUSLY RECOGNIZE AND COMMEMORATE THE LATE HONORABLE VICENTE DIAZ GUMATAOTAO, FORMER MAYOR OF PITI, FOR HIS LIFETIME OF PUBLIC SERVICE TO OUR PEOPLE AND NATION;

ANTONIA B.R. GUMATAOTAO; AND TO ELIZABETH "BETSY" G. HUSSEY; LISA G. PERKINS; YVETTE MARIE R. LEON GUERRERO CRUZ; ANTHONY FREDDIE SABLAN; GARY FRANK GUMATAOTAO; GLEN GUMATAOTAO; ROBERT G.R. I CALL UPON I MAGA'HÅGA GOVERNOR OF GUAM LOURDES A. LEON GUERRERO TO PRESENT THE GOVERNOR'S PROCLAMATION. AT THIS TIME I INVITE I MAGA'HÅGA GOVERNOR LOU LEON GUERRERO THE CHIEF JUSTICE MARAMAN TO JOIN ME IN PRESENTING THE OFFICIAL WREATH OF GUAM. I CALL UPON MAYOR MELISSA SAVARES MAYOR OF DEDEDO AND PRESIDENT OF THE MAYOR'S COUNCIL OF GUAM AND MAYOR JESSE ALIG MAYOR OF PITI TO PRESENT THE MAYORAL CERTIFICATE AND THE MAYORAL WREATH. AT THIS TIME I CALL UPON THE HONORABLE PHILLIP F. CARBALIBITY CARABULLIDO ASSOCIATE JUSTICE SUPREME COURT OF GUAM TO DELIVER THE EULOGY.

PHLLIP F. CARBULLIDO (ASSOCIATE JUSTICE SUPREME COURT OF GUAM): GOOD MORNING GOVERNOR LOU LEON GUERRERO LIEUTENANT GOVERNOR JOSH TENORIO SPEAKER TINA MUÑA BARNES CHIEF JUSTICE KATHERINE MARAMAN DISTINGUISHED LEADERS AND GUESTS AND MOST ESPECIALLY THE GUMATAOTAO FAMILY TONY OUR HEARTS ARE WITH YOU YOUR CHILDREN ROBERT KEVIN MANNY YVETTE AND VINCENT AND BEN'S OTHER CHILDREN FRED SABLAN ATTORNEY GARY GUMATAOTAO BETSY HUSSY GLENN GUMATAOTAO LISA PERKINS AND YOUR FAMILIES I GIVE THIS EULOGY FROM THE PERSPECTIVE OF BEING A NEIGHBOR OF BEN AND TONY IN THE VILLAGE OF PITI FOR NEARLY 30 YEARS VICENTE DIAZ GUMATAOTAO WAS A MAN OF CONVICTION WHO THROUGHOUT THE LIFE OF 91 YEARS DEDICATED HIMSELF TO GOD HIS FAMILY HIS ISLAND AND HIS COUNTRY MAYOR BEN WAS A MEMBER OF OUR ISLANDS GREATEST GENERATION WHO ENDURED HORRIFIC ATROCITIES DURING WORLD WAR II OCCUPATION ON GUAM HE RECOUNTED THAT HE WAS BEATEN BY THE ENEMY AND SHOT DURING THE BATTLE OF GUAM'S LIBERATION IN 1944 WHILE THE WAR WOULD CAUSE SIGNIFICANT PAIN AND SUFFERING FOR MAYOR BEN AND THOUSANDS OF CHAMORRO MEN AND WOMEN IT ALSO SPURRED IN HIM A SENSE OF DUTY AND PATRIOTISM TO SERVE HIS ISLAND AND HIS NATION HIS EXPERIENCES DURING THE WAR WOULD HELP GUIDE HOW HE CARED FOR HIS FAMILY HIS FRIENDS AND HIS CONSTITUENTS IN PITI HIS DAUGHTER YVETTE RECENTLY TOLD ME THAT WHENEVER SHE WOULD WALK INTO THE HOUSE AFTER WORK THE FIRST THING OUT OF MAYOR BEN'S MOUTH WAS WHAT DO YOU ALL WANT TO EAT FOR DINNER THE CHILDREN SHOULD NOT EAT TOO LATE THEY NEED TO BE HEALTHY TO GROW UP DON'T LET THEM STARVE LIKE WHAT I WENT THROUGH DURING THE WAR AND THAT WAS BEN'S NATURE HE WAS ALWAYS THINKING OF OTHERS AND DOING WHATEVER HE COULD TO HELP THOSE IN NEED I RECALL THAT DURING TYPHOON CHATAN AND IN 2002 THE RAINS WERE SO HEAVY THAT THEY OVERWHELMED THE DRAINS IN NIMITZ HILL AND WATER WAS POOLING IN FRONT OF MY HOUSE THREATENING TO FLOOD IN MY RESIDENCE AND FORCED MY FAMILY TO EVACUATE TO SAFER GROUND AND THE MIDDLE OF THE TYPHOON UNBEKNOWNST TO MY FAMILY OR ME MAYOR BEN WENT OUT TO CLEAR THE DRAINS IN FRONT OF MY HOUSE WHILE HE WAS OUT THERE THE WINDS PICKED UP AND WATER WAS FLOWING EVEN FASTER FORMING A RIVER BESIDE MY HOUSE THAT RAGED OVER THE CLIFF LINE BEN'S YOUNGEST SON VINCENT WOULD LATER TELL ME THAT HE WANTED TO TIE A ROPE AROUND HIMSELF AND ANCHOR IT TO A TREE SO THAT HE COULD LOOK FOR HIS DAD WITHOUT BEING SWEPT DOWN THE RAGING WATER AND OVER THE CLIFF LINE THANKFULLY MAYOR BEN BEING THE RESOURCEFUL PERSON THAT HE IS WOULD FIND SHELTER IN A SMALL CONCRETE NOOK IN FRONT OF MY HOUSE AFTER WHAT SEEMED LIKE AN ETERNITY TO VINCE AND TONY WHEN THE WINDS LED UP BEN FINISHED CLEARING THE DRAINS WENT BACK INTO HIS HOME UPON ENSURING THAT MY HOME AND OTHERS IN THE NEIGHBORHOOD WOULD NOT BE FLOODED MAYOR BEN WAS BRAVE A TRAIT HE LEARNED DURING THE OCCUPATION AND HOME DURING HIS SERVICE IN THE UNITED STATES NAVY BEN WAS PROUD OF HIS MILITARY SERVICE IN HIS 28 YEAR CAREER HE

WOULD ATTAIN THE RANK OF YOU HAVE YOU'VE JUST HEARD OF MASTER CHIEF PETTY OFFICER THE NAVY'S THE NAVY'S HIGHEST ENLISTED RANK WHILE MAYOR BEN'S TIME IN THE NAVY WOULD PULL HIM FAR FROM HOME AND HIS ISLAND HE NEVER FORGOT HIS ROOTS OR DRIFTED FAR FROM OUR SHORES IT WAS DURING HIS TIME IN THE NAVY THAT BEN LEARNED TO COOK AND BOY WAS HE A SKILLED CHEF IN THE KITCHEN HE MADE THE BEST T-BONE STEAK AND WAS ALWAYS FINDING REASONS TO BRING PEOPLE TOGETHER AROUND A DINNER TABLE AFTER MY HEART BYPASS SURGERY IN 2000 MY FAMILY'S DIET WAS DRASTICALLY CHANGED AND WE SELDOM ATE RED MEAT OR ADDED SALT TO OUR FOOD MY CHILDREN WOULD OFTEN EAT DINNER AT OUR HOME THEN WALK ACROSS THE STREET TO BEN AND TONY'S HOUSE TO QUOTE STUDY CLOSE QUOTE WITH THEIR CHILDREN OF TEN KNOWING THAT UNCLE BEN WOULD HAVE COOKED UP MORE FLAVORFUL CHAMORU BISTEAK AND SHRIMP WITH LOTS OF BUTTER FAYE WOULD OFTEN WONDER WHY MY CHILDREN WOULD HAVE SUCH SMALL APPETITES AT OUR DINNER TABLE BUT SWEETHEART IT HAD NOTHING TO DO WITH YOUR COOKING FOLLOWING SUPER TYPHOON PONGSONA GUAM WAS DEVASTATED AND WITHOUT POWER OR RUNNING WATER FOR SEVERAL WEEKS MANY FAMILIES IN OUR NEIGHBORHOOD WERE UNABLE TO COOK AND FOOD WAS THREATENING TO SPOIL YET IN THAT DIFFICULT TIME BEN BROUGHT OUR NEIGHBORHOOD TOGETHER EMPTYING OUR FREEZERS AND COOKING AMAZING MEALS FROM THE FOOD THAT WERE BOUGHT BROUGHT FROM THE NEIGHBORS THOSE WERE SOME OF THE BEST TIMES IN OUR NEIGHBORHOOD AND IT HELPED TO MAKE THE DIFFICULTIES THAT WE AS AN ISLAND WERE EXPERIENCING MORE BEARABLE THAT WAS THE LEADER AND NEIGHBOR BEN WAS HE FOUND THE GOOD IN EVERYTHING MADE THE MOST OF EACH SITUATION BROUGHT PEOPLE TOGETHER AND ENSURED ALL WERE TAKEN CARE OF IN 2004 BEN RAN TO BE THE MAYOR OF PITI TONY RECENTLY RECALLED WHEN BEN FIRST TOLD HER HE WANTED TO RUN FOR MAYOR IT WAS IN THE MIDDLE OF THE NIGHT AND HE WOKE HER UP TO SAY THAT HE WAS GOING TO RUN FOR MAYOR AND HE WAS GOING TO WIN BEN WAS CONFIDENT I AM SORRY MALI (COMADRE) TONY THAT MAYOR BEN COULD NOT WAIT TO THE FOLLOWING MORNING TO LET YOU KNOW BEN WON THAT ELECTION AND HE WENT ON TO BE A TIRELESS AND PASSIONATE MAYOR FOR THE NEXT 12 YEARS MAYOR BEN TOOK GREAT STRIDES TO ENSURE THAT OUR COMMUNITY ESPECIALLY OUR CHILDREN WAS SAFE IN THE VILLAGE HE WAS A STRICT ENFORCER OF GUAM'S LAWS PARTICULARLY TARGETING SPEEDING CARS FLYING DOWN MARINE CORPS DRIVE AND THREATENING THE SAFETY OF OUR COMMUNITY MAYOR BEN BELIEVED THAT IT WAS PARTLY HIS RESPONSIBILITY TO ENSURE THE ROADS IN THE VILLAGE WERE SAFE SO HE JUMPED IN THE PITI'S MAYOR OFFICE TRUCK TURN ON THE FLASHING LIGHTS AND ENFORCED THE SPEED LIMIT FOR EVERY DRIVER WHO MADE THE MISTAKE OF SPEEDING THROUGH THE VILLAGE OF PITI WHEN HE SAW ME IN CHURCH ONE SUNDAY MORNING AFTER SOME PUBLICITY REGARDING HIS PEACE OFFICER ROLE HE TOLD ME THAT HE WAS NOT WORRIED BECAUSE HE HAD CONSULTED MY SON BRANDON WHO WAS FRESH OUT OF LAW SCHOOL I WAS AFRAID TO ASK MY SON BRANDON WHAT HE ADVICE HE GAVE HIS UNCLE BEN BUT I WAS EVEN MORE AFRAID TO ASK IF UNCLE BEN EVEN CALLED MAYOR BEN WAS A TOUGH FIGHTER SOMETHING I'M SURE MAYOR NITO BLAS KNOWS ALL ABOUT BUT PLEASE DON'T LET HIM SAY I KNOW THAT I SAID THAT MAYOR BEN WORKED DILIGENTLY TO IMPROVE THE LIVES OF HIS CONSTITUENTS AND FOR WHAT HE BELIEVED WAS BEST FOR THE PEOPLE OF GUAM HE WORKED TO IMPROVE THE PITI'S PARKS ADDRESSED THE STRAY DOGS PROBLEMS IN THE VILLAGE UNDERTAKE NEIGHBORHOOD BEAUTIFICATION AND CLEANUP PROJECTS HELP CARE FOR THE VETERANS CEMETERY EXPAND SERVICES TO THE MANAMKO (SENIOR CITIZENS) AND MANY MORE VILLAGE PROJECTS HE TOOK JESSE ALIG UNDER HIS WING AND NOW MAYOR JESSE IS BUILDING ON THE GOOD THINGS HE LEARNED FROM HIS PREDECESSOR AND BECAUSE OF HIS ADVOCACY WITH LOCAL AND FEDERAL LEADERS I AM INFORMED THE FORMER USO FACILITY AND BEACH IN PITI MAY BE RETURNED TO THE VILLAGE AS PART OF THE LANDS TO BE RETURNED BY THE UNITED STATES NAVY MAYOR BEN HAD A DEEP FAITH IN GOD FAITH HE AND TONY INSTILLED IN THEIR CHILDREN AND GRANDCHILDREN THAT THEY LIVED OUT EVERY DAY ESPECIALLY IN THE COMMANDMENT TO LOVE THY NEIGHBOR TODAY TOGETHER THEY WERE ARDENT SUPPORTERS OF PITI CHURCH AS LONGTIME LEADERS OF THE PARISH COUNCIL AS LECTORS AND AS EUCHARISTIC MINISTERS BEN AND TONY WERE GENEROUS DONORS TO THE TO THE PITI PARISH AND YOU COULD ALWAYS COUNT ON THEM TO HELP SET UP AND CLEAN UP AFTER CHURCH FUNDRAISERS AND FIESTAS (PARTIES) BEN'S FAITH IN GOD WAS HIS STRENGTH AND HE LIVED HIS FAITH IN ALL THAT HE DID BUT MOST IMPORTANTLY BEN WAS A DEVOTED HUSBAND AND A LOVING FATHER AND GRANDFATHER HE MET TONY LATER IN LIFE AND THEY CARED FOR EACH OTHER'S CHILDREN AND THEIR OWN WITH UNCONDITIONAL LOVE AND SUPPORT TO ROBERT KEVIN MANNY SONNY BOY TO MOST OF US YVETTE AND VINCE YOUR DAD WAS EXTRAORDINARILY PROUD OF EACH OF YOU HE LOVED NURTURING YOU AS YOU GREW UP AND HE WAS IMMENSELY PROUD TO WHAT YOU BUILT YOUR OWN FAMILIES I KNOW HE WILL CONTINUE TO WATCH DOWN ON YOU AND YOUR FAMILIES ALWAYS GUIDING YOU AS HE DID IN LIFE AND FIND JOY THAT YOU WILL TEACH YOUR CHILDREN LESSONS AND MEMORIES THAT HE PASSED ON TO YOU AND TO HIS BELOVED WIFE TONY MALI (COMADRE) PARI (COMPADRE) BEN LOVED YOU DEARLY AND AS AND FOR AS LONG AS FATE AS FAYE AND I HAVE KNOWN YOU YOU AND BEN SHARED A SPECIAL INSEPARABLE BOND YOU WERE HIS SOUL MATE AND HIS ROCK AND TOGETHER YOU RAISED A BEAUTIFUL FAMILY ONE THAT FAYE AND I AND OUR CHILDREN HAVE BEEN FORTUNATE TO SEE AS AN EXTENSION OF OURS PARI (COMPADRE) MAY NO LONGER BE WITH US BUT HE WILL ALWAYS BE IN YOUR HEART OUR ISLAND HAS LOST A DEDICATED SELFLESS PUBLIC SERVANT AND SON OF GUAM AND EACH OF US GATHERED HERE THIS MORNING HAVE LOST A FRIEND A BROTHER AN IN-LAW A COUSIN AND UNCLE A FATHER GRANDFATHER AND HUSBAND TODAY WE RECOGNIZE AND THANK MAYOR VICENTE DIAZ GUMATAOTAO FOR HIS SERVICE FOR HIS UNSELFISHNESS AND FOR HIS FILLING OUR LIVES WITH LOVE LAUGHTER AND SO MANY LESSONS AND MEMORIES THAT WE WILL CHERISH FOREVER MAYOR BEN WILL BE DEARLY MISSED BUT HIS LEGACY AND EXAMPLE WILL LIVE ON IN HIS FAMILY AND ALL WHO KNEW HIM MAY ETERNAL REST BE GRANTED UNTO HIM O LORD AND MAY HE REST IN PEACE PUES ADIOS ESTA KI (GOODBYE UNTIL LATER) MAYOR PARI (COMPADRE) SI YU'OS UN BENIDISI (THANK YOU AND GOD BLESS YOU).

AT THIS TIME I CALL UPON REVEREND FATHER PAUL GOFIGAN TO DELIVER THE BENEDICTION LADIES AND GENTLEMEN PLEASE RISE.

REVEREND FATHER PAUL GOFIGAN (LEGISLATIVE CHAPLAIN): HOLY LORD ALMIGHTY AND ETERNAL GOD HEAR OUR PRAYERS FOR YOUR SERVANT VICENTE DIAZ GUMATAOTAO WHOM YOU HAVE SUMMONED OUT OF THIS WORLD FORGIVE HIS SINS AND FAILINGS AND GRANT HIM A PLACE OF REFRESHMENT LIGHT AND PEACE LET HIM PASS UNHARMED THROUGH THE GATES OF DEATH TO DWELL WITH THE BLESSED IN LIGHT AS YOU PROMISED ABRAHAM AND HIS CHILDREN FOREVER ACCEPT VICENTE INTO YOUR SAFEKEEPING AND ON THE GREAT DAY OF JUDGEMENT RAISE THEM UP WITH ALL THE SAINTS TO INHERIT YOUR ETERNAL KINGDOM WE ASK THIS THROUGH CHRIST OUR LORD THE LORD BE WITH YOU AND MAY ALMIGHTY GOD BLESS YOU THE FATHER THE SON AND THE HOLY SPIRIT.

SPEAKER MUÑA BARNES: ARE THERE ANY OBJECTIONS THERE BEING NONE THE LEGISLATIVE SESSION IS ADJOURNED SUBJECT TO THE CALL OF THE SPEAKER.
