BE IT RESOLVED BY I MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN: WHEREAS, THE LATE HONORABLE ALFONSO MATANANE PANGELINAN WAS BORN ON OCTOBER 22, 1927. HE IS THE SON OF VICENTE SANTOS PANGELINAN AND ANA MATANANE PANGELINAN AND GREW UP IN THE MACHANAO (TAKANO) AREA, AND AT HIS PARENT'S RANCH HOUSE IN LITEKYAN (RITIDIAN); AND THE LATE HONORABLE ALFONSO MATANANE PANGELINAN PASSED AWAY ON APRIL 17, 2019 AT THE AGE OF NINETY-ONE (91); AND HE WAS MARRIED TO †MARTHA CASTRO PANGELINAN FROM SINAJAÑA, AND THEY RAISED A FAMILY OF FIVE (5) CHILDREN: EVANGELINE P. FLORES, JANET P. LEON GUERRERO, MICHAEL C. PANGELINAN, DONALD C. PANGELINAN, AND ROSALYN P. OCHOCO; AND WERE BLESSED WITH EIGHTEEN (18) GRANDCHILDREN, AND TWENTY (20) GREAT-GRANDCHILDREN; AND THE LATE HONORABLE ALFONSO MATANANE PANGELINAN SERVED HONORABLY IN THE UNITED STATES ARMY; AND IN THE 1960S, THE LATE HONORABLE ALFONSO MATANANE PANGELINAN WAS A MEMBER OF THE SINAJAÑA CIVIC IMPROVEMENT CLUB (C.I.C.), AND FIRST SERVED THE MUNICIPALITY OF SINAJAÑA AS AN ASSISTANT COMMISSIONER (NOW KNOWN AS VICE-MAYOR) FROM JANUARY 11, 1965 TO DECEMBER 31, 1967; AND FROM JANUARY 1, 1968 TO JANUARY 8, 1973, THE LATE HONORABLE ALFONSO MATANANE PANGELINAN THEN SERVED THE MUNICIPALITY OF SINAJAÑA AS ITS COMMISSIONER (NOW KNOWN AS MAYOR); AND FROM 1975 TO 1978, THE LATE HONORABLE ALFONSO MATANANE PANGELINAN SERVED AT THE GOVERNOR'S OFFICE UNDER THE BORDALLO/SABLAN ADMINISTRATION; AND HE HAD ALSO SERVED AS PASSPORT OFFICE DIRECTOR UNDER THE BORDALLO/REYES ADMINISTRATION FROM 1983 TO 1986; AND RETIRED FROM THE GOVERNMENT OF GUAM AFTER THE BORDALLO/REYES TERM; AND AFTER RETIRING, THE HONORABLE ALFONSO MATANANE PANGELINAN REMAINED ACTIVE IN THE COMMUNITY AND SPENT HIS TIME PLAYING HIS BASS GUITAR WITH OTHER NOTABLE MUSICIANS, TO INCLUDE WILLIAM "BILL" MUÑA, GREGORIO MAFNAS, JOAQUIN PALOMO, BILL QUENGA, LUIS GOMBAR, AND DANNY ORLINO (TO NAME A FEW) AT WEDDINGS, FIESTAS,

AND GATHERINGS; AND THE LATE HONORABLE ALFONSO MATANANE PANGELINAN WAS ONE OF THE ORIGINAL ADVOCATES FOR THE RETURN OF CHAMORU LANDS TO THE ORIGINAL LANDOWNERS, AND FOR THE RETURN OF FEDERAL EXCESS LANDS TO THE ORIGINAL LANDOWNERS; AND DURING HIS GOLDEN YEARS, THE LATE HONORABLE ALFONSO MATANANE PANGELINAN SPENT HIS LEISURE TIME WITH HIS GRANDCHILDREN AND GREAT-GRANDCHILDREN TEACHING THEM HOW TO TUNE AND STRUM A GUITAR; AND HE WAS AN AVID FISHERMAN WHO LOVED ROD AND REEL FISHING, AND COOKING SOME OF HIS FAVORITE TRADITIONAL CHAMORU DISHES; AND THE LATE HONORABLE ALFONSO MATANANE PANGELINAN WAS VERY PROUD OF HIS FAMILY AFTER HAVING TO PLAY THE ROLE OF GRANDFATHER AND GRANDMOTHER TO HIS GRANDCHILDREN AND GREAT-GRANDCHILDREN FOR FORTY-TWO (42) YEARS; AND EVEN IN HIS OLDER YEARS, THE LATE HONORABLE ALFONSO MATANANE PANGELINAN CONTINUED TO KEEP HIS SPIRITS UP: AND HIS SENSE OF HUMOR NEVER LEFT HIM, EVEN IN HIS DYING MOMENTS; AND THE LATE HONORABLE ALFONSO MATANANE PANGELINAN WILL ALWAYS BE REMEMBERED AS AN OUTSTANDING PUBLIC SERVANT OF THE GOVERNMENT OF GUAM, AND FOR HIS HONORABLE AND DEDICATED SERVICE TO THE PEOPLE OF SINAJAÑA: NOW THEREFORE. YOUNG MAN DURING THE WAR MY GRANDFATHER MANAGED TO RISE ABOVE HIS ATROCITIES AND MAKE GOOD OF HIS LIFE AND BOY DID HE LIVE A LONG FRUITFUL LIFE OF 91 YEARS PERHAPS HE FELT THE NEED TO CONTINUE TO SERVE HIS ISLAND BY WORKING IN THE GOVERNMENT HOLDING VARIOUS JOBS THROUGHOUT HIS EARLY AND MID AGE LIFE MY GRANDFATHER FELT THE NEED TO DO MORE AND DECIDED TO SERVE THE PEOPLE OF SINAJANA BY BEING THE ASSISTANT COMMISSIONER FROM 1965 TO 1967 AS A RESULT HE GAINED THE TRUST AND CONFIDENCE OF THE PEOPLE OF SINAJANA AND BECAME THEIR COMMISSIONER IN 1968 TO 1973 NOW MANY OF YOU MIGHT AGREE THAT FOR ANYONE TO TAKE THE ROLE OF A PUBLIC SERVANT IT IS AN HONORABLE ROLE AND IT TELLS A LOT ABOUT THEIR CHARACTER AND THIS IS WHY WE ARE HERE TODAY CELEBRATING AND HONORING HIM THIS MORNING RESILIENT BECAUSE THROUGHOUT THE MANY CHANGES OF OUR ISLAND OUR ISLAND HAS SEEN IN THE PAST 70 PLUS YEARS MY GRANDFATHER CONTINUE TO BELIEVE THAT GUAM WAS GREAT THAT SINAJANA WAS GREAT AND NEVER SAW THE NEGATIVE SIDE OF THINGS RESILIENT BECAUSE LOSING HIS WIFE THE LATE MARTHA CASTRO PANGILINAN 42 YEARS AGO AND LIVING THROUGH THE DEPTHS OF ALL HIS SIBLINGS NUMEROUS FRIENDS AND COLLEAGUES MY GRANDFATHER CONTINUED TO HAVE A POSITIVE OUTLOOK IN LIFE HE REMAINED RESILIENT AND CONTINUED TO WORK AND RAISED HIS FAMILY ON HIS OWN NOW WHAT'S OUR ISLAND WITHOUT POLITICS AS A CHILD I REMEMBER MY GRANDFATHER TO BE A DIE-HARD DEMOCRAT I REMEMBER POCKET MEETINGS I REMEMBER CAMPAIGN JINGLES LIKE BORDALLO REYES FOR SURE BORDALLO REYES FOR SURE AND GRANDPA ALWAYS REMINDING US TO GET TO THE VOTING POLLS TO VOTE AT EVERY ELECTION AS A MATTER OF FACT GRANDPA NEVER MISSED HIS DUTY TO VOTE AS HE DID THIS PAST PRIMARY AND GENERAL ELECTION IT WAS HEARTWARMING TO SEE HOW THE PEOPLE OF SINAJANA WOULD FLOCK TO HIM WHENEVER THEY WOULD SEE HIM IN PUBLIC HE LOVED HIS VILLAGE VERY MUCH THAT HE WOULD FREOUENT THE COMMUNITY CENTER AND SOCIALIZE WITH HIS FRIENDS EVEN AFTER RETIRING HE LOOKED FORWARD TO GOING TO THE COMMUNITY CENTER BECAUSE IT MADE HIM HAPPY TO BE THERE RESILIENT BECAUSE FOR MANY YEARS MY GRANDFATHER FELT THE NEED TO FIGHT FOR THE RETURN OF HIS FAMILY'S LAND IN LITEKYAN' UNTIL HE COULD NO LONGER DO SO BECAUSE OF HIS FAILING HEALTH I THEN BECAME HIS VOICE BY READING HIS TESTIMONIES AT VARIOUS PUBLIC TOWN HALL MEETINGS AND PUBLIC HEARINGS I ONCE ASKED HIM A FEW YEARS AGO IF HE HAD HOPED THAT LITEKYAN' WOULD BE RETURNED BACK TO HIM AND HE REPLIED I DON'T THINK SO MY PARENTS AND ALL MY SIBLINGS HAVE DIED AND I'M THE ONLY ONE LEFT UNTIL THIS DAY WE CONTINUE TO FIGHT FOR LITEKYAN' THROUGH IT ALL MY GRANDFATHER KEPT HIS SPIRITS UP AND A SENSE OF HUMOR HELPED HIM KEEP HIS LONGEVITY LOOKING BACK THROUGH HIS LIFE OF 91 YEARS I DON'T THINK I CAN COMPARE TO WHAT MY GRANDFATHER HAS ENDURED AND ACCOMPLISHED WHAT I DO KNOW IS THAT HIS LIFE AND OUR MEMORIES OF HIM WILL FOREVER BE EMBEDDED IN OUR HEARTS AND CHERISHED AMONG HIS CHILDREN GRANDCHILDREN AND GREAT-GRANDCHILDREN I HOPE ONE DAY TO BE RESILIENT AS HE WAS MAY THE GOOD LORD KEEP HIM MEMORIALS GRANDPA WE LOVE YOU VERY MUCH.
