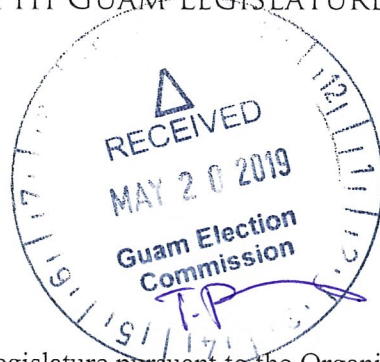


1. The Legislature did consent to the Executive Appointment of **Vincent P. Arriola** to serve as Director of the Department of Public Works.

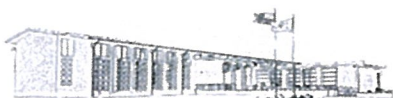


