AN ACT TO TRANSFER LOT NO. 3458-R1, CHALAN PAGO-ORDOT, GUAM FROM THE DEPARTMENT OF PARKS AND RECREATION TO THE OFFICE OF THE CHALAN PAGO-ORDOT MAYOR.

## BE IT ENACTED BY THE PEOPLE OF GUAM: 1 2 Section 1. Legislative Findings and Intent. I Mina'Trentai Siette Na 3 Liheslaturan Guåhan finds that the municipality of Chalan Pago-Ordot (CPO) 4 desires the transfer of Lot No. 3458-R1, a Government of Guam parcel within their municipality that is currently under the authority of the Department of Parks and 5 6 Recreation's, and under P.L. 18-15 granted the management of this parcel to the 7 CPO Mayor. Over the years since the enactment of P.L. 18-15, a community center, Mayor's office, and a Multi-Purpose Recreation / Emergency Center currently under 8 9 construction has been added to this site which is also being managed and maintained 10 by the CPO Mayor's office. The *Jose U. Atoigue Memorial Baseball Park* is also 11 located on this lot and was placed under the management of the CPO Mayor with 12 the enactment of P.L. 18-15. 13 I Liheslaturan Guåhan further acknowledges that the current construction of 14 the Multi-Purpose Recreation / Emergency Center and a new Mayor's office was an investment made by the Mayor and his Municipal Planning Council (MPC) using 15 16 their Host Community Premium funds and other grant funding sought out for capital 17 improvements to Lot No. 3458-R1. That the goal of these investments were focused


1	on the development of a CPO Mayor's Complex centrally located in the village and
2	easily accessible to all residents of the community.

Because the cost of the Multi-Purpose Recreation / Emergency Center includes a US Department of Agriculture (USDA) Rural Development loan that was obtained by the CPO Mayor and his MPC with the assistance of the Guam Economic Development Authority (GEDA) and a federal grant from the Office of Local Defense Community Cooperation (OLDCC), Department of Defense (DoD) based on a grant proposal that was prepared and submitted by the CPO Mayor, both of which have Federal Interests associated with these funding sources, *I Liheslaturan* Guåhan finds that the transfer of authority and jurisdiction of Lot No. 3458-R1 to the CPO Mayor's office will help to ensure that the federal interest requirements are not compromised during the 30-year requirement after the occupancy permit is issued for the Multi-Purpose Recreation / Emergency Center.

Section 2. Authorization to Transfer Lot No. 3458-R1 to the Office of the Chalan Pago-Ordot Mayor. Notwithstanding any other provision of law, rule, or regulation, *I Liheslaturan Guåhan* authorizes *I Maga'hågan Guåhan* to transfer authority and jurisdiction of Lot No. 3458-R1 to include all structures, parking areas, and recreational facilities on this government of Guam parcel to the Office of the Chalan Pago-Ordot Mayor.

**Section 3. Effective Date.** This Act *shall* be effective upon enactment.
