AN ACT TO ADD A NEW § 8104(c)(4) TO ARTICLE 1, CHAPTER 8, TITLE 5A, GUAM ADMINISTRATIVE RULES AND REGULATIONS, AND AMEND § 8105(c)(1)(F) OF ARTICLE 1. **CHAPTER** 8, **TITLE** 5A, **GUAM AND ADMINISTRATIVE** RULES REGULATIONS, RELATIVE TO EXEMPTING UNCERTIFIED TEACHERS WHO HAVE MORE THAN FOUR (4) YEARS OF TEACHING EXPERIENCE FROM THE GENERAL KNOWLEDGE REQUIREMENT **EXAMINATION** OF THE **GUAM EDUCATOR CERTIFICATION.** 

## 1 BE IT ENACTED BY THE PEOPLE OF GUAM.

2 Section 1. Legislative Intent. With this legislation, I Liheslaturan Guåhan 3 intends to exempt uncertified teachers who have more than four (4) years of teaching 4 experience and have received satisfactory performance rating from the General Knowledge Requirement examination of the Guam Educator certificate. This 5 6 legislation aims to address the shortcomings of the generalized process and requirements of the Guam Educator certification and allow uncertified teachers who 7 have accrued several years of teaching experience and have received satisfactory 8 performance evaluations to receive their teaching certificate. The teaching 9 experience and the satisfactory performance rating of uncertified teachers should be 10

- 1 accounted for for the Guam Educator certificate and should serve in lieu of the
- 2 General Knowledge Requirement examination.
- 3 Section 2. A new § 8104(c)(4) shall be added to Article 1, Chapter 8, Title
- 4 5A, Guam Administrative Rules and Regulations, to read as follows:
- 5 "(4) Any candidate for the Initial Educator Certificate under § 8105(b) of this
- 6 Chapter who have four (4) or more years of teaching experience from an accredited
- 7 <u>school in Guam and have received satisfactory performance.</u>"
- 8 Section 3. § 8105(c)(1)(F) of Article 1, Chapter 8, Title 5A, Guam
- 9 Administrative Rules and Regulations *shall* be amended to read as follows:
- 10 "(F) completion of two (2) years as an Initial Educator Certificate Holder- or
- by obtaining an Initial Educator Certificate under § 8104(c)(4) of this Chapter."
- 12 **Section 4. Effective Date.** This Act shall become effective upon enactment.
- Section 5. Severability. If any of the provisions of this Act or the application
- 14 thereof to any person or circumstance is held invalid, such invalidity *shall not* affect
- any other provision or application of this Act which can be given effect without the
- 16 invalid provision or application, and to this end the provisions of this Act are
- 17 severable.
