AN ACT TO AMEND PUBLIC LAW 21-146 TO ALLOW FOR THE CONSTRUCTION OF A SCHOOL ON LOT NO. 10119-12-R2, MUNICIPALITY OF DEDEDO AND TO AUTHORIZE THE GUAM HOUSING CORPORATION AND THE GUAM DEPARTMENT OF EDUCATION TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR SUCH.

### BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent.

3 I Liheslaturan Guåhan finds that the Guam Department of Education (GDOE)

- 4 has expressed their desire to build temporary classrooms for Simon Sanchez High
- 5 School on Lot 10119-12-R2 as described in Department of Land Management
- 6 Recorded Instrument No. 519979, Land Management 520-FY94 and is covered
- 7 under Certificate of Title 60985. The property has been transferred to the Guam
- 8 Housing Corporation by Public Law 21-146.
- 9 I Liheslaturan Guåhan also finds that the property is the best location for
- 10 temporary classrooms and administrative offices for a temporary Simon Sanchez
- High School while the permanent Simon Sanchez High School is being constructed.
- Lot 10119-12-R2 Municipality of Dededo is in very close vicinity to the existing

1 Simon Sanchez High School. The municipal boundary between Dededo and Yigo

2 crosses the property north to south.

*I Liheslaturan Guåhan* intends to authorize the Guam Department of Education and the Guam Housing Corporation to enter into a Memorandum of Agreement or such legal instrument relative to the use of Lot 10119-12-R2 Municipality of Dededo.

# Section 2. Authorization to Enter into a Memorandum of Agreement.

The Guam Housing Corporation and the Guam Department of Education are hereby authorized to enter into a Memorandum of Agreement or such legal instrument relative to the temporary use of a portion of Lot No. 10119-12-R2, hereto attached as Exhibit A, for a school. While Lot 10119-12-R2 Municipality of Dededo is zoned R-2, the portion designated for the temporary classrooms for Simon Sanchez High School *shall* be used exclusively as a school. Schools are a Conditional Use in R-1 and R-2 zones. Lot 10119-12-R2 Municipality of Dededo is depicted on Department of Land Management Recorded Instrument No. 519979, Land Management 520-FY94 and is covered under Certificate of Title 60985 for Basic Lot 10119, Municipality of Dededo.

**Section 3.** Section 1 of Public Law 21-146 is hereby amended as follows:

**Section 1.** (a) **Short Title.** This section shall be known as "The Guam Shelter Act".

(b) Authorization. The Governor of Guam is authorized to transfer Lot No. 10119-12, Dededo, containing an area of approximately 34.8 acres, as shown on Drawing DLM Sketch No. 1724 (the "Property"), to the Guam Housing Corporation to develop no less than two hundred (200) moderately priced multi-family, multi-story housing rental units. Any remaining portion of the Property shall be developed and used for schools, public parks, open spaces, and recreational facilities."

- **Section 4. Severability.** If any provision of this law or its application to any person or circumstance is found to be invalid or contrary to law, such invalidity *shall not* affect other provisions or applications of this law, which can be given effect without the invalid provisions or applications and to this end the provisions of this act are severable.
- **Section 5. Effective Date.** This Act shall be effective upon enactment.
