AN ACT TO *AMEND* §7113 OF CHAPTER 7, TITLE 17 OF THE GUAM CODE ANNOTATED, RELATIVE TO LIMITATIONS ON THE CAPACITY LEVELS FOR CONSTRUCTION OF NEW PUBLIC SCHOOLS; TO *AMEND* SECTION 2 OF PUBLIC LAW 29-102, RELATIVE TO EXPENDITURE OF BOND PROCEEDS; TO *AMEND* §3128 OF TITLE 17, GUAM CODE ANNOTATED, AND TO *DELETE* SECTION 11 OF PUBLIC LAW 28-183, RELATIVE TO EMPLOYMENT OF RETIREES AT GUAM PUBLIC SCHOOL SYSTEM (GPSS); TO APPROPRIATE FIVE MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$5,800,000) FROM THE GENERAL FUND FOR TEXTBOOKS; TO DIRECT THE PUBLIC AUDITOR TO AUDIT TEXTBOOK ACQUISITIONS AT GPSS; TO DIRECT /MAGA'LAHI/ TO RESERVE TWO MILLION DOLLARS (\$2,000,000) OF COMPACT IMPACT FUNDS FOR TEXTBOOKS; AND TO MAKE AN APPROPRIATION FOR THE CHILD NUTRITION PROGRAM.
