AN ACT TO ADD A NEW SUBSECTION (g) TO §55102, CHAPTER 55, DIVISION 3, TITLE 10 OF THE GUAM CODE ANNOTATED; AND TO AMEND §5.55(g) OF ARTICLE 2, CHAPTER 5, TITLE 8, GUAM CODE ANNOTATED, RELATIVE TO INCLUDING THE CRIMINAL INVESTIGATION SUPERVISOR, TAX INVESTIGATORS, ASSISTANT TAX **INVESTIGATORS**, COMPLIANCE INSPECTION SUPERVISOR AND COMPLIANCE INSPECTORS OF THE DEPARTMENT OF REVENUE AND TAXATION, AND THE ENTOMOLOGIST AND THE COMMODITY INSPECTORS OF THE DEPARTMENT OF AGRICULTURE IN THE COMPENSATION OF PUBLIC SAFETY AND LAW ENFORCEMENT OFFICERS.
