Bill No. 378-30 (LS) – by Frank B. Aguon, Jr.

AN ACT TO AMEND SUBSECTION (a) AND TO ADD A NEW SUBSECTION (g) OF §4301, ARTICLE 3, CHAPTER 4, TITLE 4, GUAM CODE ANNOTATED, RELATIVE TO RECOGNIZING THE TREMENDOUS BENEFIT AND IMPORTANCE OF PREVENTIVE HEALTHCARE ACTIVITIES AND PROGRAMS IN PROMOTING HEALTHIER LIVES, THROUGH REQUIRING THAT THE ACQUISITION OF HEALTH OR MEDICAL INSURANCE THROUGH THE GOVERNMENT OF GUAM INCLUDE THE PROVISION OF PREVENTIVE HEALTHCARE, WELLNESS, AND FITNESS.

AN ACT RELATIVE TO RECOGNIZING THE TREMENDOUS BENEFIT AND IMPORTANCE OF PREVENTIVE HEALTHCARE ACTIVITIES AND PROGRAMS IN PROMOTING HEALTHIER LIVES, THROUGH REQUIRING THAT THE ACQUISITION OF HEALTH OR MEDICAL INSURANCE THROUGH THE GOVERNMENT OF GUAM INCLUDE THE PROVISION OF PREVENTIVE HEALTHCARE, WELLNESS, AND FITNESS; AMENDING SUBSECTION (a) OF 54301 GROUP INSURANCE, ARTICLE 3, CHAPTER 4, TITLE 4, GUAM CODE ANNOTATED.

- 07/02/10 - Read Third ...PASSED.
- 07/06/10 - Transmitted to the Governor.
- 07/16/10 - Signed into law by the Governor. P.L. 30-170.
