AN ACT TO *ADD* A NEW §1515 AND AMEND §1514(B) OF ARTICLE 5 OF CHAPTER 1, AND TO *AMEND* §22952 OF ARTICLE 10 OF CHAPTER 22, ALL OF TITLE 5, GUAM CODE ANNOTATED; AND TO *AMEND* SECTION 2 OF PUBLIC LAW 30-179, RELATIVE TO AUTHORIZING THE ISSUANCE OF GOVERNMENT OF GUAM LIMITED OBLIGATION BONDS FOR THE PURPOSE OF ACQUIRING, CONSTRUCTING AND EQUIPPING AN EDUCATIONAL CULTURAL FACILITY AND CERTAIN OTHER PROJECTS THAT BENEFIT GUAM'S TOURISM INDUSTRY, AND FOR THE PURPOSE OF REFUNDING GOVERNMENT OF GUAM LIMITED OBLIGATION INFRASTRUCTURE IMPROVEMENT BONDS, 1997 SERIES A, TO APPROVE THE TERMS AND CONDITIONS OF SUCH BOND ISSUE; AND TO CHANGING THE TERMS FOR THE ISSUANCE OF DEBT AUTHORIZED UNDER PUBLIC LAW 30-179.

AN ACT TO REPEAL AND REENACT SECTION 1514 OF TITLE 5, GUAM CODE ANNOTATED, TO AUTHORIZE THE ISSUANCE OF GOVERNMENT OF GUAM LIMITED OBLIGATION BONDS FOR THE PURPOSE OF ACQUIRING, CONSTRUCTING AND EQUIPPING AN EDUCATIONAL CULTURAL FACILITY, A COMMUNITY CULTURAL CENTER AND CERTAIN OTHER PROJECTS THAT BENEFIT GUAM'S TOURISM INDUSTRY AND FOR THE PURPOSE OF REFUNDING GOVERNMENT OF GUAM LIMITED OBLIGATION INFRASTRUCTURE IMPROVEMENT BONDS, 1997 SERIES A, AND TO APPROVE THE TERMS AND CONDITIONS OF SUCH BOND ISSUE.
