AN ACT TO ADD §§1102(c)(1), AND 1102(vv) AND (ww) TO CHAPTER 1; AND TO ADD NEW DEFINITIONS TO §5101, AMEND §§55109(a), 5109(c) AND 5112(b), AND ADD NEW §§5112(d), 5116(d) AND 5117 TO CHAPTER 5, ALL OF TITLE 16, GUAM CODE ANNOTATED, RELATIVE TO GRANTING DMV/MCSAP OFFICIALS WITH AUTHORITY TO ISSUE CITATIONS AND EXPAND THE SCOPE FO THE AUTHORITY AND INTRASTATE MOVEMENTS OF CMVS, AND CODIFIES E.O. 87-27 RELATIVE TO CONDUCTING INSPECTION OF CMVS AT OWNER'S PREMISES.
