AN ACT TO ADD A NEW §4121 TO CHAPTER 4, AND A NEW §2103.2 TO CHAPTER 2, ALL OF TITLE 5; AND TO REPEAL AND REENACT §1106 OF CHAPTER 1 OF TITLE 2, GUAM CODE ANNOTATED, RELATIVE TO THE SUSPENSION OF THE SALARIES OF I MAGA'LAHEN GUAHAN, I SEGUNDU NA MAGA'LAHEN GUAHAN, AND THE SENATORS OF I LIHESLATURAN GUAHAN IN THE EVENT OF A GOVERNMENT SHUTDOWN CAUSED BY THE FAILURE TO ENACT AN ANNUAL OPERATING BUDGET FOR THE GOVERNMENT OF GUAM IN ACCORDANCE WITH THE ORGANIC ACT.

AN ACT TO ADD A NEW §4121 TO CHAPTER 4, TITLE 5 OF THE GUAM CODE ANNOTATED TO PROVIDE FOR THE SUSPENSION OF THE SALARIES OF I MAGA'LAHEN GUÅHAN, I SEGUNDU MAGA'LAHEN GUÅHAN, AND THE SENATORS OF I LIHESLATURAN GUÅHAN IN THE EVENT OF A GOVERNMENT SHUTDOWN CAUSED BY THE FAILURE TO ENACT AN ANNUAL OPERATING BUDGET FOR THE GOVERNMENT OF GUAM IN ACCORDANCE WITH THE ORGANIC ACT.

- 04/26/11 - Public hearing scheduled by the Committee on Rules, Federal, Foreign, & Micronesian Affairs, and Human & Natural Resources.
- 05/02/11(04/29/11)* - From the Committee on Rules, Federal, Foreign, & Micronesian Affairs, and Human & Natural Resources with the recommendation to do pass.
- 05/02/11 - Placed on Second Reading File.
- 05/09/11 - Discussed; amended; through motion placed on the Third Reading File.
- 05/10/11 - Read Third ...PASSED.
- 05/16/11 - Transmitted to the Governor.
- 05/24/11 - Signed into law by the Governor. P.L. 31-71.
