AN ACT TO APPROPRIATE FUNDS FROM THE FISCAL YEAR 2014 HEALTHY FUTURES FUND UN-APPROPRIATED FUND BALANCE TO THE DEPARTMENT OF PUBLIC HEALTH AND SOCIAL SERVICES (DPHSS) AND THE NON-COMMUNICABLE DISEASE CONSORTIUM UNDER THE DPHSS

## BE IT ENACTED BY THE PEOPLE OF GUAM:

**Section 1. Appropriation.** Notwithstanding any provision of law, the sum of Three Million Dollars (\$3,000,000) is hereby appropriated from the unappropriated, un-allocated Fiscal Year 2014 Healthy Futures Fund fund balance to the Department of Public Health and Social Services (DPHSS) and the Non-Communicable Diseases Consortium, under the DPHSS as specifically provided for in the following distribution and authorized expenditure schedule:

(\$2,500,000) is hereby allocated to the Guam Medicaid Program of the Department of Public Health and Social Services for the financial obligations incurred for FY 2015 to be used as local matching requirements with available and authorized federal matching grants-in-aid, provided, however, the expenditure of a portion of this allocation is hereby authorized and may be solely utilized to supplement the Guam Cancer Assistance and Treatment Fund Program;

1	(2) The sum of Five Hundred Thousand Dollars (\$500,000) is
2	hereby allocated to the Non-Communicable Diseases Consortium,
3	under the Department of Public Health and Social Services to sustain
4	the implementation of the "Getting Guam Healthy Incentive Program"
5	(GGHIP), pursuant to Public Law 32-179.
