Chairman Mike Cruz called the public hearing to order. He welcomed the Senators present. Chairman Mike Cruz read the purpose of the bill and asked if anyone was present to testify on behalf of the bill.

Senator Aguon spoke on behalf of the bill's author, Senator Lou Leon Guerrero, and advised that she was absent because she was off-island on personal matters.

Chairman Cruz thanked the Senator for his comment.

Janet B. Cruz, Management Analyst with the Health Profession Licensing Office, and currently in charge of overseeing daily activities in support of all of the Board of Examiners of the Healing Arts, presented oral testimony to suggest that there should be an addition in Bill 107 to provide reciprocity to manicurists as well since they were inadvertently excluded from Public Law 25-188, and as such, does not recognize manicurists who are already licensed in the U.S.

Chairman Cruz questioned the role of an esthetician.

Janet B. Cruz answered that an esthetician is one that deals with the face and skin portion of the body.

Chairman Cruz asked if Ms. Cruz was speaking in favor of Bill 107 and then re-stated Ms. Cruz' recommendation that manicurists and estheticians be recognized both under Bill No. 107 to which she affirmed that she was in favor of the bill and that his statement is correct.

Senator Aguon requested that she submit written testimony or work with the Chairman's staff to make sure that it includes the appropriate language for reciprocity. He wants to make certain that the bill holds the sufficient wording when it is brought to the floor.

Chairman Cruz thanked Senator Aguon for his comment and invited Senator Palacios to comment.

Senator Palacios noticed that the bill does not state clearly what exactly is being repealed. He questioned Janet B. Cruz on her knowledge of what is being repealed.

Janet B. Cruz apologized for not answering the question due to the fact that she did not have the bill in front of her.

Senator Palacios stated that the bill would only be established if two whole sections of the current law were eliminated, and he questioned this because he didn't know what was being taken out (because it wasn't stated in the bill).

Chairman Cruz apologized for not knowing the subsections either; and brought up the point that according to Senator Lou Leon Guerrero's staff, the language in Bill 107 actually came from GCC. The Chairman apologized for not getting the information from them. He confirmed that his office will get the report out with all the needed information and thanked his colleagues for the comment and participation. Seeing no more testimonies on Bill 107, Chairman Cruz adjourned.

COMMITTEE FINDINGS:

The concerns addressed by committee member, Senator Palacios, warranted a review of the contents of Bill 107 and the current statute on Section 18119, Chapter 19, Title 10 GCA. To repeal Sections 2 and 3 each in its entirety without restating the affected language made it difficult to determine the necessity for such repeal. As such, the Committee has substituted the bill to clearly reflect such amendments.

Oral testimony provided by Janet Cruz, has been examined and does reflect her recommendations. Moreover, written testimony received on February 22, 2006 from Associate Professor Ron Abshire of the Cosmetology department, Guam Community College expresses his support of Bill 107 (LS).

COMMITTEE RECOMMENDATION:

The Committee on Health & Human Services recommends that Bill 107 (LS): "An Act to Repeal Section 18119(a)(2) and (4) and to Amend (3)(ii) and to Add a new Subsection (3)(ii), Chapter 18, Title 10 Guam Code Annotated, relative to the Eligibility and Qualifications for Esthetician License," be submitted to I Mina'Bente Ocho Na Liheslaturan Guåhan with a recommendation TO PASS Bill No. 107 (LS), as substituted by the Committee.

- (4) who has actively engaged in at least three (3) years in the occupation of a cosmetologist, or any branch thereof, in the territory or in any jurisdiction having standards for registration substantially equivalent to those of Guam.

§18120. Eligibility and Qualifications for Cosmetological Instructors. The Board shall admit to examination for license as a cosmetology or barbering instructor any person who has made and application to the Board in the proper form, who has paid the fee required by this Chapter and who meets the following qualifications:

- (a) who is not less than 18 years of age;
- (b) has completed the 12th grade, or an accredited senior high school course of study in Guam public schools or its equivalent;
- (c) holds a valid Guam license in good standing to practice cosmetology or barbering;

Footnote: The Bill proposes to climinate inconsistencies in the existing mandate related to the requirement and eligibility for an Esthetician License. Per current mandate and information received from the DPHSS Health Professional Licensing Office, the existing mandate does not allow for licensing specific to the practice of an Esthetician, instead, in order to practice, one must hold a valid Guam License of Cosmetology. Therefore, anyone holding a Esthetician License (issued from outside of the Territory of Guam) and wishes to practice on Guam, must obtain a License on Cosmetology. As such, this Bill proposes to allow a person already holding a valid Esthetician License to practice (as long as its state license requirements, in the judgement of the Board, are equal or are greater than Guam's). Likewise, anyone studying or receiving training in esthetics on Guam or outside of Guam could obtain an Esthetician License in accordance with the requirements and eligibility being proposed (without having to obtain a Guam Cosmetology license to practice).

Note that per DPHSS, the current Health Professional License processing fee is \$20.00. This fee would apply for an Esthetician License. As such, additional revenues, although minimal, could be realized from the collection of fees based on the number of Esthetician licenses applied for (ie. in a given fiscal year). It is undetermined how many applicants would be applying for this specialty license at this time.



AN ACT TO REPEAL AMEND SECTION 18119,(a)(2) AND (4) AND TO AMEND (3)(ii) AND TO ADD A NEW SUB-SECTION (3)(iii) DIVISION 1, CHAPTER 18, TITLE 10 OF THE GUAM CODE ANNOTATED, RELATIVE TO THE ELIGIBILITY AND QUALIFICATIONS FOR ESTHETICIAN LICENSE.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Intent. I Mina'Bente Ocho Na Liheslaturan 3 Guåhan finds that there are inconsistencies in the existing mandate related to the requirement and eligibility for esthetician's examination under the 4 Board of Cosmetology. One such inconsistency is the current requirement 5 pertaining to eligibility and qualifications for licensure of individuals that 6 have practiced outside of Guam. Other concerns raised with the current 7 8 law are the additional requirements applied to those individuals who plan 9 to take the esthetician license exam which require that the individual must 10 hold a valid Guam license to practice cosmetology. This means that if an individual wishes to take an exam for an esthetician's license, that 11 individual must first have a cosmetology license. There are no other exams 12 within cosmetology that requires this. 13

1	Therefore, it is the intent of I Mina Bente Ocho Na Liheslaturan Guåhan
2	to make the necessary changes to the existing statutes that will allow
3	individuals who wish to apply for an esthetician license under the
4	Cosmetology Board consistent with their practice.
5	Section 2. Section 18119, Division 1, Chapter 18, Title 10, Guam
6	Code Annotated is hereby amended to read as follows.
7	§18119. Eligibility and Qualifications for Esthetician License.
8	(a) The Board shall administer examination for license as an
9	esthetician during a Board meeting duly held for the purpose of
10	administering examinations for applicants who have made the proper
11	applications for such license and who have qualified as follows:
12	(1) who is not less than 18 years of age;
13	(2) holds a valid Guam license to practice cosmetology;
14	(3)(2) has done one of the following:
15	(i) completed a certified esthetician program of at least six
16	hundred (600) hours extending over a school year of not
17	less than four (4) months from a school of cosmetology
18	approved by the Board; or
19	(ii) completed not less than the equivalent of six hundred
20	(600) hours of practice as a teacher assistant or teacher
21	aide in a school approved by the Board; and
22	(ii) holds a current unrestricted valid esthetician's license
23	issued by a state or territory of the United States in good

1	standing, whose license requirements in the judgment of
2	the Board are equal to or greater than Guam's.
3	(4) who has actively engaged in at least three (3) years in the
4	occupation of a cosmetologist, or any branch thereof, in the
5	territory or in any jurisdiction having standards for registration
6	substantially equivalent to those of Guam."
7	Section 3. Severability. If any provision of this Law or its
8	application to any person or circumstance is found to be invalid or contrary
9	to law, such invalidity shall not affect other provisions or applications of
10	this Law, which can be given effect without the invalid provisions or
11	application, and to this end the provisions of this Law are severable.

Dear Senator Cruz:

I write to you on behalf of the Board of Cosmetology in regard to the current draft of Bill No. 107(LS), as substituted by the Committee on Health and Human Services, which was recently provided to us by Elaine Dell'Isola of your offices. The Board has reviewed this law and would like to provide you and the Committee with our comments.

The Board strongly supports Bill No. 107(LS), but believes one important change needs to be made. As you know, Bill 107(LS) seeks to modify the current qualifications for an esthetician's license. Importantly, the Bill recognizes that estheticians are not necessarily cosmetologists, or vice versa, and therefore makes important changes to the current law. The Board was unanimous at its last session in agreeing that this change in the law was correct.

However, Section 2 of the Bill proposes that subsection (3) of section 18119 of Title 10 of the G.C.A. be modified to provide that an applicant can qualify to take the test for an esthetician license if: (i) they have completed 600 hours approved course work; (ii) they have engaged in 600 hours of equivalent work experience; or (iii) they presently hold an esthetician license in another U.S. jurisdiction. The Board believes that both subparts (i) and (iii) are valid and proper means of establishing qualification for a license. But, the Board also is of the opinion that subpart (ii) is not.

It is the unanimous view of the Board that work experience is not a valid means of establishing qualification to take the license exam. Work experience will not necessarily indicate that someone has received adequate training. Some applicants may have received their work experience in an environment that does not conform to expectations for the proper esthetician practice here in Guam. But, it will be very difficult, if not impossible, to judge whether such experience was adequate. And, if an applicant has work experience in another U.S. jurisdiction,

jurisdiction (which means they should already qualify under (iii), and that if they do not there is cause for concern).

For all of these reasons, the Board respectfully recommends that the Committee consider modifying the Bill to delete the proposed language for 10 G.C.A. § 18119(a)(3)(ii). Please feel free to contact me or the Board should you have any questions.
