AN ACT TO APPROPRIATE THE SUM OF TWELVE THOUSAND DOLLARS (\$12,000) FROM THE GENERAL FUND TO THE GUAM PUBLIC SCHOOL SYSTEM FOR THE PURPOSE OF REPLACING DEFECTIVE AIR CONDITIONING UNITS AT THE FACULTY LOUNGE, COUNSELORS' OFFICE, AND SUPPLY ROOM AT ORDOT-CHALAN PAGO ELEMENTARY SCHOOL.

BE IT ENACTED BY THE PEOPLE OF GUAM:

1 **Section 1. Legislative findings and intent.** *I Liheslaturan Guåhan* finds
2 that it has appropriated Forty Thousand Six Hundred Dollars (\$40,600) to the Ordot-
3 Chalan Pago Elementary School in Public Law 28-68 for the replacement of defective
4 air conditioning units.

5 *I Liheslaturan Guåhan*, however, finds that after the passage of Public Law 28-
6 68, other air conditioning units also became non-operational.

7 *I Liheslaturan Guåhan* now finds that the faculty lounge, the counselor's
8 office, and the supply room of the Ordot-Chalan Pago Elementary School do not have
9 air conditioning for more than a month. The absence of air conditioning at these
10 offices can be very discomfoting, if not unhealthy, for the employees of the school as
11 well as the students alike.

1 *I Liheslaturan Guåhan* further finds that the recently enacted legislation, Public
2 Law 28-45, mandates that the school must be air conditioned or properly ventilated in
3 which the sensible air temperature is no greater than 78°F.

4 *I Liheslaturan Guåhan* finds that there is a need to appropriate additional
5 funding to install appropriate air conditioning units.

6 *I Liheslaturan Guåhan*, therefore, intends to appropriate Twelve Thousand
7 Dollars (\$12,000) from the General Fund, from the Ten Million Dollars
8 (\$10,000,000) previously reserved in Section 2, subsection (a) of Public Law 28-49 to
9 the Department of Education for General Operations, to supplement the Forty
10 Thousand Six Hundred Dollars (\$40,600) appropriated in the 2006 Budget Act
11 intended for the cafeteria, the library, and the administrative office.

12 **Section 2. Appropriation.** The sum of Twelve Thousand Dollars (\$12,000) is
13 hereby appropriated from the General Fund to the Guam Public School System for
14 the purpose of installing new air conditioning units at the faculty lounge, the
15 counselor's office, and the supply room of the Ordot-Chalan Pago Elementary
16 School.

17 **Section 3.** The appropriation in Section 2 of this Act is pursuant to the
18 provision of subsection (a), Section 2 of Public Law 28-49.
