AN ACT TO APPROPRIATE THE SUM OF ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000) FROM THE TOURIST ATTRACTION FUND TO THE DEPARTMENT OF PARKS AND RECREATION FOR THE DESIGN AND CONSTRUCTION OF A MEMORIAL FOR THE LATE SENATOR ANGEL SANTOS AT THE ANGEL SANTOS LATTE STONE MEMORIAL PARK IN HAGÁTÑA PURSUANT TO THE MANDATE OF PUBLIC LAW 27-44.

BE IT ENACTED BY THE PEOPLE OF GUAM:

1 **Section 1. Legislative findings and intent.** *I Liheslaturan Guåhan* finds
2 that their former and late colleague, Senator Angel Leon Guerrero Santos was
3 a hardworking and dedicated legislator, genuinely pursuing and advocating
4 for the rights of the Chamorro people.

5 *I Liheslaturan Guåhan* also finds that the late Senator Angel Leon
6 Guerrero Santos had devoted his utmost efforts towards the preservation and
7 appreciation of the finest traditions, culture and beliefs of the Chamorro
8 people.

1 *I Liheslaturan Guåhan* further finds that the late Senator Angel Leon
2 Guerrero Santos has pursued his career in the Legislature as a strong
3 advocate for the democratic ideals in government and in ensuring that our
4 government fulfills its moral obligation to assist the destitute, the financially
5 impoverished and the socially disadvantaged members of Guam’s society.

6 *I Liheslaturan Guåhan* finds that the decision and mandate to
7 memorialize the superlative deeds and accomplishments of their former
8 colleague were incorporated in the provisions of Public Law 27-44, which
9 required the Department of Parks and Recreation to formulate the design for
10 the construction of a memorial monument at the Latte Stone Park in Hagåtña,
11 honoring the late Senator Angel Leon Guerrero Santos.

12 *I Liheslaturan Guåhan* therefore, intends to implement the mandate of
13 Public Law 27-44, which required the Department of Parks and Recreation
14 and the Governor of Guam to submit a legislation appropriating the
15 necessary funding for the design and construction of the mandated memorial
16 monument at the Angel Santos Latte Stone Memorial Park.

17 **Section 2.** The sum of One Hundred Fifty Thousand Dollars (\$150,000)
18 is hereby appropriated from the Tourist Attraction Fund to the Department of
19 Parks and Recreation for the design and construction of a memorial
20 monument, including necessary landscaping and other related
21 improvements, such as lighting and fencing, at the Angel Santos Latte Stone
22 Memorial Park in Hagåtña.
