AN ACT PROHIBITING **SMOKING** WITHIN OR GOVERNMENT **GUAM OF** OWNED LEASED VEHICLES AND PROHIBITING SMOKING WITHIN FIFTEEN (15) FEET OUTSIDE OF A DOORWAY LEADING INTO A BUILDING OR FACILITY WHERE SMOKING IS PROHIBITED, THROUGH WHICH THE PUBLIC CAN GAIN INITIAL ACCESS TO THE **BUILDING OR** FACILITY.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. New Subsections 13 and 14 is hereby added to Section 90105
- 3 Chapter 90 of Title 10, Guam Code Annotated to read as follows:
- 4 **"§90105. Prohibition of Smoking in Public Places.** (a) Smoking shall be
- 5 prohibited in all enclosed public places, including, but not limited to, the
- 6 following places:
- 7 (1) Elevators.

(2) Buses, taxicabs, airplanes, and other means of public transit, and 1 ticket, boarding, and waiting areas of public transport depots. 2 (3) Restrooms. 3 (4) Service lines. 4 (5) All areas available to and customarily used by the general public 5 in all businesses patronized by the public. 6 (6) Restaurants. 7 (7) Public areas of aquariums, galleries, libraries and museums when 8 open to the public. 9 (8) Any building not open to the sky which is primarily used for 10 exhibiting motion pictures, stage shows, musical recitals or other 11 performances, except when smoking is part of a stage production. 12 (9) Sports arenas and convention halls. 13 (10) Every place of meeting or public assembly during such time as a 14 public meeting is in progress. 15 (11) Waiting rooms, hallways, wards and semi-private rooms for 16 health facilities, including, but not limited to, hospitals, clinics, physical 17 therapy facilities, doctors' offices and dentists' offices. 18 (12) Polling places. 19 (13) Government of Guam owned or leased vehicles. 20 (14) Within fifteen (15) feet outside of a doorway leading into a 21 building or facility where smoking is prohibited under this section, 22 through which the public can gain initial access to the building or 23 facility. 24

(b) Any owner, operator, manager or other person who controls any establishment, facility or area described within this Chapter where smoking is not or in-part regulated, may prohibit smoking to occur within the entire establishment, facility or area and §90109, §90110, and §90111 of this Chapter shall apply."

Section 2. Subsections 13 and 14 of §90105 of Title 10 Guam Code
Annotated shall take effect thirty (30) days after the passage of this Act.
