AN ACT TO AMEND SECTION 1 OF PART 1-
DEPARTMENT OF PUBLIC HEALTH AND SOCIAL
SERVICES, OF CHAPTER III OF PUBLIC LAW 29-19 TO
INCREASE THE APPROPRIATION FROM FORTY-
SEVEN MILLION THREE HUNDRED FIFTY-SIX
THOUSAND ONE HUNDRED EIGHT DOLLARS
(\$47,356,108) TO SIXTY-ONE MILLION THREE
HUNDRED FIFTY-SIX THOUSAND ONE HUNDRED
EIGHT DOLLARS (\$61,356,108) FOR THE PURPOSE OF
FUNDING OBLIGATIONS IN THE MEDICALLY
INDIGENT PROGRAM AND THE MEDICAID
PROGRAM.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Section 1 Of Part 1-Department Of Public Health And
3 Social Services, Of Chapter III Of Public Law 29-19 is amended to read:

4 "Section 1. Department of Public Health and Social Services
5 General Fund Appropriations. The following appropriations totaling
6 Sixty-one Million Three Hundred Fifty-six Thousand One Hundred
7 Eight Dollars (\$61,356,108) [~~Forty-seven Million Three Hundred Fifty-~~
8 ~~six Thousand One Hundred Eight Dollars (\$47,356,108)] are made from~~

1 the General Fund to the Department of Public Health and Social
2 Services (DPHSS) for Fiscal Year 2008 as follows:

3 (a) DPHSS Operations and Community Health Centers. The
4 sum of Fifteen Million Three Hundred Fifty-six Thousand Six Hundred
5 Ninety-seven Dollars (\$15,356,697) is appropriated from the General
6 Fund to the Department of Public Health and Social Services for its
7 operations, including operation of the Community Health Centers.

8 (b) Public Assistance Program Payments. The sum of Two
9 Million Two Hundred Fifty-one Thousand Nine Hundred Dollars
10 (\$2,251,900) is appropriated from the General Fund to the Department
11 of Public Health and Social Services for Public Assistance Program
12 payments.

13 (c) Medically Indigent Program. The sum of Twenty [~~Fifteen~~]
14 Million Eight Hundred One Thousand Four Hundred Thirty-three
15 Dollars (20,801,433) [~~(\$15,801,433)~~] is appropriated from the General
16 Fund to the Medically Indigent Program Payment Revolving Fund
17 (MIPPR) for the Medically Indigent Program (MIP).

18 (d) Medicaid Program. The sum of Twenty-one [~~Twelve~~] Million
19 Nine Hundred Eleven Thousand Dollars (21,911,000) [~~(\$12,911,000)~~] is
20 appropriated from the General Fund to the Department of Public
21 Health and Social Services for the local match requirement of the
22 Medicaid Program.

1 (e) Medicines for the Community Health Centers. The sum of
2 Three Hundred Thousand Dollars (\$300,000) is appropriated from the
3 General Fund for Fiscal Year 2008 to the Department of Public Health
4 and Social Services' Community Health Centers for the purchase of
5 medicines.

6 (f) Catastrophic Illness Program. The sum of One Hundred
7 Thousand Dollars (\$100,000) is appropriated from the General Fund for
8 Fiscal Year 2008 to the Department of Public Health and Social Services
9 for the *sole* purpose of funding the Catastrophic Illness Program. Said
10 funds shall not be transferred *or* used for any other purpose.

11 (g) Enhanced Allotment Plan. The sum of Four Hundred Sixty-
12 nine Thousand Seven Hundred Three Dollars (\$469,703) is appropriated
13 from the General Fund to the Department of Public Health and Social
14 Services for the Enhanced Allotment Plan (Medicaid Part D) for Fiscal
15 Year 2008.

16 (h) Foster Homes. The sum of One Hundred Sixty-five Thousand
17 Three Hundred Seventy-five Dollars (\$165,375) is appropriated from the
18 General Fund to the Department of Public Health and Social Services
19 for payments of stipends and fees for Foster Home care for Fiscal Year
20 2008.”
