



**AN ACT TO ADD A NEW §70.11 TO CHAPTER 70 OF 9GCA
RELATIVE TO DOGFIGHTING.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** §70.11 is hereby *added* to Chapter 70 of 9GCA to read:

3 **“§70.11. Dog fighting: Defined: Penalty.** (a) A person commits a
4 third degree felony if he:

5
6 (1) Owns, possess, keeps, trains, promotes, purchases, or knowingly
7 sells a dog for the purpose of fighting, and or

8 (2) Gambles or bets on the outcome of a fight involving a dog(s), and
9 or

10 (3) For amusement or gain, causes, allows, or permits the fighting of a
11 dog(s), and or

12 (4) Is a spectator at an event involving the fighting of a dog(s).

14 Notwithstanding any other provision of law, the penalty for violations
15 of Items (1), (2), (3) and (4) of this paragraph shall be confinement in a
16 correctional facility of not less than one (1) and no more than three (3) years

1 or a fine of not less than Five Thousand Dollars (\$5,000) and no more than
2 Ten Thousand Dollars (\$10,000) or both per violation.

4 (b) A person commits a second degree felony if he:

5
6 (1) Keeps, uses, be connected with or interested in the management
7 of, or receives money or other consideration for the admission of a
8 person to, a place kept or used for the purpose of fighting a dog(s),
9 and or

10 (2) Permit or suffer a place owned or controlled by him to be used as
11 provided in Item (1) of this Paragraph), and or

12 (3) Permit or suffer a place leased by him to be used as provided in
13 Item (1) of this Paragraph, and or

14 (4) Be present and witness, pay admission to, encourage, aid or assist
15 in an activity enumerated in Item (1) of this Paragraph, and or

16 (5) Promotes, hosts or sponsors an activity enumerated in Item (1) of
17 this Paragraph.

19 Notwithstanding any other provision of law, the penalty for violations
20 of Items (1), (2), (3), (4) and (5) of this paragraph shall be confinement in a
21 correctional facility of not less than three (3) and no more than five (5) years
22 or a fine of not less than Ten Thousand Dollars (\$10,000) and no more than
23 Fifteen Thousand Dollars (\$15,000) or both per violation.
