AN ACT TO EXCHANGE LOTS WITHIN THE IJA SUBDIVISION "LAND FOR THE LANDLESS PROJECT" WITH OTHER LOTS IN INARAJAN

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan

3 finds that certain lots already awarded to forty-four (44) families in the Ija

4 Subdivision, known as the "Land for the Landless Project" Agricultural

5 Subdivision Tract 3734 Ija (Subdivision), Municipality of Inarajan and

6 registered under Document No. 471864 are undevelopable. It is the intent

7 of I Liheslaturan Guåhan that suitable land under the Chamorro Land Trust

8 inventory be exchanged for the forty-four (44) undevelopable lots so that

9 the awardees of the forty-four (44) lots can proceed in building much

10 needed homes for their families.

Section 2. Lots in the Chamorro Land Trust Subdivision. The 1 Chamorro Land Trust Commission and I Maga'lahen Guåhan are hereby 2 authorized to exchange a portion of the Ija Subdivision Extension based on 3 the Agricultural Subdivision Survey Map of Tract 37306, Municipality of 4 Inarajan, Document Number: 754846. - Section 3. Lots in the "Land for the Landless" Subdivision. Eight 4 of the above subject lots will be exchanged with the first preference based 5 on the date of full payment for their lots in the Ija Subdivision "Land for 6 the Landless Project" in Inarajan, Guam identified as follows: Agricultural 7 Subdivision Tract 3734 Ija (Subdivision) Municipality of Inarajan and 8 registered under Document No. 471864 Block 1 Lot Number 4, Joseph T. & 9 Bertha C. - Section 3. The distribution of the remaining thirty-six (36) new lots to be created by this Act shall be by lottery. The lottery shall be administered jointly by the Department of Land Management and the Inarajan mayor. The participants in the lottery shall only be the awardees of the thirty-six (36) lots listed in §2 of this Act.
- Section 4. Waiver of Subdivision Law. Notwithstanding any other 10 provision of law, all requirements of Article 5 of Chapter 62 of Title 21 of 11 the Guam Code Annotated (Subdivision law) are hereby waived and are 12 declared not applicable to the forty-four (44) "Land for the Landless" lots to 13 be created by the land exchange. This project is exempted from review and 14 consideration by the Guam Planning Council and the Guam Land Use 15 Commission. Subdivision maps for this project shall only require the 16 approval of the Department of Land Management. The Director of Land 17

- 1 Management, upon completion of the subdivision of the forty-four (44) lots
- 2 created by this Act, shall submit to I Liheslaturan Guåhan the total cost
- 3 required to develop the infrastructure thereof for appropriation by I
- 4 Liheslaturan Guåhan.
- 5 **Section 5. Waiver of Appraisal Requirements.** The requirement for
- 6 independent appraisal is waived since this is property being exchanged
- 7 from one adjoining government subdivision to another.
- Section 6. Waiver of One Land Transaction Per Bill. The nature of
- 9 the land transaction identified above does not make it practical to
- introduce forty-four separate bills to comply with the requirement.
- Section 7. Notwithstanding any other provision of law, the forty-four
- 12 (44) lots created by this Act are zoned Single Family Residential, R-1.
