AN ACT TO ADD §26208.2 TO CHAPTER 26, DIVISION 2 OF TITLE 11 OF THE GUAM CODE ANNOTATED RELATIVE TO THE PHARMACEUTICALS FUND.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Amendment to Pharmaceuticals Fund. A new §26208.2 is hereby added to Chapter 26, Division 2 of Title 11 of the Guam Code Annotated to read as follows:

"§26208.2 Application of Guam Memorial Hospital Authority Pharmaceuticals Fund. For the purpose of recognizing appropriated Pharmaceutical funds as operating revenue by the Guam Memorial Hospital Authority, retroactively and prospectively. The Hospital will be responsible to fully demonstrate the manner in which the payments were applied via the Hospital's annual audited financial report. Such distinction shall in no way result in the recognition of additional revenue by the Hospital other than what was appropriated by the Legislature."

BOARD OF TRUSTEES OFFICIAL RESOLUTION No. 09-15

"Relative to the administration of funding relevant to hospital patients accounts"

WHEREAS, the Guam Memorial Hospital Authority a component of Government of Guam, is responsible to provide and deliver quality health care to the people of Guam notwithstanding one's financial ability; and

WHEREAS, the Guam Legislature, in recognition of the Hospital's meaningful commitment has succored via legislatively appropriated funding intended to support Hospital operations; and

WHEREAS, the Hospital has properly recorded and reflected receipt of the legislative funds as non-operating revenue -- Reimbursement from the Government of Guam; and

WHEREAS, the Hospital's auditors, Deloitte and Touche has recommended that such funding be recognized and recorded as revenue applied towards patient accounts with the legislative intent of the funding to remain intact; and

WHEREAS, the change in recognition of legislatively appropriated funding from non-operating revenue to patient revenue is for the sole purpose for the Hospital to abute the growing number of patients accounts that remain outstanding, specifically patients who have been determined unable to reimburse the Hospital for services rendered due to financial limitation; and

WHEREAS, internal Hospital collection efforts from such patients would be deemed unsuccessful and external collection means would be imprudent and impractical as such patients are without any means of stable and reliable source(s) of income and/or are on government financial assistance programs; and

WHEREAS, it is clearly understood the change in recognition of legislatively appropriated funding from non-operating revenue to patient revenue will not result in any additional revenue to the Hospital and is strictly for the employment of funding towards the Hospital's outstanding patient accounts receivable; and

WHEREAS, the Hospital shall be responsible to recommend qualified patient accounts in application of the funding as outlined in Hospital approved policy governing the execution of application of the legislatively appropriated funding; and

WHEREAS, the Hospital shall be responsible to report the application of legislatively appropriated funding towards outstanding patient accounts to both the Board of Trustees and the Guam Legislature on a quarterly basis; and

WHEREAS, the GMHA Board of Trustees accepts the recommendations of the Hospital's auditor's, Deloitte and Touche and Hospital Management to recognize legislatively appropriated funds towards qualified outstanding patient accounts and delegates the Chief Financial Officer to ensure strict compliance to the Hospital's policy governing and reporting of such application to the Board of Trustees and Guam Legislature on a quarterly basis; now therefore be it

RESOLVED, that the Hospital Administrator/CEO is directed to administer legislative appropriated funding towards qualified outstanding patient accounts as governed by Hospital approved policy with the understanding of the reporting requirements; and be it further

RESOLVED, that the Chairman certifies and the Secretary attests to the adoption of this resolution.
