AN ACT TO APPROPRIATE THE SUM OF ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000) FROM THE FISCAL YEAR 2008 TOURIST ATTRACTION FUND TO THE DEPARTMENT OF PARKS AND RECREATION FOR THE DESIGN AND CONSTRUCTION OF A MEMORIAL FOR THE LATE SENATOR ANGEL LEON GUERRERO SANTOS AT "THE SENATOR ANGEL LEON GUERRERO SANTOS LATTE STONE MEMORIAL PARK" IN HAGÅTÑA PURSUANT TO THE MANDATE OF PUBLIC LAW 27-44.

BE IT ENACTED BY THE PEOPLE OF GUAM:

1 Section 1. Legislative findings and intent.

I Liheslaturan Guåhan finds that their former and late colleague, Senator 2 Angel Leon Guerrero Santos was a hardworking and dedicated legislator; 3 genuinely pursuing and advocating for the rights of the indigenous people of 4 Guam while devoting his utmost efforts towards the preservation and 5 appreciation of the finest traditions, culture, heritage and beliefs of the 6 Chamorro people. Furthermore, the late Senator Angel Leon Guerrero Santos 7 served the island community as a Senator in I Liheslaturan Guahan and as a 8 strong advocate for the democratic ideals in government and in ensuring that 9 the government fulfills its moral obligation to assist the destitute, the 10

financially impoverished, and the socially disadvantaged members of Guam's
 society.

I Liheslaturan Guåhan further finds that the decision and mandate to memorialize the superlative deeds and accomplishments of one of Guam's public servants were incorporated in the provisions of Public Law 27-44, which required the Department of Parks and Recreation to formulate the design for the construction of a memorial monument at the Latte Stone Park in Hagåtña thus honoring the late Senator Angel Leon Guerrero Santos.

9 It is therefore the intent of *I Liheslaturan Guåhan* to implement the 10 mandate of Public Law 27-44, which requires the Department of Parks and 11 Recreation to provide the late Senator Angel Leon Guerrero Santos with the 12 appropriate tribute and memorial that properly symbolizes Senator Santos' 13 public pursuits in the preservation of the indigenous culture and language, 14 but most especially his fight for the human rights of the common person.

Section 2. Appropriation Measure and Other Requirements for the
 Establishment of the Senator Angel Leon Guerrero Santos Latte Stone
 Memorial Monument.

18a.)The sum of One Hundred Fifty Thousand Dollars19(\$150,000.00) is hereby appropriated from the Tourist20Attraction Fund from Fiscal Year 2008 to the Department of21Parks and Recreation for the design and construction of a22memorial monument honoring the late Senator Angel Leon23Guerrero Santos, including necessary landscaping and other

related improvements, i.e. lighting, fencing, etc., to be constructed at the Latte Stone Memorial Park in Hagåtña in which is named in his honor. The sum appropriated herein shall be provided to the Department within One Hundred and Eighty (180) days from the enactment of this Act.

- b.) The Director of the Department of Parks and Recreation is 6 hereby authorized to receive financial donations and any 7 other forms of contribution from any person, business, or 8 organization that will applied toward the design, construction 9 or maintenance of the Senator Angel Leon Guerrero Santos 10 Latte Stone Memorial Park monument, and its surrounding 11 The Director shall record and provide a 12 park facility. quarterly written report, if necessary, to I Maga'lahen Guahan 13 and the Speaker of I Liheslaturan Guahan on any financial 14 donations or contributions received in accordance with the 15 provisions of this Act. Said report shall include the name of 16 the contributor, value sum of the contribution, form of 17 contribution (monetary or otherwise), date of contribution, 18 and any other information that the Director would consider 19 necessary in the reporting of such donations to the 20 government of Guam. 21
- c.) The Department of Parks and Recreation, upon receipt of said
 funds or contributions, shall immediately commence work on

the design and construction of the Senator Angel Leon Guerrero Santos Latte Stone Memorial Park monument, and shall further provide I Maga'lahen Guahan and the Speaker of I Liheslaturan Guahan with periodic written reports on the progress and completion date for the construction of said monument.
