INCLUSIVE OF THE FOURTH QUARTER OF FISCAL YEAR  
2010.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Section 20 of Chapter XIII of Public Law 30-196 is amended to read as  
3 follows:

5 **“Section 20. Government Staffing Pattern.**

6 (a) Staffing Pattern. *No later than* thirty (30) days after the end of each quarter of  
7 Fiscal Year 2011, every director, administrator or head of a government of Guam  
8 agency, excluding line agencies, *shall* submit to the Speaker of *I Liheslaturan Guåhan*  
9 and post on the agency website a current staffing pattern in the format of the Executive  
10 Branch FY 2011 Budget Call, as of the previous quarter’s ending. The agencies  
11 required to submit staffing patterns are all autonomous and semi autonomous agencies,  
12 public corporations, the President of the Mayors Council of Guam, the Department of  
13 Education and the Administrator of the Courts of the Unified Judiciary. Said staffing  
14 pattern *shall* include, at a minimum, the name of every current employee and his  
15 position title, salary, increment costs and benefit costs, as well as the funding source for

1 his salary and benefits. The agencies shall also post the staffing patterns for the fourth  
2 quarter of Fiscal Year 2010.

3 (b) *No later than* thirty (30) days after the end of each quarter of Fiscal Year  
4 2011, the Director of the Department of Administration *shall* post the government wide  
5 line agency staffing pattern on the bit.guam.gov portal on the budget website. The  
6 format of the report *shall* be the current staffing pattern in the format of the Executive  
7 Branch FY 2011 Budget Call, as of the previous quarter's ending. Said staffing pattern  
8 *shall* include, at a minimum, the name of every current employee and his position title,  
9 salary, increment costs and benefit costs, as well as the funding source for his salary  
10 and benefits. The Director of the Administration shall also post the staffing patterns for  
11 the fourth quarter of Fiscal Year 2010.”
