### BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. Legislative Intent and Findings. I Liheslaturan Guåhan
- 2 finds that the property owner of Lot No. 19A-3, currently designated as
- 3 Single-Family (R-1), in the Municipality of Sinajana, wish to rezone the
- 4 property to Multiple-Family Dwelling (R-2) Zone.
