**AN ACT TO ADD SECTION 18 TO CHAPTER X OF PUBLIC  
LAW 32-068 (GENERAL APPROPRIATIONS ACT OF 2014)  
MAKING AN APPROPRIATION FROM THE TOURIST  
ATTRACTION FUND (TAF) TO GVB FOR MANHITA  
CHAMORRO.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.**

3 *I Liheslaturan Guåhan* finds that Manhita Chamorro is a non-profit  
4 Chamorro cultural organization that was founded to produce a documentary of the  
5 history of the Chamorro People. *I Liheslaturan Guåhan* further finds that a  
6 significant fundraising effort has been underway to support the production of this  
7 documentary and tremendous community support has been realized for this  
8 important project.

9 *I Liheslaturan Guåhan* further finds that revenue estimates for the Tourist  
10 Attraction Fund (TAF) for Fiscal Year 2014 are tracking at Twenty-Nine Million  
11 Eight Hundred Eighty Thousand Nine Hundred Forty-Four Dollars (**\$29,880,944**),  
12 of which Twenty-Eight Million Five Hundred Thousand Dollars (**\$28,500,000**) is  
13 appropriated.

14 *I Liheslaturan Guåhan* further finds that the TAF revenues for Fiscal Year  
15 2014 are projected to exceed appropriations by One Million Three Hundred Eighty

1 Thousand Nine Hundred Forty-Four Dollars (**\$1,380,944**) and is available for  
2 appropriation.

3 **Section 2. Section 10 of Chapter X (Guam Visitors Bureau) of Public**  
4 **Law 32-068 is amended to read:**

5 **Section 18. Appropriation to GVB for Manhita Chamorro.** The  
6 sum of Fifty Thousand Dollars (**\$50,000**) is appropriated from the  
7 TAF to the GVB for Fiscal Year 2014 to Manhita Chamorro for the  
8 production of a documentary of the history of the Chamorro People.  
9 Notwithstanding the general provisions of § 30107.1, of Chapter 30,  
10 Title 11 GCA and this Act, this appropriation *shall* continue to be  
11 available until expended. The provisions contained in Section 15 (Service  
12 and Reporting Requirements) of Chapter X of Public Law 32-068 *shall* be  
13 applicable.”

14 **Section 3. Effective Date.** The provisions contained herein shall take  
15 effect immediately upon the enactment of this Act.
