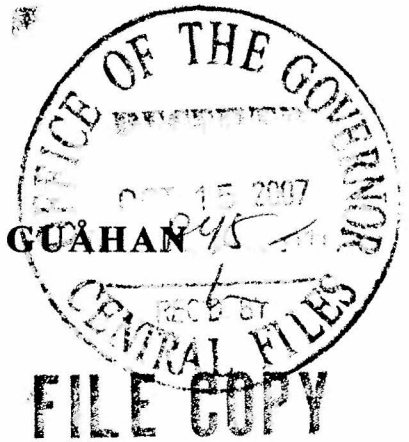

**AN ACT TO *ADD* A NEW §80127 TO CHAPTER 80, TITLE 5
GUAM CODE ANNOTATED, RELATIVE TO RESERVING
THE *HAGÅTÑA* LIBRARY PARKING LOT FOR THE
EXCLUSIVE USE BY LIBRARY EMPLOYEES AND
PATRONS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new §80127 is hereby *added* to Chapter 80 of Title 5 GCA
3 to read:

4 **“§80127. Use of *Hagåtña* Library Parking lot.** The *Hagåtña*
5 Library parking lot *shall* be reserved for parking of vehicles operated by
6 patrons and employees of the Guam Public Library System (GPLS).
7 Parking in the *Hagåtña* Library parking lot by persons other than those,

1 *supra*, shall be a violation and punishable by a fine of Twenty-five Dollars
2 (\$25) per violation.

3 The Director shall be required to maintain a roster of those persons
4 authorized to park in the *Hagåtña* Library parking lot. The form of such
5 roster shall be determined by the Board. The Director shall post a sign at
6 the entrance of the parking lot that states, 'In accordance with the provisions
7 of §80127 of Title 5 GCA, this parking lot is reserved for the exclusive use
8 of Guam Public Library patrons and employees. Patrons parking in this lot
9 shall be required to sign in and out when entering and leaving the library
10 building. Violators are subject to a fine of Twenty-five Dollars (\$25) per
11 violation.'

12 Enforcement of the provisions herein this Section shall be the
13 responsibility of the Guam Police Department; however, the Chief of Police
14 may authorize any employee(s), designated by the Director, to issue
15 citations for violation of this Section.”
