





**CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LAHEN
GUĀHAN**

This is to certify that Bill No. 218 (LS), "AN ACT TO APPROPRIATE THE SUM OF EIGHT HUNDRED THOUSAND DOLLARS (\$800,000) FROM THE GENERAL FUND TO THE DEPARTMENT OF REVENUE AND TAXATION (DRT) FOR THE PURPOSE OF FUNDING OVERTIME COSTS AND THE PURCHASE OF COMPUTER HARDWARE AND SOFTWARE IN ORDER TO SPEED UP THE REVIEW AND PROCESSING OF INCOME TAX RETURNS SO THAT DRT CAN PAY OUT FEDERAL FUNDS RECEIVED RELATIVE TO THE FEDERAL ECONOMIC STIMULUS PACKAGE IN A TIMELY MANNER," returned without approval of *I Maga'lahaen Guāhan*, was reconsidered by *I Liheslaturan Guāhan* and after such consideration, did agree, on the 25th day of April, 2008, to pass said bill notwithstanding the veto of *I Maga'lahaen Guāhan* by a vote of ten (10) Members.



AN ACT TO APPROPRIATE THE SUM OF EIGHT HUNDRED THOUSAND DOLLARS (\$800,000) FROM THE GENERAL FUND TO THE DEPARTMENT OF REVENUE AND TAXATION (DRT) FOR THE PURPOSE OF FUNDING OVERTIME COSTS AND THE PURCHASE OF COMPUTER HARDWARE AND SOFTWARE IN ORDER TO SPEED UP THE REVIEW AND PROCESSING OF INCOME TAX RETURNS SO THAT DRT CAN PAY OUT FEDERAL FUNDS RECEIVED RELATIVE TO THE FEDERAL ECONOMIC STIMULUS PACKAGE IN A TIMELY MANNER.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation.** The sum of Eight Hundred Thousand Dollars

1 (\$800,000) is appropriated from the General Fund to the Department of Revenue
2 and Taxation (DRT) in order to speed up the review and processing of income tax
3 returns so that DRT can pay out the Federal funds received relative to the Federal
4 economic stimulus package in a timely manner. The appropriation *shall* be for the
5 following purposes:

6 (a) Four Hundred Fifty Thousand Dollars (\$450,000) for the
7 purpose of paying overtime for employees processing income tax
8 returns; and

9 (b) Three Hundred Fifty Thousand Dollars (\$350,000) for the
10 purpose of purchasing computer hardware and software.
