AN ACT TO AUTHORIZE *I MAGA'LAHEN GUÅHAN* TO PLEDGE COMPACT IMPACT FUNDS FOR THE CONSTRUCTION COSTS OF A NEW LANDFILL.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that pursuant to an Order of the District Court to finance the construction of a new landfill, *I Maga'lahi* has announced plans to delay payment of the prior year's tax refunds, including the EITC and the COLA award to retirees until the new landfill is constructed. It is the intent of *I Liheslatura* to prevent any further delay in payment of the long overdue COLA award to retirees by providing a source of funding for the landfill, which would *not* encumber general fund revenues already
 prioritized for payment of these other obligations of equal *or* greater priority.

Section 2. Authorization for Pledge of Compact Impact Funds for
Construction of Landfill. Notwithstanding any provision of law, *I Liheslaturan Guåhan* hereby authorizes the pledge of all remaining unencumbered *or* unpledged
current *or* future Compact Impact funds for the costs of construction and financing
of a new landfill.

8 Section 3. Severability. *If* any of the provisions of this Act or the 9 application thereof to any person or circumstance is held invalid, such invalidity 10 shall *not* affect any other provision or application of this Act which can be given 11 effect without the invalid provision or application, and to this end the provisions of 12 this Act are severable.
