
CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LAHEN GUÅHAN



**AN ACT TO APPROPRIATE FUNDS TO THE MAYORS
COUNCIL OF GUAM FROM THE GUAM HIGHWAY FUND
FOR VILLAGE STREETS MAINTENANCE AND
BEAUTIFICATION.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Notwithstanding any other provision of law, the sum of One
3 Million Eight Hundred Twenty-one Thousand Twenty-four Dollars (**\$1,821,024**) is
4 appropriated from the FY 2009 Guam Highway Fund revenues to the Village Streets
5 Fund for the Mayors Council of Guam, for the maintenance and beautification of

1 village secondary and tertiary roads, including the hiring of personnel *specifically* for
2 village streets maintenance and beautification; and for Mayoral Employees Separation
3 Pay. Said funds shall *not* be subject to any transfer authority of *I Maga'lahen Guåhan*
4 and *shall* be divided among the Village Mayors as follows:

5 (a) Each Mayor *shall* receive the sum of Twenty Thousand Dollars
6 **(\$20,000)**; and

7 (b) The remaining balance of the fund *shall* be distributed to each
8 Mayor *pro rata* based on the total road mileage in his village as a
9 percentage of Guam's total road mileage in the 2006 Guam Roads
10 Pavement Inventory of the Department of Public Works.

11 The appropriation made in this Section *shall* be available to the Mayors Council
12 of Guam until fully expended, for the purposes contained in this Section.

13 **Section 2.** Notwithstanding any other provision of law, the sum of Two
14 Hundred Fifty Thousand Dollars **(\$250,000)** is appropriated from the FY 2009 Guam
15 Highway Fund revenues to *I Liheslatura* for its operations.
