





**AN ACT TO *ADD* A NEW CHAPTER 12 TO TITLE 17,  
GUAM CODE ANNOTATED, RELATIVE TO  
AUTHORIZING GUAM ACADEMY CHARTER  
SCHOOLS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new Chapter 12 is *added* to Title 17, Guam Code Annotated,  
3 to read as follows:

4 **“CHAPTER 12**

5 **GUAM ACADEMY CHARTER SCHOOLS ACT OF 2009**

1           **§12101. Short Title.** This Chapter *shall* be known and may be cited as the  
2 “Guam Academy Charter School Act of 2009”.

3           **§12102. Purpose.** The Guam Academy Charter School Act of 2009 is  
4 enacted to provide opportunities for teachers, parents, guardians, students and  
5 community members to establish and maintain schools that operate independently  
6 from the Guam Public School System as a method to:

7           (a) improve student learning;

8           (b) increase learning opportunities for all students, with special  
9 emphasis on expanded learning experiences;

10          (c) encourage the use of different and innovative teaching methods;

11          (d) create new professional opportunities for teachers, including the  
12 opportunity to be responsible for the learning program at the school site;

13          (e) provide parents, guardians and students with expanded choices  
14 in the types of educational opportunities that are available within the public  
15 school system; and

16          (f) hold the schools established under this Chapter accountable for  
17 meeting measurable student educational standards.

18           **§12103. Definitions.**

19           (a) *Board* means the Guam Education Policy Board;

20           (b) *Academy Charter School* means schools acknowledged as  
21 Charter Schools by the Guam Academy Charter Schools Council under  
22 Chapter 12 of Title 17 GCA;

23           (c) *Chamorro Language Immersion Program* is a method of  
24 teaching the *Chamorro* language. Using the *Chamorro* language as the  
25 teaching tool, surrounding *or* immersing students in the *Chamorro* language  
26 in class activities such as math, science, social studies, history, and other  
27 class subjects.

1 (d) *Council* means the authorizing chartering entity known as the  
2 Guam Academy Charter Schools Council.

3 (e) *Eligible applicant* means an individual, a group of individuals,  
4 teachers, parents, guardians or a non-profit organization authorized under the  
5 laws of Guam to do business; and

6 (f) *Trustees* means the Board of Trustees, the governing structure  
7 of an Academy Charter School as set forth in the Academy's Charter.

8 **§12104. Process for Filing Charter Petitions.** (a) Existing public school.  
9 An eligible applicant seeking to convert a public school into an Academy Charter  
10 School:

11 (1) *shall* prepare a petition to establish an Academy Charter School  
12 that meets the requirements of §12105 of this Chapter;

13 (2) *shall* provide a copy of the petition to:

14 (A) the parents and guardians of minor students attending the  
15 existing public school;

16 (B) adult students attending the existing public school;

17 (C) employees of the existing public school;

18 (D) parents and guardians of minor students who attend the  
19 school grade immediately lower than the first school grade  
20 which is served by the public school which is the subject of the  
21 conversion petition; and

22 (E) each Mayor which represents an area within the  
23 attendance area of the public school which is the subject of the  
24 conversion petition; and

25 (3) *shall* file the petition with the Council for approval after the  
26 petition:

1 (A) is signed by *not less than* sixty percent (60%) of the sum  
2 of:

3 (i) the total number of parents and guardians of minor  
4 students attending the public school; and

5 (ii) the total number of adult students attending the  
6 public school; and

7 (iii) the total number of full-time teachers currently  
8 assigned to the public school.

9 (B) New School. An eligible applicant seeking to establish an  
10 Academy Charter School, but *not* converting an existing public  
11 school, *shall* file with the Council for approval a petition to establish  
12 an Academy Charter School that meets the requirements of §12105 of  
13 this Chapter.

14 (C) Limitations on multiple petitions. An eligible applicant  
15 may *not* file *more than* one (1) petition to establish an Academy  
16 Charter School during a calendar year.

17 (D) A petition to establish an Academy Charter School, *or* to  
18 convert a public school, is a public document.

19 **§12105. Contents of Petition.** A petition under §12104 of this Chapter to  
20 establish an Academy Charter School *shall* include the following:

21 (a) a statement defining the mission and goals of the proposed  
22 Academy Charter School and the manner in which the Academy Charter  
23 School will conduct any district-wide assessments required by the Guam  
24 Public School System;

25 (b) a statement of the need for the proposed Academy Charter  
26 School;

1 (c) a description of the proposed instructional goals and methods  
2 for the proposed Academy Charter School, which *shall* include, at a  
3 minimum:

4 (1) the area of focus of the proposed Academy Charter  
5 School, such as mathematics, science, the fine arts, language,  
6 technology, agriculture, vocational training, *Chamorro* language  
7 immersion program, high school academy, information technology *or*  
8 criminal justice, *if* the Academy Charter School will have such a  
9 focus;

10 (2) the methods that will be used, including classroom  
11 technology, to provide students with the knowledge, proficiency, and  
12 skills needed:

13 (A) to become nationally and internationally  
14 competitive students and educated individuals in the Twenty-  
15 first (21<sup>st</sup>) century; and

16 (B) to perform competitively on any district-wide  
17 assessments; and

18 (3) the methods that will be used to improve student self-  
19 motivation, classroom instruction, and learning for all students;

20 (d) a description of the scope and size of the proposed Academy  
21 Charter School's program that will enable students to successfully achieve  
22 the goals established by the Academy Charter School, including, the grade  
23 levels to be served by the Academy Charter School and the projected and  
24 maximum enrollment of each grade level;

25 (e) a description of the plan for evaluating student academic  
26 achievement at the proposed Academy Charter School and the procedures  
27 for remedial action that will be used by the Academy Charter School when

1 the academic achievement of a student falls below the expectations of the  
2 Academy Charter School;

3 (f) an operating budget for the first two (2) years of the proposed  
4 Academy Charter School that is based on anticipated enrollment;

5 (g) a description of the proposed rules and policies for governance  
6 and operation of the proposed Academy Charter School;

7 (h) a description of the method for conducting annual audits of the  
8 financial, administrative, and programmatic operations of the proposed  
9 Academy Charter School;

10 (i) an identification of a facility for the proposed Academy Charter  
11 School, including a description of the site where the school will be located;

12 (j) the names and addresses of the members of the proposed  
13 interim Board of Trustees and the procedures for selecting trustees;

14 (k) a description of the student enrollment, admission process,  
15 suspension, expulsion, and other disciplinary policies and procedures of the  
16 proposed Academy Charter School, and the criteria for making decisions in  
17 such areas;

18 (l) a description of the procedures the proposed Academy Charter  
19 School plans to follow to ensure the health and safety of students,  
20 employees, and guests of the school and to comply with applicable health  
21 and safety laws, and all applicable civil rights statutes and regulations of the  
22 Federal Government and the government of Guam;

23 (m) an explanation of the qualifications that will be required of  
24 employees of the proposed Academy Charter School;

25 (n) a description of how parents, guardians, teachers, and other  
26 members of the community have been involved in the design and will



1 continue to be involved in the implementation of the proposed Academy  
2 Charter School;

3 (o) a description of how parents, guardians, teachers and staff will  
4 be provided an orientation and other training to ensure their effective  
5 participation in the operation of the proposed Academy Charter School;

6 (p) an assurance the proposed Academy Charter School will seek,  
7 obtain, and maintain accreditation from an accrediting body deemed  
8 appropriate by the Council;

9 (q) an explanation of the relationship that will exist between the  
10 Academy Charter School and the school's employees; and

11 (r) a description of how the proposed Academy Charter School  
12 plans to meet the transportation and food service needs of its students; and

13 (s) a description of the facilities the Academy Charter School plans  
14 to use.

15 **§12106. Process for Approving *or* Denying Charter School Petitions.**

16 (a) Schedule. An eligible applicant seeking to establish an  
17 Academy Charter School *shall* submit a petition pursuant to §12105 of this  
18 Chapter to the Council *no later than* the first Monday of January. However,  
19 it is recommended that an eligible applicant consult with the Council prior to  
20 submitting the petition. All petitions submitted *no later than* the first  
21 Monday in January *shall* be for the following school year.

22 (b) Public Hearing. *Not later than* forty-five (45) days after a  
23 petition to establish an Academy Charter School is filed with the Council,  
24 the Council *shall* hold a public hearing on the petition to gather the  
25 information that is necessary for the Council to make the decision to approve  
26 *or* deny the petition.

1 (c) Notice. Ten (10) days before the scheduled time of the public  
2 hearing on a petition to establish an Academy Charter School, the Council  
3 *shall*:

4 (1) send a written notification of the public hearing to the  
5 eligible applicant;

6 (2) post notice of the public hearing at a place convenient to  
7 the public in the administrative office, cafeteria, and the  
8 classrooms of the public school which is subject to be converted  
9 into an Academy Charter School;

10 (3) post notice of the public hearing at a place convenient to  
11 the public in the administrative office, cafeteria and the  
12 classrooms of the public school which is school grade lower than  
13 the first school grade which is served by the public school which  
14 is subject to conversion; and

15 (4) post notice of the public hearing at a place convenient to  
16 the public in the Mayor's office which represents an area within  
17 the attendance area of the public school which is the subject of the  
18 conversion petition.

19 (d) The Council *shall* approve a petition to establish an Academy  
20 Charter School, *if*:

21 (1) the Council determines that the petition satisfies the  
22 requirements of this Chapter;

23 (2) the eligible applicant who filed the petition agrees to  
24 satisfy any condition *or* requirement, consistent with this Chapter and  
25 other applicable law that is set forth in writing by the Council as an  
26 amendment to the petition;

1 (3) the Council determines that the Academy Charter School  
2 has the ability to meet the educational objectives outlined in the  
3 petition; and

4 (4) the approval will *not* cause the Council to *exceed* a limit  
5 under subsection (g) of this Section.

6 (e) The Council *shall* approve *or* deny a petition to establish an  
7 Academy Charter School *not later than* thirty (30) days after the conclusion  
8 of the public hearing on the petition.

9 (f) Denial explanation. Written notice of the council's action *shall*  
10 be sent to the eligible applicant. *If* the petition is *not* approved, the reasons  
11 for the denial and suggested remedial measures, *if any, shall* be clearly stated  
12 in the notice sent by the council to the eligible applicant. *If* the petition is  
13 *not* approved, the eligible applicant may amend the petition to address  
14 objections and any suggested remedial measures and resubmit the petition to  
15 the Council. The Council *shall* approve *or* disapprove the resubmitted  
16 petition within twenty (20) days after receiving it. *If* the petition is *not*  
17 approved, the eligible applicant *may* appeal the decision of the Council to the  
18 Board.

19 (g) The total number of Academy Charter Schools operating on  
20 Guam under this Chapter at any one time *shall not exceed* seven (7). At  
21 least two (2) Academy Charter School *shall* be an elementary school. At  
22 least one (1) *shall* be a middle school. At least one (1) high school. *No*  
23 *more than* three (3) non-converted public schools *shall* be authorized.

24 **§12107. Duties and Powers, and other Requirements, of Charter**  
25 **Schools.**

26 (a) An Academy Charter School *shall* comply with all of the terms  
27 and provisions of its Charter.

1           (b) An Academy Charter School *shall* be subject to all federal and  
2 state laws and constitutional provisions prohibiting discrimination on the  
3 basis of disability, race creed, color, gender, national origin, religion,  
4 ancestry *or* need for special education services.

5           (c) Each power conferred upon an Academy Charter School under  
6 this Chapter can only be used for the *sole* purpose of operating the Academy  
7 Charter School. An Academy Charter school *shall* have the following  
8 powers:

9                   (1) to adopt a name and corporate seal, but only *if* the name  
10 selected includes the words ‘Academy Charter School’;

11                   (2) to acquire real property for use as the Academy Charter  
12 School's facilities, from public *or* private sources, but Academy  
13 Charter Schools *shall not* have the power to acquire property by  
14 eminent domain;

15                   (3) to receive and disburse funds for Academy Charter  
16 School purposes;

17                   (4) to secure appropriate insurance and to make contracts  
18 and leases, including agreements to procure *or* purchase services,  
19 equipment, and supplies;

20                   (5) to incur debt in reasonable anticipation of the receipt of  
21 funds from the general fund of the government of Guam *or* the receipt  
22 of Federal or private funds;

23                   (6) to solicit and accept any grants *or* gifts for the Academy  
24 Charter School’s purposes, *if the Academy Charter School:*

25                           (A) *Does not* accept any grants *or* gifts subject to any  
26 condition contrary to law *or* contrary to its Charter; and

1 (B) Maintains, for financial reporting purposes,  
2 separate accounts for grants *or* gifts;

3 (7) to be responsible for the Academy Charter School's  
4 operation, including preparation of a budget and personnel matters;  
5 and

6 (8) to sue and be sued in the Academy Charter School's own  
7 name.

8 (d) An Academy Charter School *shall not* charge an application fee  
9 and tuition.

10 (e) An Academy Charter School *may* impose reasonable fees or  
11 otherwise require payment, at rates established by the Trustees of the school,  
12 for any field trips *or* similar activities *not* funded in whole *or* part through  
13 appropriation by *I Liheslaturan Guåhan*.

14 (f) An Academy Charter School *shall* exercise exclusive control  
15 over its expenditures, administration, personnel, and instructional methods,  
16 within the limitations imposed in this Chapter.

17 (g) An Academy Charter School *shall* be *exempt* from Guam  
18 statutes, policies, rules, regulations, and collective bargaining agreements  
19 established for the Guam public schools, *except* as otherwise provided in the  
20 Academy's Charter *or* this Chapter.

21 (h) An Academy Charter School *shall* comply with all federal and  
22 Guam health and safety requirements applicable to public schools.

23 (i) An Academy Charter School *shall* be governed by the Trustees  
24 in a manner consistent with the Charter granted to the school and the  
25 provisions of this Chapter.

1           (j) *No* employee of the Guam Public School System *shall* be  
2 required to accept employment with, *or* be assigned to, an Academy Charter  
3 School.

4           (k) *No* student enrolled in a public school *shall* be required to  
5 attend an Academy Charter School;

6           (l) An Academy Charter School *shall not* levy taxes *or* issue  
7 bonds.

8           (m) An Academy Charter School seeking to revise its Charter *shall*  
9 prepare a petition for approval of the revision and file the petition with the  
10 Council. The provisions of §12105 of this Chapter *shall* apply to such a  
11 petition in the same manner as such provisions apply to a petition to  
12 establish an Academy Charter School.

13           (n) An Academy Charter School *shall* submit an annual report *no*  
14 *later than* thirty (30) days after the end of the fiscal year to the Council, the  
15 Superintendent of Education, and the Board. The Academy Charter School  
16 *shall* permit the public to review any such report upon request. A report  
17 *shall* include the following data:

18                   (1) a report on the extent to which the school is meeting its  
19 mission and goals as stated in the petition for the Academy Charter  
20 School;

21                   (2) student performance on any district-wide assessments;

22                   (3) grade advancement for students enrolled in the Academy  
23 Charter School;

24                   (4) graduation rates, college admission test scores, and  
25 college admission rates, *if* applicable;

26                   (5) types and amounts of parental involvement;

27                   (6) official student enrollment;

1 (7) average daily attendance;

2 (8) annual financial audit and subsequent fiscal year annual  
3 financial audits, a financial statement audited by the Public Auditor;

4 (9) a report on school staff indicating the qualifications and  
5 responsibilities of such staff; and

6 (10) a list of all donors and grantors that have contributed  
7 monetary *or* in-kind donations having a value equal to *or exceeding*  
8 Five Hundred Dollars (\$500) during the year that is the subject of the  
9 report.

10 (A) Data described in items (1) through (8) of this  
11 subsection *shall not* identify the individuals to whom the data  
12 pertain.

13 (n) An Academy Charter School *shall* provide to the Guam Public  
14 School System student enrollment data.

15 (o) An Academy Charter School *shall* establish a formal complaint  
16 resolution process.

17 (p) An Academy Charter School *shall* provide a program of  
18 education, which *shall* include any grade *or* grades from kindergarten  
19 through grade twelve (12).

20 (q) An Academy Charter School *shall* be nonsectarian and *shall not*  
21 be affiliated with a sectarian school *or* religious institution.

22 (r) An Academy Charter School *shall not* be home based.

23 (s) An Academy Charter School *shall not* be converted from any  
24 existing private *or* parochial school.

25 (t) An Academy Charter School *shall* initiate the process for  
26 accreditation within the first one hundred twenty (120) days of  
27 opening and attain accreditation within five (5) years of opening.

1 (u) An Academy Charter School *shall not* hire a for-profit  
2 management company to operate the school.

3 (v) An Academy Charter School *shall* provide instruction each year  
4 for at least the same number of days required of the Guam Public  
5 School System.

6 (w) An Academy Charter School, and its incorporators, Trustees,  
7 officers, employees, and volunteers, *shall* be immune from civil  
8 liability, both personally and professionally, for any act *or* omission  
9 within the scope of their official duties unless the act *or* omission:

10 (1) constitutes gross negligence;

11 (2) constitutes an intentional tort; *or*

12 (3) is criminal in nature.

13 (x) Upon termination of the Charter, all assets of the Academy  
14 Charter School *shall* revert to the Guam Public School System.

15 **§12108. Board of Trustees of a Charter School.** (a) There is established  
16 the Board of Trustees. The Trustees of an Academy Charter School *shall* be  
17 elected *or* selected pursuant to the Charter granted to the Academy Charter School.  
18 The Board of Trustees *shall* consist of *not less than* five (5) members and *not more*  
19 *than* nine (9) members. At least one (1) member *shall* be parent *or* guardian of a  
20 student attending the Academy Charter School. At least one (1) member *shall* be  
21 from the general public with an accounting *or* finance background. The Principal  
22 of the Academy Charter School *shall* be a non-voting member.

23 (b) In the case of the first Trustees of an Academy Charter School to be  
24 elected *or* selected after the date on which the school is granted a Charter, the  
25 election *or* selection of the members under subsection (a) of this Section *shall*  
26 occur on the earliest practicable date after classes at the school have commenced.  
27 Until such date, any other members who have been elected *or* selected *shall* serve



1 as interim Trustees. Such an interim Board of Trustees may exercise all of the  
2 powers, and *shall* be subject to all of the duties, of a Board of Trustees.

3 (c) The Trustees of an Academy Charter School *shall* be fiduciaries of the  
4 school and *shall* set overall policy for the school. The Trustees *may* make final  
5 decisions on matters related to the operation of the school, consistent with the  
6 Charter granted to the school, this Chapter, and other applicable law.

7 (d) Meetings held by the Board of Trustees *shall* be in compliance with  
8 the Open Government Law of Guam.

9 **§12109. Academy Charter Schools; Admission Requirements.** (a) An  
10 Academy Charter School *shall* enroll all students who submit a timely application,  
11 unless the number of applications exceeds the capacity of a program, class, grade  
12 level *or* building. An Academy Charter School *shall* give enrollment preference to  
13 students returning to the Academy Charter School in the second *or* any subsequent  
14 year of its operation and to siblings of students already enrolled in the Academy  
15 Charter School. *If* capacity is insufficient to enroll all students who submit a  
16 timely application, the Academy Charter School *shall* select students through an  
17 equitable selection process such as a lottery. A public school converted to an  
18 Academy Charter school *shall* give enrollment preference to students attending the  
19 public school prior to conversion and students who reside within the former  
20 attendance zone of that converted public school.

21 (b) *Except* as provided in subsection (c), an Academy Charter School  
22 *shall not* limit admission based on ethnicity, national origin, gender, income level,  
23 disabling condition, proficiency in the English language *or* athletic ability.

24 (c) An Academy Charter School *may* limit admission to students within a  
25 given age group *or* grade level.

1 (d) An Academy Charter School *may* refuse to admit any student who has  
2 been expelled from another educational institution *or* who is in the process of  
3 being expelled from another educational institution.

4 (e) For schools preparing students for specific professions, admissions  
5 may be limited to students who meet Bona Fide Occupational Qualifications  
6 (BFOQ) selection criteria for the profession. *If* the profession exists in an  
7 equivalent government position, the admissions criteria may be based on the  
8 government of Guam's employment selection criteria.

9 **§12110. Employees.**

10 (a) An employee of an Academy Charter School who transferred  
11 from the Guam Public School System *shall* be considered to be on three (3)  
12 years leave of absence from the Guam Public School System. The leave of  
13 absence *shall* commence on the initial date of employment at the Charter  
14 School. Upon request of the employee, the three (3) years leave of absence  
15 *shall* be renewed for up to two (2) additional one (1)-year periods, absent  
16 good cause.

17 (b) The time during which an employee is on a leave of absence  
18 *shall* be counted for service credit on the Guam Public School System's  
19 salary schedule.

20 (c) During the period of time that an employee is on a leave of  
21 absence from the Guam Public School System and is actively employed by  
22 the Charter School, the Academy Charter School as the employer *shall*  
23 continue the retirement *or* other benefits previously granted to the employee  
24 make applicable retirement contributions.

25 (d) A leave of absence *shall not* be considered a break in service  
26 with the Guam Public School System with which and employee was  
27 previously employed.

1 (e) An employee who is on leave of absence and actively teaching  
2 at an Academy Charter School and who submits a notice of intent to return  
3 to a public school in which the employee was employed immediately prior  
4 to employment in the Charter School *shall* be given employment  
5 preference by the Guam Public School System *if*:

6 (1) the employee's notice of intent to return is submitted to  
7 the Guam Public School System within three (3) years after ceasing  
8 employment with the Guam Public School System; and

9 (2) *if* the employee is a teacher, a position for which the  
10 teacher is certified *or* is qualified to become certified is available. *If*  
11 the employee is *not* a teacher, a position for which the employee is  
12 qualified is available.

13 (f) An employee who is on leave of absence and employed by an  
14 Academy Charter school and is discharged *or* terminated for just cause by  
15 the Academy Charter School may be considered discharged *or* terminated by  
16 the Guam Public School System.

17 **§12111. Guam Academy Charter Schools Council; Membership;**  
18 **Terms; Compensation.**

19 (a) There is established the Guam Academy Charter Schools  
20 Council. The Council *shall* consist of seven (7) voting members and one  
21 non-voting member and *shall* include:

22 (1) one (1) retired teacher;

23 (2) one (1) retired school administrator;

24 (3) two (2) members with accounting *or* finance  
25 background;

26 (4) three (3) members from the general public; and

1 (5) the Superintendent of Education *or* the Superintendent's  
2 designee who *shall* be a non-voting member.

3 (b) The voting members *shall* be appointed by *I Maga'lahren*  
4 *Guåhan*, subject to confirmation by *I Liheslatura*. The voting members *shall*  
5 serve a term of three (3) years.

6 (c) The Council *shall* each year elect a chairman and other officers  
7 as it deems necessary from among its membership.

8 (d) Members of the Council are *not* eligible to receive  
9 compensation, *except* that they *shall* be paid Fifty Dollars (\$50) per meeting,  
10 *not to exceed* One Hundred Fifty Dollars (\$150) per month.

11 (e) Clerical and administrative support *shall* be provided by the  
12 Guam Public School System.

13 **§12112. Powers and Duties of the Guam Academy Charter School**  
14 **Council.**

15 (a) The Council:

16 (1) *may* grant Academy School Charter status to qualifying  
17 applicants pursuant to this Chapter;

18 (2) *shall* monitor the operations of each Academy Charter  
19 School;

20 (3) *shall* ensure that each such Academy Charter School  
21 complies with applicable laws and the provisions of the charter  
22 granted to such school;

23 (4) *shall* monitor the progress of each school in meeting  
24 student academic achievement expectations specified in the charter  
25 granted to such Academy Charter School; and

1                   (5) *shall* ensure that each Academy Charter School complies  
2 with the annual reporting requirements, including, submission of the  
3 audited financial statement.

4                   (b) The Council *may* require an Academy Charter School to  
5 produce any book, record, paper, *or* document, *if* the Council determines that  
6 such production is necessary for the Council to carry out its functions under  
7 this Chapter.

8                   (c) The Council *shall* charge an eligible applicant *or* an Academy  
9 Charter School a non-refundable application *or* renewal fee of Five Hundred  
10 Dollars (\$500). All such application *or* renewal fees *shall* be deposited to  
11 the Guam Academy Charter School Fund.

12                   (d) The Council *shall* be immune from civil liability, both  
13 personally and professionally, for any act *or* omission within the scope of  
14 their official duties unless the act *or* omission:

- 15                               (1) constitutes gross negligence;  
16                               (2) constitutes an intentional tort; or  
17                               (3) is criminal in nature.

18                   (e) Meetings held by the Council *shall* be in compliance with the  
19 Open Government Law of Guam.

20 **§12113. Academy Charter School Initial Term and Renewal.**

21                   (a) A Charter granted to an Academy Charter School *shall* remain  
22 in force for a five (5) year period.

23                   (b) A Charter *may* be renewed an unlimited number of times, each  
24 time for a five (5) year period.

25                   (c) The Council *shall* review a Charter at least once every year to  
26 determine whether the Charter should be revoked for the reasons described

1 in §12115 of this Chapter in accordance with the procedures for revocation  
2 established under §12115 of this Chapter.

3 (d) In the case of an Academy Charter School that desires to renew  
4 its charter, the Trustees of the school *shall* file an application to renew the  
5 charter with the Council *not later than* one hundred twenty (120) days *nor*  
6 earlier than three hundred sixty-five (365) days before the expiration of the  
7 charter. The application *shall* contain the following:

8 (1) a report on the progress of the Academy Charter School  
9 in achieving the goals, student academic achievement expectations,  
10 and other terms of the approved Charter; and

11 (2) all audited financial statements for the Academy Charter  
12 School for the preceding four (4) years, *if* applicable.

13 (e) The Council *shall* approve an application to renew the Charter  
14 that is filed in accordance with subsection (b) of this Section, *except* that the  
15 Council *shall not* approve such application *if* the Council determines that:

16 (1) the Academy Charter School committed a material  
17 violation of applicable laws *or* a material violation of the conditions,  
18 terms, standards, *or* procedures set forth in its Charter, including  
19 violations relating to the education of children with disabilities; or

20 (2) the Academy Charter School failed to meet the goals and  
21 student academic achievement expectations set forth in its Charter.

22 (f) In an application to renew a Charter filed by the Trustees in  
23 accordance with this Chapter, the Council *shall* provide written notice to the  
24 Trustees of the public hearing on the application *not later than* fifteen (15)  
25 days after the date on which the Council received the application.

26 (g) *Not later than* thirty (30) days after the date on which the  
27 Trustees receive a notice under subsection (e) of this Section, the Trustees

1 may request, in writing, a public hearing on the application before the  
2 Council.

3 (h) Upon receiving a timely written request for a public hearing  
4 under subsection (f) of this Section, the Council *shall* set a date and time for  
5 the public hearing and *shall* provide notice of the date and time, as well as  
6 the procedures to be followed at the public hearing, to the Trustees.

7 (i) A public hearing under this subsection *shall* take place *not later*  
8 *than* thirty (30) days after the Council receives a timely written request for  
9 the public hearing under subsection (f) of this Section.

10 (j) The Council *shall* render a final decision, in writing, on an  
11 application to renew a Charter *not later than* thirty (30) days after the date  
12 on which the public hearing is concluded.

13 (k) A decision *not* to renew the Charter of an Academy Charter  
14 School *may* be appealed to the Board as described by §12115 of this  
15 Chapter.

16 **§12114. Basis and Procedures for Academy Charter School Probation**  
17 **or Revocation.**

18 (a) The Council may place an Academy Charter School on  
19 probation *or* revoke the Academy Charter School's Charter *if* the Council  
20 determines that the Academy Charter School:

21 (1) committed a violation of applicable law *or* material  
22 violation of the conditions, terms, standards, *or* procedures set forth in  
23 the Charter, including violations relating to the education of children  
24 with disabilities;

25 (2) has failed to meet the goals and student academic  
26 achievement expectations set forth in the Charter;

1           (3) has engaged in a pattern of non-adherence to generally  
2 accepted accounting principles;

3           (4) has engaged in a pattern of fiscal mismanagement; *or*

4           (5) is *no* longer economically viable.

5 (b) Procedures for consideration of probation *or* revocation:

6           (1) The Council *shall* provide to the Trustees a written notice  
7 stating the reasons for the probation of the Academy Charter School  
8 *or* the revocation of the Academy Charter School's Charter. The  
9 notice *shall* inform the Trustees of the right to have a public hearing.

10           (2) *Not later than* fifteen (15) days after the date on which  
11 the Trustees receives a notice under (b)(1) of this Section, the Trustees  
12 may request, in writing, a public hearing on the probation of the  
13 Charter School *or* the revocation of the Academy Charter School's  
14 Charter before the Council.

15           (3) Upon receiving a timely written request for a public  
16 hearing under this Section, the Council *shall* set a date and time for  
17 the public hearing and *shall* provide reasonable notice of the date and  
18 time, as well as the procedures to be followed at the public hearing, to  
19 the Trustees.

20           (4) A public hearing under this Section *shall* take place *not*  
21 *later than* thirty (30) days upon written request for a public hearing  
22 under this subsection.

23 (c) The Council *shall* render a final decision *no later than* thirty  
24 (30) days after the conclusion of the public hearing. The vote of two-thirds  
25 (2/3) of all the members of the Council *shall* be required to revoke the  
26 Charter.



1 (d) The Council *may* place an Academy Charter School on  
2 probation, rather than revoke its Charter, in order to allow for the  
3 implementation of a remedial plan approved by the Council. *If* after ninety  
4 (90) days, *or* such longer period as the Council may specify, said plan is  
5 unsuccessful in remedying the problem *or* alleviating the causes of the  
6 probation, the Council *shall* revoke the Charter.

7 (e) *If* the Council revokes a charter granted to an Academy Charter  
8 School, the Guam Public School System shall manage the Academy Charter  
9 School directly until alternative arrangements can be made for students at  
10 the Academy Charter School.

11 (f) *If* the Academy Charter's School Charter is revoked, the  
12 Trustees *may* appeal the decision of the Council to the Board.

13 **§12115. Appeal Process.** (a) The Board, upon receipt of a notice of appeal,  
14 *shall* review the decision of the Council.

15 (b) An eligible applicant *or* the Trustees of an Academy Charter School  
16 that wishes to appeal a decision of the Council concerning the denial, nonrenewal  
17 *or* revocation of an Academy Charter School *shall* provide the Board with a notice  
18 of appeal within thirty (30) days after the Council's decision. The eligible  
19 applicant *or* Trustees of the Charter School bringing the appeal *shall* limit the  
20 grounds of the appeal to the grounds for denial, nonrenewal *or* revocation specified  
21 by the Council. The notice *shall* include a brief statement of the reasons the  
22 eligible applicant *or* Trustees contends the Council's decision was in error. Within  
23 thirty days (30) after receipt of the notice of appeal, the Board *shall* hold a public  
24 hearing that may be held in the school district in which the proposed Academy  
25 Charter School has applied for *or* at the current location of the Academy Charter  
26 School. The Board *shall* review the decision of the Council and make its findings  
27 within ten (10) days after the completion of the public hearing. *If* the Board finds

1 that the Council's decision was contrary to the best interests of the students, *or*  
2 community, the Board *shall* reverse the decision of the Council. The decision of  
3 the Board *shall* be final and *not* subject to appeal.

4 **§12116. Funding.** (a) The Trustees, in consultation with teachers and  
5 administrators, *shall* determine the school's curriculum and develop the school's  
6 annual budget. The Trustees of each Charter School *shall* submit to the Council a  
7 copy of its budget for each fiscal year.

8 (b) The Council *shall* submit on a timely basis as required by the Board,  
9 the budgets of an Academy Charter Schools to the Superintendent of Education.  
10 The Superintendent of Education *shall* submit the budgets to the Board for  
11 approval as part of the Guam Public School System Fiscal Year Budget.

12 (c) Following the appropriation of the Guam Public School System's  
13 operating budget for the fiscal year, the amount approved by *I Liheslatura* for the  
14 operation of each Academy Charter School *shall* be available for expenditure by  
15 the Trustees of such Charter School for any lawful purpose without further  
16 approval by the Superintendent of Education *or* the Board. In no case *shall* an  
17 Academy Charter School expend *or* incur obligations in excess of its budget  
18 request; provided, however, that a Academy Charter School *shall* be authorized to  
19 spend federal grants and other funds received independent of the Guam Public  
20 School System *not* accounted for in said Charter School's budget request without  
21 prior approval from the Superintendent of Education *or* the Board.

22 (d) Notwithstanding any other provision of this Chapter, *no* capital  
23 improvement funds *shall* be awarded to a non-converted public school for the  
24 purpose of constructing, reconstructing *or* improving said school.

25 (e) Academy Charter Schools *shall* be funded as follows: the Charter  
26 School *shall* receive a tuition amount from the General Fund equal to the number  
27 of students enrolled at the Charter School for the upcoming school year, multiplied

1 by the per pupil cost. The Department of Administration is hereby authorized and  
2 directed to deduct said Charter School tuition amount from the total General Fund  
3 appropriation to the Guam Public School System. Specific to the Charter, any  
4 reimbursement for special education *or* bilingual education costs between the  
5 Guam Public School System and the Academy Charter School *shall* follow such  
6 formula and mechanisms adopted in the Academy’s Charter.

7 (f) A public school that converts into an Academy Charter School *shall*  
8 retain the identical school budget appropriated prior to its conversion to the  
9 following school year.

10 **§12117. Transportation.** Students attending an Academy Charter School  
11 *shall* be provided transportation to the Charter School by the Department of Public  
12 Works on the same terms and conditions as transportation is provided to children  
13 attending other public schools. In providing such transportation, the Department of  
14 Public Works *shall* accommodate the particular school day and school year of the  
15 Charter School; provided, however, that in the event that the Department of Public  
16 Works limits transportation for public school students, the Department of Public  
17 Works *shall not* be required to provide transportation to any Academy Charter  
18 School beyond said limitations.

19 **§12118. Academic Credits; Transfer.** *If* a student who was previously  
20 enrolled in an Academy Charter School enrolls in a public school, the public  
21 school *shall* accept credits earned by the student in courses *or* instructional  
22 programs at the Academy Charter School in a uniform and consistent manner and  
23 according to the same criteria that are used to accept academic credits from other  
24 public schools.

25 **§12119. Guam Academy Charter School Fund.** There is hereby created,  
26 separate and apart from other funds of the government of Guam, a fund known as  
27 the ‘Guam Academy Charter School Fund (Fund).’ The Fund *shall not* be

1 commingled with any other fund, and *shall* be kept in a separate bank account and  
2 administered by the Guam Academy Charter School Council for the operations of  
3 the Guam Academy Charter School. Expenditures from the Fund *shall* be reported  
4 quarterly to *I Liheslaturan Guåhan* and the Office of Public Auditor for the use of  
5 the Fund.

6       **§12120.** All provisions of this Act *shall* expire on July 1, 2018, unless re-  
7 enacted by *I Liheslaturan Guåhan* prior to expiration.

8       **§12121.** The Guam Academy Charter Schools Council *shall* recommend  
9 changes to this Act to *I Liheslatura* within thirty (30) days of its first meeting at  
10 which a quorum is present.”
