
CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LAHEN GUÅHAN

**AN ACT TO APPROPRIATE FUNDS FOR THE REPAIR,
RENOVATION AND CONSTRUCTION OF THE HAL'S ANGELS
FOOTBALL FIELD.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. (a) Funding for the Hal's Angels Football Field.**

3 Notwithstanding any other provision of law, the sum of One Hundred Thousand
4 Dollars (**\$100,000**) is appropriated from the FY 2009 Guam Highway Fund revenues
5 to the Dededo Mayor's Office *specifically* for the repair, renovation, and construction
6 of the Hal's Angels Football Field. Said funds *shall not* be subject to any transfer

1 authority of *I Maga'lahen Guåhan* and *shall* be available until fully expended for the
2 purposes contained herein.

3 **(b) Planning and Development.** The Dededo Mayor's Office, in
4 consultation with the Hal's Angels Organization, *shall* develop and approve planned
5 expenditures of said funds as mandated in Subsection (a).

6 **(c) Expenditure Report.** *No later than* thirty (30) days after the close of
7 each fiscal quarter of FY 2009 and thereafter, until fully expended, the Mayor of
8 Dededo *shall* report all expenditures made pursuant to this Section to the Speaker of *I*
9 *Liheslaturan Guåhan* and post the same on the Mayor's website.
