**AN ACT TO *AMEND* §5103(f) OF CHAPTER 5, TITLE 12,
GUAM CODE ANNOTATED, RELATIVE TO THE
COMPENSATION OF COMMISSIONERS OF THE
GUAM HOUSING AND URBAN RENEWAL
AUTHORITY.**

1 **BE IT ENACTED BY PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that since its creation, the appointed Commissioners of the Guam Housing and
4 Urban Renewal Authority (GHURA) *do not* receive a stipend for their attendance
5 at Authority meetings. Other similar autonomous agencies within the government
6 of Guam governed by a board *or* commission are authorized by law to compensate
7 its members with a minimal stipend. *I Liheslatura* further finds that Guam

1 Housing and Urban Renewal Authority officials have represented that federal
2 funding is available for the compensation of GHURA Commissioners. Therefore,
3 it is the intent of *I Liheslaturan Guahan* to extend equity to the Commissioners of
4 the Guam Housing and Urban Renewal Authority, and to authorize compensation
5 for Commissioners similar to their counterparts in other autonomous agencies.

6 **Section 2.** §5103(f) of Chapter 5, Title 12, Guam Code Annotated, is
7 *amended* to read as follows:

8 “(f) A Commissioner *shall* receive *no* compensation for his services,
9 but *shall* be entitled to payment of official travel costs and re-imbusement
10 of expenses actually and necessarily incurred in the discharge of his duties
11 and functions. Commissioners *shall* be compensated in the amount of Fifty
12 Dollars (\$50.00) for attending a board or commission meeting, such
13 compensation *not to exceed* One Hundred Dollars (\$100.00) per month.”
